Objectives & Investment Policy

The aim is for your investment to reflect the performance of the DAX Index (Index), while seeking to minimise foreign currency fluctuations at share class level. The Index is designed to reflect the performance of the shares of 30 of the largest and most actively traded companies on the Frankfurt Stock Exchange.

To be included in the Index, a company's readily available shares must be continuously traded and represent at least 10% of all readily available shares on the stock exchange. The Index is weighted in favour of larger companies. Only companies based in Germany are included in the Index but the companies can come from any business sector. The Index is reviewed and rebalanced at least quarterly. At each review, the combined value of a company's readily available shares cannot exceed 10% of the combined value of the shares of all companies comprising the Index.

The Index is a price return Index. This means that the level of the Index does not include any dividends and distributions made by the companies.

To achieve the aim, the Fund will attempt to replicate the Index by i) buying all (or, on an exceptional basis, a substantial number of) the

No dividends will be paid on your shares.

You may redeem your shares on demand on a daily basis.

DWS entities and related companies may act in several roles in relation to the Fund such as distributor and management company which may involve conflicts of interest.

The Fund is not guaranteed and your investment is at risk. The value of your investment may go down as well as up.

The value of an investment in shares will depend on a number of factors including, but not limited to, market and economic conditions, sector, geographical region and political events.

The Index is rules-based and is not capable of being adjusted to take into account changing market circumstances. As a result you may be negatively affected by, or may not benefit from, the lack of such adjustments in changing market circumstances.

The Fund may use derivatives to i) try to manage its investments more efficiently; and ii) try to reduce movements in currency exchange rates between the currency of the Fund's assets and the currency of the Fund's shares. This may not always be successful and may result in greater fluctuations in the value of the Fund. This may negatively affect the value of the Fund and your investment.


Charges

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

The ongoing charges figure is based on expenses for the year ending October 2017. It may vary from year to year. It excludes portfolio transaction costs and performance fees, if any. To the extent the Fund undertakes securities lending to reduce costs, the Fund will receive 90% of the associated revenue generated and the remaining 10% will be received by Deutsche Bank AG as the securities lending agent. As securities lending revenue sharing does not increase the costs of running the Fund, this has been excluded from the ongoing charges.

- - On May 17, 2018 the share class changed its underlying benchmark to track the DAX Index in the Fund's base currency. Previously, the share class tracked the DAX monthly USD Hedged Index. The share class continues to be currency hedged. The index past performance shown for 2017 is that of DAX monthly USD Hedged Index.
