Objectives and Investment Policy

Investment Objective

The objective of the Fund is to track the performance of the U.S. dollar-denominated corporate bond market for investment grade (high quality), fixed-rate, taxable securities.

Investment Policy

The Fund seeks to track the performance of the Bloomberg Barclays U.S. Corporate Bond Index (the "Index") as closely as possible.

The Fund invests at least 90% of its assets in government and government-related bonds and corporate bonds which are securities of the Index. These securities include investment grade, fixed-rate, taxable, corporate bonds denominated in U.S. Dollars.

As it may be difficult to purchase all securities in the Index efficiently, in seeking to track the performance of the Index, the Fund will use a stratified sampling strategy to build a representative portfolio. Consequently, the Fund will typically hold only a subset of the securities included in the Index.

The Fund may use financial derivative instruments (that is, financial contracts whose prices are dependent on one or more underlying assets) in order to manage the portfolio efficiently.

Save in exceptional circumstances, the Fund will generally only issue and redeem shares to certain institutional investors. However, shares of the Fund may be purchased or sold through brokers on one or more stock exchanges. The Fund trades on these stock exchanges at market prices which may fluctuate throughout the day. Market prices may be greater or less than the daily net asset value of the Fund.


