# Xtrackers CSI300 Swap UCITS ETF

#### Objectives and investment policy

The fund is passively managed. The aim is for your investment to reflect the performance of the CSI300 Index (index) which reflects the performance of shares of 300 companies listed on the Shanghai Stock Exchange and the Shenzhen Stock Exchange (China A Shares). The index is calculated in Renminbi (CNY). The shares are issued by companies which are selected on the basis that they have the largest combined value of readily available shares as compared to other companies on the stock exchanges. The index is reviewed and may be adjusted every 6 months. The index is

calculated on a total return net basis which means that all dividends and distributions by the companies are reinvested in the shares after tax. To achieve the aim, the fund will invest in transferable securities and enter into financial contracts (derivatives) with one or more swap counterparties relating to the transferable securities and the index, in order to obtain the return on the index. The currency of the fund is USD. Returns and gains are not distributed but are reinvested in the fund. You may request the redemption of shares generally on a daily basis.

The derivative counterparty may reduce the payments under the swap agreement if the tax policies in China change. The reduction may result in a negative impact on the net asset value of the shares. The derivative used to gain exposure to the index may be adjusted to reflect certain expenses in relation to taxes and/or buying, selling, borrowing, financing or custody costs. 
