Objectives and investment policy

The fund is passively managed. The aim is for your investment to reflect the performance of the CSI300 Index (index) which reflects the performance of shares of 300 companies listed on the Shanghai Stock Exchange and the Shenzhen Stock Exchange (China A Shares). The index is calculated in Renminbi (CNY). The shares are issued by companies which are selected on the basis that they have the largest combined value of readily available shares as compared to other companies on the stock exchanges. The index is reviewed and may be adjusted every 6 months. The index is

calculated on a total return net basis which means that all dividends and distributions by the companies are reinvested in the shares after tax. To achieve the aim, the fund will invest in transferable securities and enter into financial contracts (derivatives) with one or more swap counterparties relating to the transferable securities and the index, in order to obtain the return on the index. The currency of the fund is USD. Returns and gains are not distributed but are reinvested in the fund. You may request the redemption of shares generally on a daily basis.

The calculation of the risk and reward profile is based on historical data that cannot be used as a reliable indicator for the future risk profile. The fund may enter into one or more derivatives with one or more counterparties. If any of the counterparties fails to make payments (for example, it becomes insolvent) this may result in your investment suffering a loss. DWS entities and related companies may act in several roles in relation to the fund such as distributor and management company which may involve conflicts of interest. The fund is not guaranteed and your investment is at risk. The value of your investment may go down as well as up. The fund is exposed to less economically developed economies (known as emerging markets) which involve greater risks (including market suspension risks) than well developed economies. Political unrest and economic downturn may be more likely and will affect the value of your investment. Your investment is dependent on the performance of the index less costs but your investment is not expected to match that performance precisely. The derivative counterparty may reduce the payments under the swap agreement if the tax policies in China change. The reduction may result in a negative impact on the net asset value of the shares. The index is rules-based and is not capable of being adjusted to take into account changing market circumstances. As a result you may be negatively affected by, or may not benefit from, the lack of such adjustments in changing market circumstances. The derivative used to gain exposure to the index may be adjusted to reflect certain expenses in relation to taxes and/or buying, selling, borrowing, financing or custody costs. 
