Objectives:	ETFS Physical Platinum is designed to enable investors to gain a simple and cost-efficient way to access the platinum market by providing a return equivalent to the movements in the platinum spot price less the applicable management fee. The product reflects the performance of the underlying spot price such that, for example, if the spot price were to rise in value by 5% over a period, the product would increase in value by 5% over that same period (before fees, expenses and adjustments) and if the spot price were to fall in value by 5% over a period, the product would fall in value by 5% over that same period (before fees, expenses and adjustments).
