About Caledonia

Caledonia is a self-managed investment trust company with net assets of £2.0bn. Our aim is to grow net assets and dividends paid to shareholders, whilst managing risk to avoid permanent loss of capital. We achieve this by investing in proven well-managed businesses that combine long term growth characteristics with an ability to deliver increasing levels of income. Our investments cover both listed and private markets in broadly equal proportions, a range of sectors and, in particular through our fund investments, a global reach.

Review

Our NAV total return over the year to 31 March 2019 was 10.7%, including our biannual revaluation of unquoted investments.

During the month, we invested £5.3m and realised £56.8m, including £42.0m from redemption of the NTAsset funds. At the end of the month, we held cash totalling £112.3m.

Also during the month, we instructed redemption of £15.3m from the Arlington AVM Ranger fund, which was traded and settled in early April 2019.

We have given an irrevocable mandate to Winterflood Securities to purchase the company's shares on our behalf, within certain parameters, from 1 April 2019 to 28 May 2019, being the day before the planned release of our annual results.


