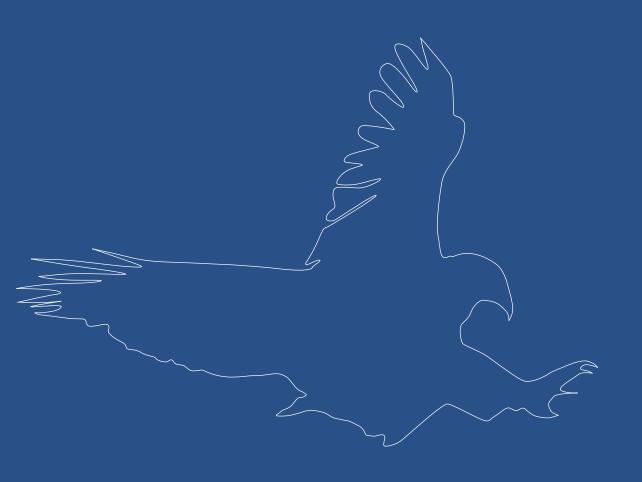
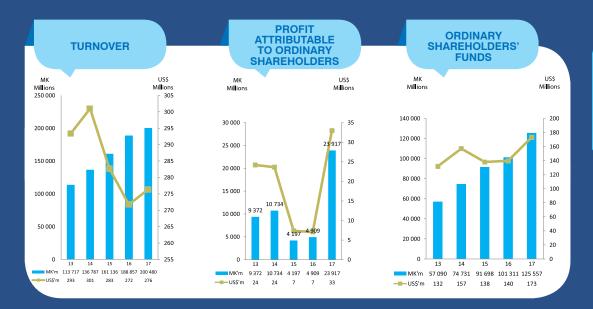

ENVIRONMENTAL MANAGEMENT



PCL and its subsidiaries are committed to developing policies that address the environmental impact of business activities by integrating pollution control, waste management and rehabilitation activities into operating procedures.

Members of staff are encouraged to "reduce, re-use and re-cycle" paper.

Castel (Malawi) Ltd embraces pollution control and waste management by treating and returning waste water to the environment. The aim is to return 100% of the water used in its processes. The company has a waste water treatment plant in its soft drink plant which treats all liquid

waste to acceptable limits before being discharged back to the environment.

As a way of managing waste, both ethanol producing companies namely Ethanol Company Limited (EthCo) and Presscane Limited use ponds to hold effluent from the ethanol production. This byproduct called vinnase is naturally evaporated and the remaining sludge is used as a fertilizer supplement because of its richness in potassium. Part of this supplement is taken back to the sugar making company (and applied in the sugarcane fields) whose byproduct is molasses which is the ethanol production raw material.

(EthCo) also maximizes the use of steam from a renewable source (sugarcane bagasse steam from Dwangwa Sugar Corporation) as opposed to steam from coal which is a fossil fuel in order to protect the environment.

Tree planting has been an ongoing exercise carried out by most of the Group companies as one way of addressing environmental degradation. During the year, PCL through its subsidiaries, planted thousands of trees across the country in an attempt to reverse the effects of deforestation

COMMUNITY AND SOCIAL ENGAGEMENT



As a responsible corporate citizen, the Group and its subsidiaries aim to give back to the community by engaging in various corporate social responsibility activities.

(EthCo) continued to freely deliver the dry sludge from the ethanol production process to local small scale farmers in its community within a 20 km radius. This sludge is used as a fertilizer supplement in their gardens hence reducing the communities' fertilizer costs.

MTL and TNM continued to provide support to YONECO (a nongovernmental organization whose aim is the elimination of child abuse, violence against children and exploitation of children in schools and communities in Malawi) through Child Helpline Services. TNM provided the Toll Free lines where as MTL provided the search lines.

GOVERNANCE AND LAW REFORM



During the year, PCL and its subsidiary and associate companies continued to provide support to efforts by national and regional institutions in the promotion of law reform and good governance.

In this regard, the Company played a pivotal role in supporting the Anti-Corruption Bureau to host the regional summit for heads of anti-corruption institutions in Africa. In addition, PCL assisted the office of the Registrar General during the country's hosting of the African Regional Intellectual Property Organization conference.

ANTI-CORRUPTION



PCL conforms to Principle Ten of the UN Global Compact which states that businesses should fight corruption in all its forms, including extortion and bribery as well as other forms of corruption. The principle gives guidelines for companies to proactively develop policies and concrete programs to address corruption internally and within their supply chains.

PCL and its subsidiary companies support the objective of the Business Action against Corruption (BAAC) which is to actively promote business commitment to fighting corruption and foster widespread support for the Business Code of Conduct and to pursue linkages with relevant national and regional business led anticorruption initiatives.

PCL and its subsidiaries subscribe to Tip Offs Anonymous, a whistle blowing hotline service provided by Deloitte, as an extension of the Group's Fraud Policy. This can be used by those of the Group's employees who may have reservations about using the internal reporting mechanism provided for in the Fraud Policy. It can also be used by any member of the general public on any matter relating to the operations of the Group companies.

THE GENERAL OPERATING ENVIRONMENT

The general outlook of key macroeconomic indicators has been stable and had shown significant improvements in 2017. The value of the Malawi Kwacha has also remained stable against all major currencies since July, 2016 up until the last guarter of 2017 when a strong performance of the Rand and British Pound weakened the Kwacha. However the Kwacha maintained its floor value against the US Dollar.

The availability of food (particularly maize) and Government's ban on maize exports resulted in a crash in the price of farm produce leading to an accelerated reduction in the rate of inflation from 22% per annum at the beginning of the year to 7.1% per annum as at 31st December 2017. This led to a series of reductions in the Policy Rate from 24% at the beginning of the year to 16% in December, 2017. These reductions triggered corresponding reductions in commercial banks' base rates which as of December, 2017 ranged from 21% to 23% as compared to an average of 35% at the beginning of the year.

cover, a comfortable level which has held for a good part of the year.

The stock market had a bull run as it registered a positive return on investment of 62.09% (US\$ terms) and an increase in both total traded value and volume. Listed companies within the Group registered some movement with significant trading and gains in TNM and moderate trading in NBM. PCL itself had a quiet year with no material trading except for a gain of K60 per share at the beginning of the year.

The stability of the Kwacha against the US Dollar meant that the Group was within expected levels of foreign exchange exposure particularly in those entities whose inputs are largely imported and denominated in USD.

Although inflation averaged 11.6% in 2017, production

costs of most Group companies significantly increased from the third quarter onwards due to unstable and inadequate power supply (load shedding) resulting in overdependence on diesel generators.

GROUP PERFORMANCE

The Group delivered strong results with a consolidated profit after tax of MK39.67 billion (2016: MK15.32 billion) representing a 159% growth. Net profit attributable to ordinary shareholders was MK23.92 billion (2016: MK4.91 billion) representing a 387% growth on prior year. Likewise, earnings per share increased to MK198.98 from MK40.84 representing a 387% growth.

PROSPECTS FOR 2018

Relative stability in some of the macroeconomic fundamentals registered in 2017, such as inflation, interest rates and the exchange rate are expected to continue in 2018, complemented with a projected GDP growth rate of 4.5%. Expectations are that the Kwacha could continue its stability as the country approaches general elections in 2019.

Notwithstanding the positive economic outlook in these indicators, continuing disruptions and inadequacies in power supply and an appreciated Kwacha as measured by the Real Effective Exchange Rate (REER), combined with expected fiscal slippages due to the forthcoming general elections could result in the reversal of some of the gains, particularly if taken together with the underperformance of revenue collection by the Malawi Revenue Authority.

Another downside risk to growth is the underperformance of the agricultural sector following the army worm plague and erratic rainfall experienced in some parts of the country during the 2017/18 growing season.

In spite of these risks to the growth of the economy, and because of the Group's strength in terms of its size, diversity and management, directors are optimistic that the Group will be resilient and will deliver its planned results. The successful restructuring, right-sizing and efficiency improvement measures undertaken in most businesses during the year (including the holding company which saw a 50% reduction in headcount) has re-positioned the Group for growth.

Net profit attributable to ordinary shareholders was MK23.92 billion (2016: MK4.91 billion) representing a 387% growth on prior year.

Implementation of action plans aimed at resuscitating loss making entities will continue in earnest in 2018 with most of them expected to turn around. Going forward, the focus will be to maintain the efficiency momentum and continue searching for profitable new business ventures.

THE BOARD OF DIRECTORS

Mr Patrick Mhango retired from the Board following his exit as Executive Secretary of Press Trust. In his place, Mr Gibson Ngalamila, Mr Mhango's successor at the Trust, was appointed to the Board. In addition, a nominated director by Old Mutual, Mr Damien Kafoteka, retired from the Board and was replaced by Mrs Edith Jiya. I would like to welcome both Mrs Jiya and Mr Ngalamila and look forward to their contributions on the Board.

APPRECIATION

I wish to take this opportunity to thank Mr Mhango and Mr Kafoteka for their valuable contributions while serving on the Board and wish them well in their retirement. I also wish to thank my fellow Directors for their wise counsel, the management team and all members of staff for their hard work, co-operation and dedication to duty during the year. With their efforts, the Group achieved excellent results as outlined in this Report. I look forward to another successful year.

GROUP OPERATIONS

GROUP CHIEF EXECUTIVE'S REPORT

During the year, Management concentrated its efforts in developing and implementing strategies on underperforming businesses as these continue to have a significant negative impact on overall Group results, all the while still keeping close attention on Group companies that are performing to ensure their sustenance. Strategies being deployed included functional reviews, a revamp of performance management systems, recapitalizations, disposal of non-performing assets, technical partnerships, debt restructurings, cultural and change management. The following companies received extensive management attention:

Peoples Trading Centre Limited (PTC)

Senior management changes have been made at PTC. The company's partnership with Spar brand was enhanced by the opening of the Northgate Spar in Blantyre. PTC's new strategic direction included balance sheet restructuring through recapitalization, debt restructuring, automation, ambience improvements, rebranding, rationalization of outlets and functional reviews. These strategies were developed in the course of the year and implementation started late in 2017 and will continue in earnest in 2018.

The Foods Company Limited

Interventions in aquaculture production at The Foods Company started yielding positive outcomes. The interventions were particularly important on account of the dwindling capture fisheries business due to issues of overfishing, climate change and control challenges. Although still in a relatively significant loss position due to the cost of interventions and lagging effects of results, the company managed to produce over 800 tons of Chambo, a record in aquaculture since the fish farming venture started. Due to these positive results in productivity, it gave confidence to Executive Management to recapitalize the Company in the second half of 2017 for purposes of funding the expansion of the Aquaculture Division. The Feed Mill Division was discontinued as part

of the restructuring process. Meanwhile a functional review exercise and the search for a strategic partner are ongoing.

Malawi Telecommunications Limited (MTL)

A functional review exercise was successfully implemented towards the end of the year while a balance sheet reorganization is still work in progress. The Company embarked on the disposal of some of its non-performing properties. In some cases where properties are actively in use by the Company, the route will be on the basis of sale and lease back arrangements. Cash released from the exercise will be used for debt reduction and restructuring to levels where it is sustainable.

The functional review and the process re-engineering exercise resulted in a 50% reduction in operating costs and a 58% improvement in operating results.

Open Connect Limited (OCL)

OCL, which operates the fibre backbone infrastructure that was hived off from MTL, had a positive EBITDA although it still made a loss due to significant financing costs as the company is highly geared. Discussions with a potential equity investor in OCL are nearing a completion stage. The primary objective is to reduce foreign exchange exposure on significant foreign obligations by either paying off debt or localizing obligations, thereby minimizing foreign exchange exposures for a company whose entire receivables are in Malawi Kwacha.

Press Properties Limited (PPL)

The property business which had been experiencing severe cash flow problems was successfully restructured through a functional review process and has completely turned around showing a 101% growth in profit. The focus going forward is to sustain its performance and significantly grow its operations to compete successfully with its peers in the industry. Plans are underway to make acquisitions of some valuable real estate through a recapitalization process.

Castel (Malawi) Limited

PCL diluted its shareholding in Castel (formerly Carlsberg) to 20% from 39.65% at the time when Carlsberg sold its interests to Castel. Significant investments of over USD20 million have been made by Castel in rehabilitating the plants, additional production lines, automation, quality control, logistics and new product lines. New brands of beverages have been introduced on the market with particular emphasis on capturing market share at the lower end of the market which is being flooded with informal imported brands. These investments will help turn around the company whose performance has been unsatisfactory for the past few years. Proceeds of the part disposal of PCL's stake allowed for further strategic investments within the Group, including retiring of debt which was crippling operations of some Group companies.

Corporate Head Office

An extensive functional review and process re-engineering exercise was carried out and operations were accordingly restructured accompanied with a new performance management system to bring about efficiencies. The functional review resulted in a one off retrenchment cost of about MK700 million.

Training and development of staff continues to play an important role in the Company's overall strategic plan in order to allow for the efficient delivery of services and also provide for effective succession planning. The Company continues to seek and recruit qualified and young graduates into its Management Trainee Program who are making positive impact in the various companies where they have been placed within the Group.

GROUP FINANCIAL PERFORMANCE

As pointed out in the Chairman's Report, Group profit after tax at MK39.67 billion (2016: MK15.32 billion) represents a 159% increase over prior year. This performance was achieved after taking into account a profit of MK14 billion on the part-disposal in Castel as alluded to above. However, excluding the above part-disposal, the underlying results at 68% growth (MK25.67 billion) still show commendable improvement on prior year results, notwithstanding the prevailing sub-optimal operating environment arising out of poor farm produce prices which affected overall effective demand on Group turnover, and acute power shortages which affected production.

The underlying performance was driven by cost reductions and improved operating efficiencies in spite of high restructuring costs. Functional review exercises which were carried out in most Group companies during the year aimed at streamlining operations and improving efficiencies resulted in significant cost savings even after taking into account high retrenchment costs. In addition, there were additional savings in finance costs following the downward movement of interest rates and the relative stability of the local currency. The Group also paid off some of its liabilities which resulted in further reduction in finance costs.

Prior year comparatives were restated to take into account a prior year loss adjustment in Peoples Trading Centre Limited amounting to MK1.9 billion.

Brief profiles and performance highlights of all individual companies within the Group have been given elsewhere in this Annual Report.

STRATEGIC DIRECTION

PCL will continue to focus on growth through diversification. The Group is keen to maintain its leadership role in the private sector by nurturing profitable operations to ensure sustainable growth in market share and dominance in the respective sectors consistent with the pillars contained in its 5 year Strategic Plan. These pillars are Business Expansion, Competitive Advantage, Human Capital Development, Technological Enhancement, and Corporate Social Responsibility. However, alongside these pillars, it has become imperative that management also prioritize on turn-around strategies to resuscitate non-performing investments with potential, which are negatively affecting Group results in a significant way.

CONCLUSION

Let me take the opportunity to sincerely thank the Board for its guidance and support given to me and my fellow members of the executive management team, particularly on the difficult decisions that we had to make during the year. I also wish to thank members of staff at the Corporate Office for their dedication to duty and hard work. This being my first full year at Corporate Office, I particularly appreciate their willingness and flexibility in quickly embracing and sharing some of the changes which we all agreed were required within the Group. On behalf of the Board, I wish to express my sincere appreciation to members of staff and all directors in the different boards of our Group companies for a successful year despite challenges in the operating environment. I look forward to another fruitful and adventurous year.

National Bank of Malawi Plc (NBM) and its subsidiaries are engaged in the business of commercial banking, stock broking, fund management and pension fund administration. In addition, NBM has a 31% stake in United General Insurance, a general short term insurance company as its associate.

NBM Group Performance

The Bank registered a 15% growth in the group profit after tax from K16.6 billion to K19.15 billion and achieved a 19% growth in shareholders' funds.

The year started on a fairly positive note with inflation continuing to trend downwards from 18.2% in January 2017 closing at 7.1% in December 2017 (December 2016: 20%). Agricultural production improved following good weather. Consistent with the inflation trend the Reserve Bank of Malawi reduced the Policy Rate three times in the course of the year. The Bank responded accordingly with reductions of its base lending rates from 32% in January 2017 to 25% as at December 2017.

In spite of the above, economic activity was generally subdued mainly due to challenges with power supply and the collapse of maize prices. Maize price significantly dropped by over 50% mainly as a result of the oversupply caused by an export ban. Consequently there were challenges in the growth of the loan book and servicing of debts resulting in the bank making a significant provision of K5.25 billion for bad debts.

Due to lower than expected business activity of clients and tight margins, the Bank underperformed on foreign exchange income but exceeded targets on money market investments due to relatively high volumes on investments from the excess liquidity brought about by low demand for lending products.

The Bank has therefore demonstrated remarkable resilience in its performance under the circumstances.

Among other major projects, the Bank successfully



upgraded its core banking system that went live on 1st July, 2017. The upgrade is expected to improve customer delivery and product innovation. The Bank also successfully launched a bouquet of credit cards and completed the replacement of its Leasing System which has enabled the Personal and Business Banking unit to better manage its leasing business. The Bank's systems were interfaced with Malawi Revenue Authority tax system to enable customers pay taxes electronically.

Outlook for 2018

The Bank has developed a new 5 year Strategic Plan for 2018 to 2022 to take it to the next level following the successful implementation of the previous plan. The Bank has in-built flexibility, resources, and agility necessary to continue on a sustained growth path. The Bank therefore expects a strong performance through its ability to leverage on core strengths and exploiting opportunities in the market. The Bank will focus on the acceleration of digitalisation of processes and product offerings to delight its customers.



Telekom Networks Malawi Plc (TNM) is a truly Malawian company committed to maintaining a sustainable and profitable business. The company aims to be the leading ICT and multimedia service provider in Malawi that in turn enables the required economic growth for building a great nation.

Performance

The Company achieved good subscriber and service revenue growth in 2017 which resulted in improved margins and profitability levels. These achievements were supported by strong performance of consumer and business enterprise products and services, a strong brand and well managed cost controls.

The economic environment stabilized during the period under review with falling inflation rates and interest rates. Exchange rates stabilized which resulted in foreign currency denominated expenditure savings as well as minimal exchange losses compared with previous years.

Although the current level of profitability is encouraging, TNM requires a higher level of profitability to ensure the sustainability of the business to support continued future investment in new technologies and infrastructure expansion.

The Company has been successful with initiatives taken to improve its revenue streams and cost containment management, which resulted in an EBITDA margin of 37% which represents a 2% increase over 2016. Net financing cost decreased to MK2,810 million (2016: MK 4,250 million) which includes foreign exchange losses of MK12 million (2016: MK815 million). Net profit after tax increased by 60% to MK13,108 million, from MK8,206 million in 2016.

TNM investments in capital projects amounted to MK19,037 million (2016: MK9,176 million) which mainly consisted of 4G LTE broadband technology and U900–3G technology across the country. A convergent fix mobile capability was also achieved with the implementation of the IP Multimedia platform (IMS).

Strategy

The Company continues to pursue its strategic objective of becoming the leading ICT and multimedia service



provider in Malawi through focus on improved customer experience and product innovation. The focus is therefore on long term growth benefits from investment in infrastructure, human capital and subscriber satisfaction.

Outlook for 2018

TNM expects the macro-economic environment to be stable in 2018 with low inflation levels, lower interest rates and a continued stabilized Malawi Kwacha.

The focus in 2018 will be on improving customer experience, growing business products, managing foreign exchange exposure and investing in areas which will achieve business growth.

TNM expects to dominate the Business Enterprise space and to be the preferred ICT provider in Malawi. TNM has invested in a new Mpamba platform which will support the growth of the Mobile Money business as well as enable new innovative products and services to promote financial inclusion.

TNM will continue investing in new network coverage and capacity sites thereby enhancing customer voice and data experience. The U900 and 4G LTE technology will be used as prime connectivity platform to launch further cutting edge products and services for our customers.

Malawi Telecommunications Limited (MTL) is a limited liability company which offers a wide range of Information and Communications Technology (ICT) based solutions to corporate businesses, Small and Medium Enterprises and consumers. The range of products and services offered to business customers and consumers include fixed voice, mobile voice and data services.

MTL is owned by Press Corporation Plc, the majority shareholder, at 52.7% shareholding; the Malawi Government at 20%; Old Mutual at 16.1%; Nico Holdings Plc at 9.0%; and Investment Alliance at 2.2%.

Telecommunication Industry Outlook

Driven by the continuous migration of consumers from fixed telephony to data-centric communications solutions, and the evolving business needs that are driving enterprises to move towards IT based service models, the telecommunications industry in Malawi continues to grow mainly in the mobile voice, mobile broadband, fixed broadband, and internet market segments, consistent with global trends.



The business outlook for 2018 appears positive with projected growth of 15% in turnover and a positive working capital.

Business Model and Strategy

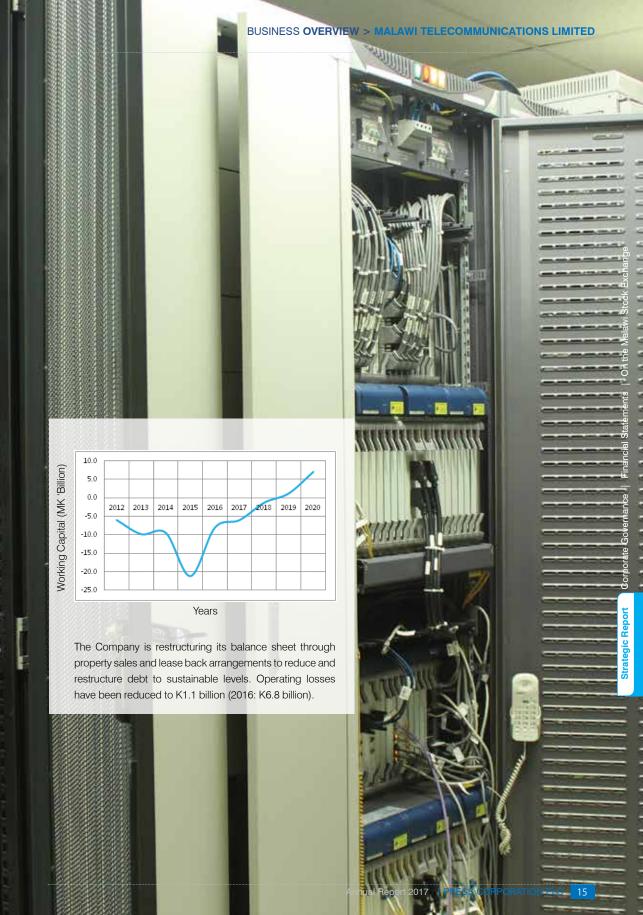
Despite the prevailing economic challenges in the country, MTL has taken a more focused approach in determining products and services offerings on the market in order to capture real opportunities in the telecommunication ecosystems. Specifically, the driver for growth and profitability rests on a multi-dimensional and integrated corporate restructuring that optimally balances business strategy, business modeling, financial and operational structures. During the year, MTL anchored the foundation of the Company's turnaround strategy by renewing the business strategy which transforms the Company's philosophy from being a provider of communication technologies to a provider of connectivity solutions for greater customer experience as follows:

- Shifted the focus of MTL's business from infrastructure to customer value propositions.
- Designed the product/service roadmap to transform the Company's offerings from individual products or services into integrated reliable communication solutions.
- Combined strategic positioning, activity fit, and operational efficiency and effectiveness.

Secondly, the Company further streamlined its business through decommissioning of assets that were significantly eroding value and restructuring of the corresponding functions. This follows the unbundling of the business in 2016 into three (FOC backbone which provides secure, reliable, low-cost, high-speed bandwidth as a carrier of carriers trading under the name of Open Connect Limited (OCL) as a separate entity; Broadband and Telephony which provides customer-centric, secure and competitive data and voice services; and Co-siting which provides secure and reliable sites with optimum coverage for broadcasters and telecoms).

2017 Performance Highlights

During the year, operational processes were reviewed in tandem with customer expectations: focused customer acquisition process and renewed MTL's commitment to quality services through Service Level Agreements (SLAs) and active engagement with key customers. In the last quarter of 2017, the company successfully re-engineered itself with the aim of streamlining operations and resources in order to achieve greater efficiency following the curving out of the FOC backbone infrastructure business. The headcount was reduced by over 50% resulting in reduced administrative costs and improved efficiencies. The business outlook for 2018 appears positive with projected growth of 15% in turnover and a positive working capital.

Open Connect Limited (OCL) is a new company that was incorporated in March 2016 following unbundling of the fibre optic backbone business from the Malawi Telecommunication Limited (MTL) OCL was registered as a special purpose vehicle to operate and manage the fibre network with the ultimate desire to offering it to strategic investors in consideration of equity injection.

OCL offers carrier services to licensed telecommunications operators, ISPs and broadcasters. Its services range from provision of backbone SDH capacity, metro SDH capacity and last mile backhauling dark fibre.

Business Composition and Market Share

OCL is a carrier of carriers company that currently owns more than 50% of the fibre network in Malawi and covers all the country's four regions, and also crosses the border into Tanzania and Mozambique. The lit capacity of the network is 10G in redundant mode in the main backbone routes and 2.5G in redundant mode for the metros and international connectivity. OCL also owns a considerable amount of Access Network.

Business and Performance Highlights

During the year, OCL entered into business partnerships with several telecom operators. Under these partnerships, OCL was a preferred service provider of carrier services, metro backhauling and Access Network.

OCL also strategically shifted its operational centres to shorten up network down times thereby keeping service levels above the required standards.

Total revenues were MK3, 804 million representing a 47% growth compared to 2016. EBITDA at MK 2,721million was 72% of the total revenue and was 2% higher than

2016. The business however made a loss of MK1, 647million due to significant finance charges, this being a 100 percent geared company.

Search for Strategic Investors

Due to the high gearing of the company, negotiations with strategic investors for injection of equity are at an advanced stage and are expected to conclude in early 2018. It is planned that the strategic investors will take up to 60% of the shareholding in OCL and the rest of the shareholders will be diluted proportionately.





Ethanol Company Limited (EthCo) is an ISO 9001, ISO14001 and OHSAS 18001 certified company and the sole producer of Extra Neutral Alcohol (ENA) in Malawi. The company also produces Anhydrous (fuel ethanol), rectified (industrial) spirit and has an associate that produces coca cola grade carbon dioxide for the beverage industry.

2017 Performance Highlights

EthCo registered a bearish performance in 2017 that saw a 72% reduction in pre-tax profit against prior year due to three external factors. Firstly, Government increased enforcements on liquor manufacturers due to noncompliance with packaging and quality standards which led to the closure of 13 major customers from June to the end of the year. This resulted in a significant reduction in demand for EthCo's flagship product, ENA, and ultimately revenue. In mitigation, management identified an export market where 41% of the sales were directed but the base was not sufficient to make up for the volume loss on the local market.

Revenue was also affected by the decision of the Regulatory Authorities not to revise upwards the petrol price in 2017. The profitability on Absolute Alcohol (AA) therefore was less than expected.

Lastly, frequent power disruptions compelled the company to run diesel generators for a third of the production time leading to increased costs, challenges in product quality,

increased downtime and high maintenance costs as a result of damage caused by low and high voltages.

Despite these challenges, management of other costs and implementation of mitigation strategies meant that the overall inherent risk exposure remained within set appetite levels.

Outlook for 2018

The company is geared to bounce back in 2018 with the resumption of operations by the closed liquor manufacturers and the implementation of various cost containment measures. Furthermore, some sections of the plant will be upgraded to improve production efficiency and increase flexibility on the production mix.

Strategic Direction

Management continues to work on increasing plant capacity utilisation by moving ahead with feedstock project (Project RAMA) as a long term solution to feedstock challenges. In the short term, the company will endeavour to import additional molasses for the 2018 season to improve plant utilisation which currently is at 50%.

Financial



Presscane Limited is Malawi's leading producer and marketer of automotive fuel grade ethanol that has been used in Malawi for blending with imported petrol since 1985. It also produces rectified spirit used in industrial manufacturing processes.

2017 Performance Highlights

The Company installed a new plant and equipment. This has seen the capacity of the plant to produce rectified spirit, the intermediate product for manufacturing fuel ethanol, increase to 90,000 litres per day from 60,000. Intermittent power supply challenges resulted in increased production costs due to use of diesel generators thus negatively affecting output. The Company had a late start of production due to the plant upgrade.

The lower production horizon and molasses conversion efficiencies due to persistent power challenges, on the back of stagnant prices of fuel ethanol set by the energy regulator, contributed to the operational loss of MK254 million recorded in the 2017 financial statements. Nonetheless, a net profit of MK556 million was achieved owing to investmet income.

Notable initiatives undertaken in the year include:

 Expansion of the distillery from 60 to 90 thousand litres per day.





The Company installed a new plant that increased rectified spirit production from 60,000 to 90,000 litres per day.

- A business re-engineering exercise that led to reduction in head count resulting in stream-lined and efficient business processes.
- In partnership with the Ministry of Agriculture, initiated studies for production and use of sweet sorghum as an alternative feedstock.
- Conceptualized a 330 ha sugarcane farm project which was selected by the Malawi Innovation Challenge Fund (MICF) for consideration by its Investment Panel subject to submission of a full proposal.

Strategic Direction

Implementation of the Company's raw material supplementation project christened as RAMA will be a priority going forward. This will enable the company to fully utilize the now expanded plant capacity. The Company will also undertake market and product development initiatives leading to diversification regarding uses of rectified spirit.



Market Position

Demand for petroleum fuels increased by 7% in 2017 compared with 14% growth in previous year. The industry has registered an increase in number of retail sites owned by new entrants in the market. The Malawi Energy Regulatory Authority (MERA) revised standards of constructing retail service stations, including locations of new sites. MERA also amended the regulation that governs on stock holding days. The amended regulation requires that all Oil Marketing Companies (OMC's) comply with minimum stock holding of 30 days, and hence terminal capacity of 30 days sales. Compliance with these amendments is however yet to be reinforced by the regulator. Once implemented, the increased holding stock levels is likely to increase working capital requirements thereby increasing operating costs. The regulator is working on a transport recovery model for product delivered beyond 20 kms from storage depots.

2017 Performance Highlights

The Company increased its retail network by four sites and started the fifth site which is expected to be operational by mid-2018

Key focus areas included customer service and safe practice improvements. There was no margin increase throughout the year.

Product supply was sustained despite implementation of a 50-50 fuel importation split between National OIL Company of Malawi (NOCMA) and Petroleum Importers Limited (PIL).

With no margin increase in the year, cost leadership and maximization of revenue for aviation and lubricants were key strategies. A total of 139 million litres were sold as compared with 135 million litres in 2016. The company

registered significant market share growth in lubricants and commercial sectors.

Total turnover at MK105 billion was 11% higher than in 2016. Total Operating costs at MK3.9 billion were 26% higher than in 2016. Profit Before Tax at MK5.3 billion was 8% higher than in 2016.

Strategic Direction

During the year, the Company revised its marketing strategy to maintain a leadership and profitable position for the industry. Revenue maximization, efficient cash management and cost leadership will remain key pillars of the strategy. A customised investment strategy will be implemented in semi urban centres to assist with economic growth.

Peoples Trading Centre Limited (PTC) is a wholly owned subsidiary of Press Corporation Plc and is a pioneer of the chain stores in Malawi. Currently PTC is the retail chain leader with 70 stores across Malawi and with foot print in almost all districts.

2017 Performance Highlights

Despite working capital challenges, the Company employed strong controls for managing stock losses which has been an Achilles heel in the past years. This resulted in a significant decline in shrinkage and wastage by more than 50%. High interest rates continued to exert significant pressure on the business performance during the year and finance costs remained one of the key challenges of the Company.

Strategic Direction

PTC will continue to focus on being the leading fast moving consumer goods chain store in Malawi. The Company is aligning stores to customer profiles to address the diverse local markets. The Peoples brand will focus on the mass market while the SPAR and Food Lovers brand will target the high end customers. The Company will expand foot print in all these store formats going forward after a recapitalization process.

The Company will continue investing in automation and measures aimed at improving controls to reduce wastage and stock shrinkages.

Outlook for 2018

Outlook for 2018 is brighter than 2017 due to the planned recapitalization exercise and on account of stable exchange rate and declining interest rates. Power challenges are expected to affect the confectionary, butchery and fresh foods business and increase costs through the use of generators. However, PTC is well positioned to take full advantage of the economic prospects and a growing market. Product offering will be properly aligned with the growing markets.

Performance

Sales volumes in 2017 were down by 18% as construction and infrastructure projects shrank. This was mainly due to the difficult economic environment and increased steel prices on the international market. Intermittent power supply challenges had a huge impact on steel fabrication and production which increased costs. Consequently the Company registered a decrease in profit by almost 46% i.e. from K648.0 million in 2016 to K441.0 million in 2017.



The Company will introduce two new popular roofing products which will further improve sales volumes.

Outlook

Malawi's key economic indicators have improved and there will be an increase in infrastructure and construction projects. Performance in 2018 is therefore expected to recover. The Company will introduce two new popular roofing products which will further improve sales volumes.

The Company will continue with its cost cutting exercise by improving production and administration efficiencies.



Statements



In August 2016, Castel Group replaced Carlsberg A/S by taking ownership of bottling and brewing operations of Carlsberg Malawi Ltd. Carlsberg (Malawi) Limited had been operating in Malawi since 1968 and was the first brewery established outside Copenhagen, Denmark by the Danish brewer, Carlsberg.

Castel Group is the leading producer of wine in Europe and has a significant market share in the production of beer and soft drinks in Africa. Following the change of ownership, the company officially changed its name to Castel Malawi Limited on 24th October 2017. Castel Malawi operates from 4 sites across the country with 6 production lines supplying customers and consumers via 13 owned depots and 7 contracted depots.

Market Position

Castel Malawi has continued to be the leading beverage producer in Malawi with its beer brands which include Carlsberg Green, Stout, Special Brew, Chill and local power brand Kuche Kuche. The soft drinks range includes Coca- Cola, Fanta, Sprite, Sobo squash and Quench still water and the spirits range includes the iconic Malawi Gin, Malawi Vodka, Powers Brandy, Powers No. 1 and Premier Brandy. Castel Malawi holds 90% of the clear beer market and 80% of the soft drinks market with around 20% of the local spirit market in glass. Malawi Gin is the best seller in the spirit range and is an export product as well.

2017 Performance Highlights

Overall, the business declined by 10% in 2017 compared to 2016. The Company experienced notable decline in soft drinks volume (mainly the Coca-Cola range). This is attributed to the influx of various imported carbonated drinks in various pack sizes, flavors, mainly in plastic bottles (PET), in nearly all channels. Eighty percent (80%) of the competition was coming onto the market through informal channels/imports. This resulted in the Company's losing some market share to its competitors.

Against this background, Castel Malawi launched PET packaging in 350ml, 500ml and 2 litre, for a range of sparkling products to help fight off competition. The Company also extended the Quench packaging to include 1 and 2 litre packs thereby increasing consumer offering. The sparkling beverage portfolio was expanded with a new product called World Cola and with the launch of additional Sobo sparkling flavours. Castel Malawi also resumed production and sale of Sobo Tonic and Ginger. In addition, new product categories were introduced which included the launch of an energy drink (XXL), wine (Maison Castel) and juice (Compal Juice).

Outlook for 2018

The Company is optimistic that 2018 will provide the requisite environment for improvements to be made across various departments. The Company aims at consolidating its product portfolio; supply chain; and production and to bring innovation with the launching of new products, especially new beer and draught beer.

Strategic Direction

The main focus of the business at present is to regain the desired levels of volumes; operating efficiencies; and profit; and to deliver on 2018 priorities. In the long term the aim is to consistently grow the product base in Malawi, broaden the product range and to be able to offer Malawi's consumers a complete range of beverages at affordable prices.

Overall, management is committed to ensuring that set plans are implemented effectively timely and in a quality manner in order to secure a stronger and successful 2018.



The Foods Company Limited (TFCL), is the single, largest commercial fishing company and large-scale aquaculture producer of tilapia in Malawi. TFCL operates three divisions: Maldeco Fisheries engaged in capture fishing (open lake), Maldeco Aquaculture which produces its farmed tilapia (branded Aqua Chambo) in circular floating cages in Lake Malawi and the Fish Feed division.

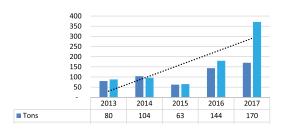
2017 Performance Overview

The Company's overall performance continues to improve despite the tough operating environment. It registered increased fish production during the year, despite power challenges and reduced fish levels in traditional fishing areas. High fish feed costs resulted in increased production costs.

Aquaculture

The Aquaculture Division continues to improve. The Company is now able to grow Chambo to 300g within a culture period of seven months and due to this improvement the Company is able to realize more revenues per kg.

Aqua Chambo Five Year Performance



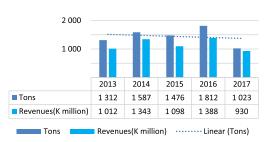
Harvests and revenues grew by 25% and 106% respectively over prior year due to the use of high quality floating feed and improvements in aquaculture management. As at 31st December 2017, the Company had over 200 tons of fish ready for harvest.

Capture Fisheries

2017 was a particularly bad year with the lowest tonnage captured over the past five years. General fish scarcity due to climate change and the increasing number of illegal commercial fishing operators within the traditional fishing areas was the major reason for reduced catches.

Catches and revenues were 44% and 33% respectively below prior year.

Feed Division

Due to the strategic focus to increase Chambo production and importation of floating fish feed, the feed mill was inactive and a management decision was made to close the feed mill whilst waiting for investment in a new feed plant.

Strategic Drection

The goal for the Aquaculture Division is to grow Chambo production output to 2000 – 5000 tons per annum in the medium to long term to satisfy local demand and tap on regional export market. In this respect, additional 20 cages will be added in 2018. The Company plans to acquire a new feed plant to produce high quality extruded feed in the medium term.

The Company will also prioritize the use of high quality floating feed, invest in processing and holding facilities, and adopt modern technologies in order to improve security. In addition, the Company intends to revamp its distribution channels in a bid to improve fish uptake

Outlook for 2018

The implementation of these initiatives is expected to significantly improve performance of the Company in 2018. However power shortages, and high costs of imported floating fish feed and raw materials will impact on the production costs of Aqua Chambo.



Press Properties Limited (PPL) was established in 1969, and is a 100% subsidiary of Press Corporation Plc (PCL). For close to 50 years, the company's major business has been property development and property letting. Recently, it has expanded its sphere of operations to include property management, property sales and valuation services for third party clients.

2017 Performance Highlights

In 2017, the performance of the company was anchored by a sales promotion campaign to accelerate sales of plots at Chapima Heights. The promotion was aimed at unlocking the funds and redirect the investments to very profitable ventures. As a result of the sales promotion campaign, the Company generated revenues of over MK300 million. Apart from increasing property sales revenue, the rental income grew by 12%. These initiatives resulted in an overall pre-tax profit growth of 101% over 2016

Press Properties started implementing a new strategic plan for the years 2017 to 2020 titled "Consolidation and Growth Strategy" in order to sustain and grow shareholders' value. Among its pillars, the strategy prioritises revenue diversification by growing property management income and enhancing earning capacity of existing portfolio through refurbishment and renovation of existing properties.

Outlook for 2018

Once the business has been consolidated, from 2018 onwards the company will embark on a growth path and will focus on among other things developing residential and commercial plots; partnering with group companies in providing their real estate needs and identifying land in Lilongwe for development of commercial and industrial complexes as well as residential houses.

Limbe Leaf Tobacco Company Limited procures and packs tobacco leaf through its two processing facilities in Lilongwe and Limbe, and exports the packed product to destinations all over the world. The company buys directly from farmers that it has contracts with and from the auction floors.

The company has forged partnerships with farmers and communities where tobacco is grown to ensure the crop, the environment and their business is sustainable.

2017 Performance Highlights

The Company purchased 31% of total national leaf tobacco crop production during the year. Factory processing volumes were 39% lower than the previous year following a reduced national crop. Pretax profits therefore decreased by 6% as compared to the previous year.

The Company's sustainability programmes included a comprehensive forestry program which saw the planting of 350 hectares and 150 hectares of trees under the company's smallholder and commercial forestry programmes respectively. The programme and other related initiatives aim at progressively matching and exceeding wood use in the production of its leaf tobacco purchases.

Outlook

It is expected that there will be a bigger tobacco crop in 2018 in comparison to the 2017 crop and this may positively impact processing volumes and performance for the coming year.

Board of Directors

At 31 December 2017 the Board consisted of six non-executive directors and two executive directors. The Chairman is a non-executive director and has a casting vote.

Press Trust and Old Mutual Life Assurance Company Limited nominate five of the non-executive directors. These directors are appointed in accordance with the Company's Articles of Association. At 31 December 2017 Press Trust and Old Mutual owned 45.08% and 15.2% respectively of the shares in the Company. Executive Directors are appointed by the whole Board from members of Executive Management.

The Board is accountable to shareholders, but it proceeds mindful of the interests of the Group's staff, customers, suppliers and the communities in which the Group pursues its interests. In the performance of its functions, the Board is guided by, and has due regard to, the following governance instruments:

PCL continues with a gradual implementation of its policy on gender diversity which is modeled on the 30% Club. Currently female representation is at 25% at Group level. The aspiration of the Group is to appoint more qualifying women to executive and non-executive directorships on the boards of PCL or its subsidiary companies. Furthermore, the Group is keen to improve the pipeline below board level, to widen the talent pool available to its businesses.

1. **INCORPORATION AND REGISTERED OFFICE**

PRINCIPAL ACTIVITIES OF THE GROUP 2.

Press Corporation plc is a diversified Group with significant interests in the Malawi economy. Its subsidiary companies operate in financial services; telecommunications; energy; retail; consumer products and real estate. Press Corporation plc has two joint venture companies in the energy and consumer goods sectors. It also has two associates in the agro-industrial and food and beverages sectors.

3. **FINANCIAL PERFORMANCE**

The results and state of affairs of the Group and the Company are set out in the accompanying consolidated and separate financial statements which comprise of the statements of: financial position; comprehensive income; changes in equity and cash flows and related notes to the financial statements.

8. **DIRECTORS' TENURE POLICY**

In accordance with the Articles of Association, non-executive Directors are appointed by the major shareholders namely Press Trust and Old Mutual Plc with the exception of one independent Director (Mr. A. Barron) who is nominated by the Board of Directors and confirmed by the Annual General Meeting.

Unless a Director resigns, non-executive Directors appointed by the major shareholders serve on the Board up until they are recalled by the particular appointing major shareholder whereas an independent non-executive Director serves a one year term renewable at the Annual General Meeting. Mr. A. Barron shall therefore retire by rotation as Director at the ensuing Annual General Meeting and is eligible for re-appointment, should he offer himself.

Executive Directors serve on the Board by virtue of their offices and their tenure is as per the terms of their contract of employment. Accordingly, the current contract of employment for Executive Director Dr. G Partridge expires on 22nd May 2023 and that of Mr. J Biziwick expires on 30th September 2018.

On termination of the contract, a three months' notice in writing must be given in case of Executive Directors whereas Non-executive Directors termination of their appointment is effective immediately when the notice of termination of their appointment is delivered to the Company Secretary. There is no predetermined compensation on termination of the appointment of Non-executive Directors.

Opinion

We have audited the consolidated and separate financial statements of Press Corporation plc and its subsidiaries ("the Group"), set out on pages 54 to 150, which comprise the consolidated and separate statements of financial position as at 31 December 2017, and the consolidated and separate statements of comprehensive income, the consolidated and separate statements of changes in equity and the consolidated and separate statements of cash flows for the year then ended, and the notes to the consolidated and separate financial statements, including a summary of significant accounting policies.

In our opinion, the consolidated and separate financial statements give a true and fair view of the consolidated and separate financial position of the Group as at 31 December 2017, and its consolidated and separate financial performance and consolidated and separate cash flows for the year then ended in accordance with International Financial Reporting Standards (IFRSs) and in the manner required by the Companies Act, 2013.

Basis for Opinion

We conducted our audit in accordance with International Standards on Auditing (ISAs). How the matter was addressed in the audit

Impairment of loans and advances to customers

Significant judgement is required by the Directors in assessing the impairment of loans and advances granted by the banking business to customers. The Groups' credit risk policy is disclosed in note 6.4.5.

The impairment amounting to K6 billion of loans and advances balance of K127 billion as disclosed in note 16, represents the shortfall between the present value of future expected cash flows, discounted at the original effective interest rate, and the carrying value of the advance in respect of loans and advances that exhibit indications of impairment.

The judgements applied in determining the impairment include:

- the expected realisable value of the collateral securing the advance; and
- the probability that loans and advances will result in

Because the determination of impairment requires significant judgements coupled with the requirement to comply with IAS 39 Financial Instruments Measurements and Recognition, we considered determining impairment against loans and advances to customers as a key audit matter.

In evaluating the impairment against loans and advances, we assessed the judgements applied by the Directors and our procedures included the following:

ate. We further concluded that details of the valuations have been disclosed appropriately in the financial statements.

- Considered managements' credit control processes to identify impaired advances and testing of relevant key controls in the process;
- Examined on a sample basis the appraised fair value of the collateral securing impaired advances;
- Considered the qualitative factors that indicate impairment including the amount in arrears, period in arrears and the financial strength of the borrower;
- Assessed the adequacy of the impairment recorded based on the realisable value of the collateral and the qualitative factors described above; and
 - We further assessed whether determination of impairment against loans and advances is in line with IAS 39 Financial Instruments measurements and recognition.

We found that the judgements applied in determining impairment against loans and advances were appropriate and that the amounts recorded were reasonable and complied with IAS 39 Financial Instruments Measurements and Recognition. We further concluded that the financial statements disclosures in relation to impairment of loans and advances to customers are appropriate.

Key Audit Matter (Consolidated financial statements)

How the matter was addressed in the audit

Revenue recognition in the telecommunication segment

The Group's billing systems for voice and data operate on dedicated computer platforms. These systems process millions of pieces of data to electronic records which enables the Group to charge their customers, in real time, based on service usage.

The operations of these systems are fairly complex with dynamic and intelligent tariffs regimes which provide for various promotions and discounts that are dependent on demand and individual usage profiles. Income is determined taking into account the profile and usage of each individual customer.

In addition prepaid phone units are used over periods that can straddle more than one accounting period. The determination of the correct cut off between what has been used and can be included in income and what has not be used and should be deferred income (creditor) is also a key audit consideration.

The nature of the systems and billing profiles make this a complex audit area in relation to the auditor assessing completeness of income. Accordingly, we consider this a key audit matter.

The revenue recognition policy of the Group has been disclosed in note 3.9 and we have assessed the policy and found it to be in line with International Financial Reporting Standards and industry practice. In addition the deferred income which is disclosed in note 32 has been assessed to be in accordance with the revenue recognition policies.

We involved our Information Technology (IT) risk specialists in the engagement and carried out the following:

- Assessed the general computer controls around the significant revenue and billing systems;
- Evaluated the process for capturing the tariff plans, combined with testing of a sample of related transactions. A key aspect of this exercise was to ensure that tariffs are properly approved;
- Obtained downloads of information recorded in the Group's billing systems and by using advanced data analytics mirror the dynamic, intelligent tariff regimes to independently compute the income for the year and thus assess the completeness and accuracy of the figures in the revenue reports.
- Assessed whether revenue was recorded in the correct period.
- Obtained a deferred income reconciliation for the expected deferred income as at period end and tested the accuracy and completeness of the reconciling items.
- Re-computed deferred revenue from Intelligent Network data using Computer Assisted Audit Techniques (CAATS).
- Checked that the deferred income in the billing system are being reconciled to the records.

Based on the work performed, we concluded that revenue was properly recorded.

Key Audit Matter (Consolidated financial statements) How the matter was addressed in the audit

Depreciation and capitalisation of property plant and equipment in the telecommunication segment

Depreciation of property, plant and equipment requires management estimation. Key judgments relate to the use of appropriate residual values for assets without a ready secondary market and determining appropriate useful lives.

The Group also continued to invest in significant capital expenditure during the year ended 31 December 2017. The determination of when the asset has been commissioned and brought into use has an impact on the depreciation charged during the year.

Further the significant level of capital expenditure requires consideration of the nature of costs incurred to ensure that capitalisation of property, plant and equipment meets the specific recognition criteria in IAS 16, 'Property, Plant and Equipment' (IAS 16), specifically in relation to constructed assets and the application of the directors' judgement in assigning appropriate useful economic lives. As a result, this was noted as a key audit matter.

The Group's accounting policy in relation to property, plant and equipment is disclosed in note 3.15.

We assessed the reasonableness of residual values and useful lives in line with our understanding of the business and industry practice. We made a sample of assets and performed the following:

- Assessed whether the residual values and useful lives were correctly determined in line with Group policy and industry practice.
- Assessed whether depreciation was correctly computed.
- Assessed the nature of property, plant and equipment capitalised by the Group to test the validity of amounts capitalised and evaluated whether assets capitalised meet the recognition criteria set out in IAS 16 and note 3 15
- Assessed if capitalisation of assets occurred when the asset was in the location and condition necessary for it to be capable of operating in the manner intended by the Group and that a consistent approach was applied by the Group across all significant operations. In this regard, we examined compliance to the commission and project completion acceptance processes used by the Group.

Assessed the useful economic lives assigned with reference to the Group's historical experience, our understanding of the future utilisation of assets by the Group and by reference to the depreciation policies applied by third parties operating similar assets. The capitalisation of assets was assessed to be appropriate and the timing of commencement of depreciation on the capitalised assets was also appropriate. We concluded that the useful economic lives assigned to these assets are appropriate based on the evidence obtained.
How the matter was addressed in the audit

Information Technology (IT) Systems and controls over financial reporting in the banking business

A significant part of the Group's banking business operations and financial reporting process is reliant on IT systems with automated processes and controls over the capture, storage and extraction of information. The banking operations are dependent on their IT systems to (1) serve customers, (2) support their business processes, (3) ensure complete and accurate processing of financial transactions and (4) support the overall internal control framework. Many of the bank's internal controls over financial reporting are dependent upon automated application controls, completeness, and integrity of reports generated by the IT-systems.

A fundamental component of these controls is ensuring that appropriate user access and change management protocols exist and are being adhered to. These protocols are important because they ensure that access and changes to IT systems and related data are made and authorised in an appropriate

The banking IT environment is complex with a number of interdependent systems, interfaces and databases. The Group continues to invest in the improvement of banking IT systems and processes as well as development of new IT systems and their implementation further add to the complexity of the IT infrastructure.

As our audit sought to place reliance on IT systems and application controls related to financial reporting, a high proportion of the overall audit effort was in this area.

Key areas where IT systems were critical in determining accuracy and completeness of account balances were interest income, interest expense, fees and commission income, foreign exchange transactions, classification and suspension of interest on non-performing loans.

We focussed our audit on those IT systems and controls that are significant for financial reporting. As audit procedures over the IT systems and application controls requires specific expertise, we involved our IT audit specialists and Data Analytics team in our audit procedures.

We understood and assessed the overall IT control environment and the controls in place which includes controls over access to systems and data, as well as system changes, We tailored our audit approach based on the financial significance of the system and whether there were automated procedures supported by that system.

As part of our audit procedures, we identified relevant controls activities and evaluated design and determine implementation. We further, determine the need to test operating effectiveness of the control over appropriate access rights and validating that only appropriate users had the ability to create, modify or delete users accounts for the relevant in scope applications. We also tested the operating effectiveness of controls around program changes to establish changes to the system were appropriately authorised and implemented. Additionally, we assessed and tested the design and implementation and operating effectiveness of the application controls embedded in the process relevant to our audit.

Using our Data Analytics team, we recomputed on a sample basis, interest income, interest expense, fees and commission income, and foreign exchange transactions and compared with the amounts that were computed by the system and recognised in the general ledger.

For selected loans, we checked if the Bank was suspending interest for loans that were non-performing or recording to profit or loss if the loans were performing.

We identified some control deficiencies and the conclusion of these findings had no impact on the financial statements.

How the matter was addressed in the audit

Goodwill impairment assessment

As disclosed in note 10, the carrying value of goodwill was K5 billion as at 31 December 2017. Significant judgement is required by the Directors in assessing the impairment of goodwill, which is determined with reference to the value in use, based on the cash flow forecast for each cash-generating unit.

The assumptions with the most significant impact on the cash flow forecast were:

- The growth rate, which is highly subjective since it is based on the Directors' experience and expectations.
- Cash flow projections based on expected future performance.
- The discount rate is subjective and the calculation is complex.

Accordingly, for the purposes of our audit, we identified the impairment of goodwill as a key audit matter due to significant assumptions used in the determination of impairment for goodwill and the complexity of the value in use calculation

In evaluating the impairment of goodwill, we reviewed the value in use calculations prepared by the Directors, with a particular focus on the growth rate and discount rate. We performed various procedures, including the following:

- Tested inputs into the cash flow forecast against performance and in comparison to the Directors' strategic plans in respect of each cash-generating unit.
- Compared the growth rates used for the cash generating units to available forecast economic growth rates.
- Recomputed the value in use of each cash-generating unit.

The results of our assessment indicated that goodwill is not impaired. We further concluded that disclosures made in the financial statements in relation to goodwill impairment are appropriate.

Key Audit Matter (Consolidated financial statements) How the matter was addressed in the audit

Going Concern

Subsidiaries of the Group; Malawi Telecommunications Limited, The Foods Company Limited and Peoples Trading Centre Limited have been making losses for a number of years and have net current liability positions as at 31 December 2017.

The continued losses and net current liability positions raises questions about the ability of these companies to continue as going concerns and the impact of this on the Group's valuation of assets and liabilities using the going concern basis of accounting.

The Directors believe that these subsidiaries will continue as going concerns based on strategic plans that they have put in place. These plans involve making significant judgement and assumptions. We therefore consider the going concern of these subsidiaries and valuation of the respective assets and liabilities as a key audit matter.

In assessing the going concern of these subsidiaries we performed the following procedures:

- Evaluated management strategic plans for future actions and assess whether the outcome of those plans is likely to improve the situation and whether management's plans are feasible in the circumstances.
- Assessed if assumptions used in the management plans were based on reasonable data.
- Examined the financing structures for these companies and assessed whether adequate funds are available to sustain operations.
- Assessed if any going concern uncertainties affecting these companies has a material impact on the Group as a whole.

We concluded that despite the existence of uncertainties in the specific subsidiaries, the going concern assumption used for those subsidiaries was appropriate. As a consequence, we also consider the valuation of the assets appropriate.

Key Audit Matter (Consolidated financial statements) How the matter was addressed in the audit

Compliance with debt covenants

As disclosed in note 29, the Group has loans and borrowings with a carrying value of K55 billion as at 31 December 2017. Non-compliance with covenants governing these loans and borrowings may affect the liquidity of the Group and as such loans may become payable on demand and can also result in financial penalties for the Group. We therefore consider this as a key audit matter.

We inspected loan agreements; reviewed liquidity and financial ratios and reviewed management calculations associated with debt covenants to determine whether any breach of covenants exist.

We assessed if re-payments are being made when they fall due.

If, based on the work we have performed on the other information that we obtained prior to the date of this auditor's report, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

As part of an audit in accordance with ISAs, we exercise professional judgement and maintain professional scepticism throughout the audit. We also:

We are responsible for the direction, supervision and performance of the Group audit. We remain solely responsible for our audit opinion.

We communicate with the Directors regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide the Directors with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

From the matters communicated with the Directors, we determine those matters that were of most significance in the audit of the consolidated and separate financial statements of the current period and are therefore the key audit matters. We describe these matters in our auditor's report unless law or regulation precludes public disclosure about the matter or when, in extremely rare circumstances, we determine that a matter should not be communicated in our report because the adverse consequences of doing so would reasonably be expected to outweigh the public interest benefits of such communication.

1. **General Information**

Reporting entity

Press Corporation plc ('the company') is a company incorporated in Malawi under the Companies Act, 2013. It was listed on the Malawi Stock Exchange in September 1998 and as a Global Depository Receipt on the London Stock Exchange in July 1998. The consolidated financial statements as at, and for the year ended, 31 December 2017 comprise the company and its subsidiaries (together referred to as the 'Group' and individually as 'Group entities') and the Group's interest in associates and joint ventures.

The address of its registered office and principal place of business are disclosed in the directors' report together with the principal activities of the Group.

1.2 Going concern

The directors have, at the time of approving the Consolidated and Separate Financial Statements, a reasonable expectation that the Group and the Company have adequate resources to continue in operational existence for the foreseeable future. Thus they continue to adopt the going concern basis of accounting in preparing the Consolidated and Separate Financial Statements.

1.3 Functional and presentation currency

These consolidated and separate financial statements are presented in Malawi Kwacha, which is the functional currency of the principal subsidiaries within the Group. Except as indicated, all financial information presented in Malawi Kwacha has been rounded to the nearest million.

Application of new and revised International Financial Reporting Standards (IFRS)

Amendments to IFRSs that are mandatorily effective for the current year 2.1

In the current year, the Group has applied those new and revised Standards and Interpretations issued by the International Accounting Standards Board (IASB) and the International Financial Reporting Interpretations Committee of the International Accounting Standards Board that are relevant to its operations and are effective for an accounting period that begins on or after1 January 2017.

The adoption of these new and revised Standards and Interpretations did not have a significant impact on the financial statements of the Group.

2.2 New and revised IFRSs in issue but not yet effective

A number of new standards, amendments to standards and interpretations are effective for annual periods beginning on or after 1 January 2018, and have not been applied in preparing these financial statements. Those which may be relevant to the Group are set out below. The Group does not plan to adopt these standards early. These will be adopted in the period that they become mandatory.

IFRS 9 Financial Instruments

IFRS 9, issued in November 2009, introduced new requirements for the classification and measurement of financial assets. IFRS 9 was subsequently amended in October 2010 to include requirements for the classification and measurement of financial liabilities and for derecognition, and in November 2013 to include the new requirements for general hedge accounting. Another revised version of IFRS 9 was issued in July 2014 mainly to include impairment requirements for financial assets and limited amendments to the classification and measurement requirements by introducing a 'fair value through other comprehensive income' (FVTOCI) measurement category for certain simple debt instruments.

IFRS 9 Financial Instruments (Continued)

Key requirements of IFRS 9:

- All recognized financial assets that are within the scope of IFRS 9 are required to be subsequently measured at amortised cost or fair value. Specifically, debt investments that are held within a business model whose objective is to collect the contractual cash flows, and that have contractual cash flows that are solely payments of principal and interest on the principal outstanding are generally measured at amortised cost at the end of subsequent accounting periods. Debt instruments that are held within a business model whose objective is achieved both by collecting contractual cash flows and selling financial assets, and that have contractual terms that give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding, are generally measured at FVTOCI. All other debt investments and equity investments are measured at their fair value at the end of subsequent accounting periods. In addition, under IFRS 9, entities may make an irrevocable election to present subsequent changes in the fair value of an equity investment (that is not held for trading nor contingent consideration recognized by an acquirer in a business combination) in other comprehensive income, with only dividend income generally recognized in profit or loss;
- With regard to measurement of financial liabilities designated as at fair value through profit or loss, IFRS 9 requires that the amount of change in the fair value of a financial liability that is attributable to changes in the credit risk of that liability is presented in other comprehensive income, unless the recognition of such changes in other comprehensive income would create or enlarge an accounting mismatch in profit or loss. Changes in fair value attributable to a financial liability's credit risk are not subsequently reclassified to profit or loss. Under IAS 39, the entire amount of the change in the fair value of the financial liability designated as fair value through profit or loss is presented in profit or loss;
- In relation to the impairment of financial assets, IFRS 9 requires an
 expected credit loss model, as opposed to an incurred credit loss model
 under IAS 39. The expected credit losses and changes in those expected
 credit losses each reporting date to reflect changes in credit risk since
 initial recognition. In other words, it is no longer necessary for a credit
 event to have occurred before credit losses are recognised; and
- The new general hedge accounting requirements retain the three types of hedge accounting mechanics currently available in IAS 39. Under IFRS 9, greater flexibility has been introduced to the types of transactions eligible for hedge accounting, specifically broadening the types of instruments that qualify for hedging instruments and the types of risk components of non-financial items that are eligible for hedge accounting. In addition, the effectiveness test has been overhauled and replaced with the principle of an "economic relationship". Retrospective assessment of hedge effectiveness is also no longer required. Enhanced disclosure requirements about an entity's risk management activities have also been introduced.

Annual periods beginning on or after 1 January 2018

IFRS 15 Revenue from Contracts with Customers

IFRS 15 specifies how and when an entity will recognise revenue as well as requiring such entities to provide users of financial statements with more informative, relevant disclosures.

The core principle of IFRS 15 is that an entity will recognise revenue to depict the transfer of promised goods or services to customers in an amount that reflects the consideration to which the entity expects to be entitled in exchange for those goods or services. Specifically, the Standard introduces a 5-step approach to revenue recognition:

- Step 1: Identify the contract(s) with a customer;
- Step 2: Identify the performance obligations in the contract;
- Step 3: Determine the transaction price;
- Step 4: Allocate the transaction price to the performance obligations in the contract; and
- Step 5: Recognise Revenue when (or as) the entity satisfies a performance

Under IFRS15, an entity recognises Revenue when (or as) a performance obligation is transferred to the customer.

Far more prescriptive guidance has been added in IFRS 15 to deal with specific scenarios. Furthermore, extensive disclosures are required by IFRS 15.

In April 2016, the IASB issued Classifications to IFRS 15 in relation to the identification of performance obligations, principal versus agent considerations, as well as licensing application guidance.

Annual periods beginning on or after 1 January 2019

IFRS 16 Leases

IFRS 16 introduces a comprehensive model for the identification of lease arrangements and accounting treatments for both lessors and lessees. IFRS 16 will supersede the current lease guide including IAS 17 Leases and the related interpretations when it becomes effective.

IFRS 16 distinguishes leases and service contracts on the basis of whether an identified asset is controlled by a customer. Distinctions of operating leases (off balance sheet) and finance leases (on balance sheet) are removed for lessee accounting, and is replaced by a model where a right-of-use asset and corresponding liability have to be recognized for all leases by lessees (i.e. all on balance sheet) except for short-term leases and leases of low value assets.

The right-of-use asset is initially measured at cost and subsequently measured at cost (subject to certain exceptions) less accumulated depreciation and impairment losses, adjusted for any re-measurement of the lease liability. The lease liability is initially measured at present value of the lease payments that are aid at that date. Subsequently, the lease liability is adjusted for interest and lease payments, as well as the impact of lease modifications, amongst others. Furthermore, the classification of cash flows will also be affected as operating lease payments under IAS 17 are presented as operating cash flows; whereas under the IFRS 16 model, the lease payments will be split into a principal and an interest portion that will be presented as financing and operating cash flows respectively.

In contrast to lessee accounting, IFRS 16 substantially carries forward the lessor accounting requirements in IAS 17, and continues to require a lessor to classify a lease either as an operating lease or a finance lease.

Furthermore, extensive disclosures are required by IFRS 16.

Annual reporting periods beginning on or after 1 January 2021

IFRS 17 Insurance Contracts

IFRS 17 requires insurance liabilities to be measured at a current fulfilment value and provides a more uniform measurement and presentation approach for all insurance contracts. These requirements are designed to achieve the goal of a consistent, principle-based accounting for insurance contracts. IFRS 17 supersedes IFRS 4 Insurance Contracts as of 1 January 2021.

Annual periods beginning on or after 1 January 2018

Classification and Measurement of Share-based Payment Transactions

Amends IFRS 2 Share-based Payment to clarify the standard in relation to the accounting for cash-settled share-based payment transactions that include a performance condition, the classification of share-based payment transactions with net settlement features, and the accounting for modifications of share-based payment transactions from cash-settled to equity-settled.

The amendments to IFRS 1 and IAS 28 are effective for annual periods beginning on or after 1 January 2018

Annual Improvements to IFRS Standards 2014-2016 Cycle

Makes amendments to the following standards:

- IFRS 1 Deletes the short-term exemptions in paragraphs E3–E7 of IFRS 1, because they have now served their intended purpose
- IAS 28 Clarifies that the election to measure at fair value through profit
 or loss an investment in an associate or a joint venture that is held by
 an entity that is a venture capital organisation, or other qualifying entity,
 is available for each investment in an associate or joint venture on an
 investment-by-investment basis, upon initial recognition.

Annual reporting periods beginning on or after 1 January 2018

IFRIC 22 Foreign Currency Transactions and Advance Consideration

The interpretation addresses foreign currency transactions or parts of transactions where:

- There is consideration that is denominated or priced in a foreign currency;
- The entity recognises a prepayment asset or a deferred income liability in respect of that consideration, in advance of the recognition of the related asset, expense or income; and
- The prepayment asset or deferred income liability is non-monetary.

The Interpretations Committee came to the following conclusion:

- The date of the transaction, for the purpose of determining the exchange rate, is the date of initial recognition of the non-monetary prepayment asset or deferred income liability.
- If there are multiple payments or receipts in advance, a date of transaction is established for each payment or receipt.

Annual reporting periods beginning on or after 1 January 2019

IFRIC 23 Uncertainty over Income Tax Treatments

The interpretation addresses the determination of taxable profit (tax loss), tax bases, unused tax losses, unused tax credits and tax rates, when there is uncertainty over income tax treatments under IAS 12. It specifically considers:

- Whether tax treatments should be considered collectively;
- Assumptions for taxation authorities' examinations;
- The determination of taxable profit (tax loss), tax bases, unused tax losses, unused tax credits and tax rates; and
- The effect of changes in facts and circumstances.

Annual periods beginning on or after 1 January 2019

Prepayment Features with Negative Compensation (Amendments to IFRS 9)

Amends the existing requirements in IFRS 9 regarding termination rights in order to allow measurement at amortised cost (or, depending on the business model, at fair value through other comprehensive income) even in the case of negative compensation payments.

Annual periods beginning on or after 1 January 2019

Long-term Interests in Associates and Joint Ventures (Amendments to IAS 28)

Clarifies that an entity applies IFRS 9 Financial Instruments to long-term interests in an associate or joint venture that form part of the net investment in the associate or joint venture but to which the equity method is not applied

The directors anticipate that other than IFRS 9 and IFRS 15 these Standards and Interpretations in future periods will have no significant impact on the financial statements of the Group. IFRS 9 will impact the measurement of financial instruments and IFRS 15 will affect recognition of revenue.

Assessed impact of IFRS 15 Revenue from Contracts with Customers

IFRS 15 Revenue from Contracts with Customers which establishes a single comprehensive model for use in accounting for revenue from contracts with customers is expected to have an impact on the Group's telecommunication businesses. The directors of the Group have preliminarily assessed that the "contract handsets and contract packages" represent two separate performance obligations from the sale of the contract packages and handsets and accordingly, its revenue reported service revenues will be recognized for each of these performance obligations when control over the corresponding goods and services is transferred to the customer.

Assessed impact of IFRS 9 Financial Instruments

The directors have preliminarily assessed that loans and advances to customers, finance lease receivables, other investments and trade and other receivables will be subject to the impairment provisions of IFRS 9. The Group expects to apply the general approach to recognise lifetime and 12-month expected credit losses for loans and advances to customers and finance lease receivables. Other investments have been deemed to have low credit risk by the directors as they include Malawi Government Bills and Notes which are guranteed by the Government of Malawi and Money Market deposits which are transacted with reputable financial institutions, the Group hence expects to recognise 12 month expected credit losses for these items. The Group expects to apply the simplified approach to recognise lifetime expected credit losses for its trade and other receivables as permitted by IFRS 9.

In general, the directors anticipate that the application of the expected credit loss model of IFRS 9 will result in earlier recognition of credit losses for the respective items and will increase the amount of loss allowance recognised for these items. The Group is in the progress of developing its models and this is expected to be completed in the first half of 2018.

3. Significant accounting policies

3.1 Statement of compliance

The consolidated and separate financial statements have been prepared in accordance with International Financial Reporting Standards (IFRSs) as issued by the International Accounting Standards Board (IASB) and provisions of the Companies Act, 2013.

3.2 Basis of preparation

The consolidated and separate financial statements have been prepared on the historical cost basis except for the following items in the statement of financial position:

- Financial instruments at fair value through profit or loss are measured at fair value.
- Biological assets are measured at fair value less costs to sell.
- Investment property is measured at fair value.
- Investments in subsidiaries, joint ventures and associates are measured at fair value in the company financial statements.
- Land and buildings is measured at fair value.

3. Significant accounting policies (Continued)

3.2 Basis of preparation (Continued)

The methods used to measure fair values are discussed further in note 6.7.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 and 3 based on the degree to which inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety.

These different levels have been defined in note 6.7.

The accounting policies set out below have been applied consistently to all periods presented in these consolidated and separate financial statements, and have been applied consistently by Group entities.

3.3 Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities that are controlled by the Company and its subsidiaries. Under the Companies Act, 2013 and International Financial Reporting Standard 10, Consolidated Financial Statements, control is achieved when the company:

- Has power over the investee:
- Is exposed, or has rights to variable returns from its involvement with the investee; and
- Has the ability to use its power to affect its returns.

The Company reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

When the Company has less than a majority of the voting rights of an investee, it has power when the voting rights are sufficient to give it the practical ability to direct the relevant activities of the investee unilaterally. The company considers all relevant facts and circumstances in assessing whether or not the Company's voting rights in an investee are sufficient to give it power, including:

- The size of the Company's holding of voting rights relative to the size and dispersion of holdings of the other vote holders;
- Potential voting rights held by the company, other vote holders or other parties;
- Rights arising from other contractual arrangements; and
- Any additional facts and circumstances that indicate that the company has, does not have, the current ability to direct the relevant activities at the time that decisions need to be made, including patterns at previous shareholders' meetings.

Consolidation of a subsidiary begins when the Company obtains control over the subsidiary and ceases when the company loses control of the subsidiary. Specifically, assets, liabilities, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of comprehensive income and financial position from the date the company gains control until the date when the company ceases to control the subsidiary.

Profit or loss and each component of other comprehensive income are attributed to the owners of the company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies in line with the Group's accounting policies.

All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

In the separate financial statements the investments are measured at fair value. These are valued on a regular basis by external valuers.

3.3.1 Changes in the Group's ownership interests in existing subsidiaries

Changes in the Group's ownership interests in subsidiaries that do not result in the Group losing control over the subsidiaries are accounted for as equity transactions. The carrying amounts of the Group's interests and the non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiaries. Any difference between the amount by which the non-controlling interests are adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to owners of the company.

When the Group loses control of a subsidiary, a gain or loss is recognized in profit or loss and is calculated as the difference between:

- (i) The aggregate of the fair value of the consideration received and the fair value of any retained interest;
- (ii) The previous carrying amount of the assets (including goodwill), and liabilities of the subsidiary and any non-controlling interests.

All amounts previously recognized in other comprehensive income in relation to that subsidiary are accounted for as if the Group has directly disposed of the related assets or liabilities of the subsidiary. The fair value of any investment retained in the former subsidiary at the date when control is lost is regarded as the fair value on initial recognition for subsequent accounting under IAS 39, when applicable, the cost on initial recognition of an investment in an associate or a joint venture.

Business combinations 3.4

Acquisitions of subsidiaries and businesses are accounted for using the acquisition method. The consideration transferred in a business combination is measured at fair value, which is calculated as the sum of the acquisitiondate fair values of the assets transferred by the Group, liabilities incurred by the Group to the former owners of the acquire and equity interests issued by the Group in exchange for control of the acquiree. Acquisition-related costs are generally recognised in profit or loss as incurred.

At the acquisition date, the identifiable assets acquired and liabilities assumed are recognised at their fair value, except that:

- Deferred tax assets or liabilities, and assets or liabilities related to employee benefit arrangements are recognised and measured in accordance with IAS 12 Income taxes and IAS 19 Employee benefits respectively;
- Liabilities or equity instruments related to share-based payment arrangements of the acquiree or share-based payment arrangements of the Group entered into to replace share-based payment arrangements of the acquiree are measured in accordance with IFRS 2 Share based payment at the acquisition date; and
- Assets (or disposal groups) that are classified as held for sale in accordance with IFRS 5 Non-current Assets Held for Sale and Discontinued Operations are measured in accordance with that Standard.

Goodwill is measured as the excess of the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree, and the fair value of the acquirer's previously held equity interest in the acquiree (if any) over the net of the acquisition-date amounts of the identifiable assets acquired and the liabilities assumed. If, after reassessment, the net of the acquisition-date amounts of the identifiable assets acquired and liabilities assumed exceeds the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree and the fair value of the acquirer's previously held interest in the acquiree (if any), the excess is recognized immediately in profit or loss as a bargain purchase gain.

Non-controlling interests that are present ownership interests and entitle their holders to a proportionate share of the entity's net assets in the event of liquidation may be initially measured either at fair value or at the non-controlling interests' proportionate share of the recognised amounts of the acquiree's identifiable net assts. The choice of measurement basis is made on a transaction by-transaction basis. Other types of non-controlling interests are measured at fair value or, when applicable on the basis specified in another IFRS.

When the consideration transferred by the Group in a business combination includes assets or liabilities resulting from a contingent consideration arrangement, the contingent consideration is measured at its acquisition-date fair value and included as part of the consideration transferred in a business combination. Changes in the fair value of the contingent consideration that qualify as measurement period adjustments are adjusted retrospectively, with corresponding adjustments against goodwill. Measurement period adjustments are adjustments that arise from additional information obtained during the 'measurement period' (which cannot exceed one year from the acquisition date) about facts and circumstances that existed at the acquisition date.

The subsequent accounting for changes in the fair value of the contingent consideration that do not qualify as measurement period adjustments depends on how the contingent consideration is classified. Contingent consideration that is classified as equity is not re-measured at subsequent reporting dates and its subsequent settlement is accounted for within equity. Contingent consideration that is classified as an asset or liability is re-measured at subsequent reporting dates in accordance with IAS 39 Financial Instruments: Recognition and Measurement, or IAS 37 Provisions, Contingent Liabilities and Contingent Assets, as appropriate with the corresponding gain or loss being recognized in profit or loss.

3.4 Business combinations (Continued)

When a business combination is achieved in stages, the Group's previously held equity interest in the acquiree is remeasured to its acquisition-date fair value and the resulting gain or loss, if any, is recognized in profit or loss. Amounts arising from interests in the acquiree prior to the acquisition date that have previously been recognized in other comprehensive income are reclassified to profit or loss when such treatment would be appropriate if that interest were disposed of.

If the initial accounting for a business combination is incomplete by the end of the reporting period in which the combination occurs, the Group reports provisional amounts for the items for which the accounting is incomplete. Those provisional amounts are adjusted during the measurement period (see above), or additional assets or liabilities are recognized, to reflect new information obtained about facts and circumstances that existed at the acquisition date that, if known, would have affected the amounts recognized at that date.

3.5 Goodwill

Goodwill arising on an acquisition of a business is carried at cost as established at the date of acquisition of the business less accumulated impairment losses, if any.

For the purpose of impairment testing, goodwill is allocated to each of the Group's cash-generating units that is expected to benefit from the synergies of the combination.

A cash-generating unit to which goodwill has been allocated is tested for impairment annually, or more frequently when there is an indication that the unit may be impaired. If the recoverable amount of the cash-generating unit is less than its carrying amount, the impairment loss is allocated first to reduce the carrying amount of any goodwill allocated to the unit and then to the other assets of the unit pro-rata based on the carrying amount of each asset in the unit. Any impairment loss for goodwill is recognised directly in profit or loss. An impairment loss recognised for goodwill is not reversed in subsequent periods.

On disposal of the relevant cash-generating unit, the attributable amount of goodwill is included in the determination of the profit or loss on disposal.

The Group's policy for goodwill arising on the acquisition of an associate and a joint venture is described at note 3.6 below.

3.6 Investments in Associates and Joint Ventures

An associate is an entity over which the Group has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee but is not control or joint control over those policies.

A joint venture is a joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint arrangement. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require unanimous consent of the parties sharing control.

The results and assets and liabilities of associates or joint ventures are incorporated in these consolidated financial statements using the equity method of accounting, except when the investment, or a portion thereof, is classified as held for sale, in which case it is accounted for in accordance with IFRS 5. Under the equity method, an investment in an associate or a joint venture is initially recognised in the consolidated statement of financial position at costand adjusted thereafter to recognise the Group's share of the profit or loss and other comprehensive income of the associate or joint venture. When the Group's share of losses of an associate or a joint venture exceeds the Group's interest in that associate or joint venture (which includes any long-term interests that, in substance, form part of the Group's net investment in the associate or joint venture), the Group discontinues recognising its share of further losses. Additional losses are recognised only to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the associate or joint venture.

An investment in an associate or a joint venture is accounted for using the equity method from the date on which the investee becomes an associate or a joint venture. On acquisition of the investment in an associate or a joint venture, any excess of the cost of the investment over the Group's share of the net fair value of the identifiable assets and liabilities of the investee is recognised as goodwill, which is included within the carrying amount of the investment. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of the investment, after reassessment, is recognised immediately in profit or loss in the period in which the investmentis acquired.

Investments in Associates and Joint Ventures (Continued)

The requirements of IAS 39 are applied to determine whether it is necessary to recognise any impairment loss with respect to the Group's investment in an associate or a joint venture. When necessary, the entire carrying amount of the investment (including goodwill) is tested for impairment in accordance with IAS 36 Impairment of Assets as a single asset by comparing its recoverable amount (higher of value in use and fair value less costs of disposal) with its carrying amount. Any impairment loss recognised forms part of the carrying amount of the investment. Any reversal of that impairment loss is recognised in accordance with IAS 36 to the extent that the recoverable amount of the investment subsequently increases.

The Group discontinues the use of the equity method from the date when the investment ceases to be an associate or a joint venture, or when the investment is classified as held for sale. When the Group retains an interest in the former associate or joint venture and the retained interest is a financial asset, the Group measures the retained interest at fair value at that date and the fair value is regarded as its fair value on initial recognition in accordance with IAS 39. The difference between the carrying amount of the associate or joint venture at the date the equity method was discontinued, and the fair value of any retained interest and any proceeds from disposing of a part interest in the associate or joint venture is included in the determination of the gain or loss on disposal of the associate or joint venture. In addition, the Group accounts for all amounts previously recognised in other comprehensive income in relation to that associate or joint venture on the same basis as would be required if that associate or joint venture had directly disposed of the related assets or liabilities. Therefore, if a gain or loss previously recognised in other comprehensive income by that associate or joint venture would be reclassified to profit or loss on the disposal of the related assets or liabilities, the Group reclassifies the gain or loss from equity to profit or loss (as a reclassification adjustment) when the equity method is discontinued.

The Group continues to use the equity method when an investment in an associate becomes an investment in a joint venture or an investment in a joint venture becomes an investment in an associate. There is no remeasurement to fair value upon such changes in ownership interests.

When the Group reduces its ownership interest in an associate or a joint venture but the Group continues to use the equity method, the Group reclassifies to profit or loss the proportion of the gain or loss that had previously been recognised in other comprehensive income relating to that reduction in ownership interest if that gain or loss would be reclassified to profit or loss on the disposal of the related assets or liabilities.

When a Group entity transacts with an associate or a joint venture of the Group, profits and losses resulting from the transactions with the associate or joint venture are recognised in the Group's consolidated financial statements only to the extent of interests in the associate or joint venture that are not related to the Group.

In separate financial statements, investments in associates and joint ventures are carried at fair value.

3.7 Interests in joint operations

A joint operation is a joint arrangement whereby the parties that have joint control of the arrangement haverights to the assets, and obligations for the liabilities, relating to the arrangement. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require unanimous consent of the parties sharing control.

When a Group entity undertakes its activities under joint operations, the Group as a joint operator recognises in relation to its interest in a joint operation:

- its assets, including its share of any assets held jointly;
- its liabilities, including its share of any liabilities incurred jointly;
- its revenue from the sale of its share of the output arising from the joint operation;
- its share of the revenue from the sale of the output by the joint operation; and
- Its expenses, including its share of any expenses incurred jointly.

The Group accounts for the assets, liabilities, revenues and expenses relating to its interest in a joint operation in accordance with the IFRSs applicable to the particular assets, liabilities, revenues and expenses.

When a Group entity transacts with a joint operation in which a group entity is a joint operator (such as a sale or contribution of assets), the Group is considered to be conducting the transaction with the other parties to the joint operation, and gains and losses resulting from the transactions are recognised in the Group's consolidated financial statements only to the extent of other parties' interests in the joint operation.

When a Group entity transacts with a joint operation in which a Group entity is a joint operator (such as a purchase of assets), the Group does not recognise its share of the gains and losses until it resells those assets to a third party.

3.8 Non-current assets held for sale

Non-current assets and disposal groups are classified as held for sale if their carrying amount will be recovered principally through a sale transaction rather than through continuing use. This condition is regarded as met only when the asset (or disposal group) is available for immediate sale in its present condition subject only to terms that are usual and customary for sales of such asset (or disposal group) and its sale is highly probable. Management must be committed to the sale, which should be expected to qualify for recognition as a completed sale within one year from the date of classification.

When the Group is committed to a sale plan involving loss of control of a subsidiary, all of the assets and liabilities of that subsidiary are classified as held for sale when the criteria described above are met, regardless of whether the Group will retain a non-controlling interest in its former subsidiary after the sale.

When the Group is committed to a sale plan involving disposal of an investment, or a portion of an investment, in an associate or joint venture, the investment or the portion of the investment that will be disposed of is classified as held for sale when the criteria described above are met, and the Group discontinues the use of the equity method in relation to the portion that is classified a held for sale. Any retained portion of an investment in an associate or a joint venture that has not been classified as held for sale continues to be accounted for using the equity method. The Group discontinues the use of the equity method at the time of disposal when the disposal results in the Group losing significant influence over the associate or joint venture.

After the disposal takes place, the Group accounts for any retained interest in the associate or joint venture in accordance with IAS 39 unless the retained interest continues to be an associate or a joint venture, in which case the Group uses the equity method (see the accounting policy regarding investments in associates or joint ventures above).

Non-current assets (and disposal groups) classified as held for sale are measured at the lower of their carrying amount and fair value less costs to sell.

3.9 Revenue recognition

Revenue represents amounts invoiced or sales otherwise made in the normal course of trade of the respective companies after deduction of Value Added Tax (VAT) and credit notes where applicable. Group revenue excludes sales between Group companies.

3.9.1 Sale of goods

Revenue from the sale of goods is recognized when the goods are delivered and titles have passed, at which time all the following conditions are satisfied:

- The Group has transferred to the buyer the significant risks and rewards of ownership of the goods;
- The Group retains neither continuing managerial involvement to the degree usually associated with ownership nor effective control over the goods sold;
- The amount of revenue can be measured reliably;
- It is probable that the economic benefits associated with the transaction will flow to the Group; and
- The costs incurred or to be incurred in respect of the transaction can be measured reliably.

If it is probable that discounts will be granted and the amount can be measured reliably, the discount is recognised as a reduction of revenue as the sales are recognized. No revenue is recognised if there are significant uncertainties regarding recovery of the consideration due, associated costs or the possible return of goods.

Revenue from the sale of goods in the course of ordinary activities is measured at the fair value of the consideration received or receivable, net of returns and allowances, trade discounts and volume rebates.

3.9.2 Rendering of services

Revenue from services rendered is recognised in profit or loss by reference to the stage of completion of the transaction at the reporting date. Specifically:

- Revenue from prepaid, post-paid and international roaming telephone service is recognised when airtime is used by the customer. Value of unused airtime on prepaid service sold to customers and unused bonuses in customer phones is recognised as deferred revenue in the consolidated statement of financial position.
- Installation revenue is recognised on the date of installation.

Revenue recognition (Continued)

3.9.3 Interest income

Interest income for all interest-bearing financial instruments except for those classified as held for trading or designated at fair value through profit and loss are recognised within "revenues" in the statement of comprehensive income using the effective interest rate method.

The effective interest rate method is a method of calculating the amortised cost of a financial asset or a financial liability and of allocating the interest income over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash payments or receipts through the expected life of the financial instrument or, when appropriate, a shorter period to the net carrying amount of the financial asset or financial liability. When calculating the effective interest rate, the Group estimates cash flows considering all contractual terms of the financial instrument (for example, prepayment options) but does not consider future credit losses. The calculation includes all fees and points paid or received between parties to the contract that are an integral part of the effective interest rate, transaction costs and all other premiums or discounts.

Once a financial asset or a group of similar financial assets has been written down as a result of an impairment loss, interest income is recognised using the rate of interest used to discount the future cash flows for the purpose of measuring the impairment loss.

3.9.4 Fees and commissions

Fees and commission income that are integral to the effective interest rate on a financial asset are included in the effective interest rate. Other fees and commission are generally recognised on an accrual basis when the services have been provided, specifically:

- Loan commitment fees for loans that are likely to be drawn down are deferred (together with related direct costs) and recognised as an adjustment to the effective interest rate on the loan.
- Loan syndication fees are recognised as revenue when the syndication has been completed and the bank retained no part of the loan package for itself or retained a part at the same effective interest rate for the other participants.
- Commission and fees arising from negotiating or participating in the negotiation of a transaction for a third party, such as the arrangement of the acquisition of shares or other securities or the purchase or sale of businesses are recognised on completion of the underlying transaction.
- Portfolio and other management advisory and service fees are recognised based on the applicable service contracts, usually on a time apportion basis.
- Asset management fees related to investment funds are recognised rateably over the period in which the service is provided. The same principle is applied to wealth management, financial planning and custody services that are continuously provided over an extended period of time.
- Performance linked fees or fee components are recognised when the performance criteria are fulfilled.

3.9.5 Rental income

Rental income from investment property is recognized in the profit or loss on a straight line basis over the term of the lease. Lease incentives granted are recognized as an integral part of the total rental income to be received.

The Group's policy for recognition of revenue from operating leases is description in note 3.10 below.

Rental income from other property is recognised as other income.

3.9.6 Dividend income

Dividend income from investments is recognised when the shareholder's right to receive payment has been established.

3.9.7 Premium on foreign exchange deals

Premium on spot foreign exchange deals are recognised as income when the deal is agreed.

3.9 Revenue recognition (Continued)

3.9.8 Other revenue

Revenue on other sales is recognised on the date all risks and rewards associated with the sale are transferred to the purchaser.

Revenue on other services is recognised upon the performance of the contractual obligation.

3.10 Leases

Leases are classified as finance lease when the terms of the lease transfer substantially all the risks and rewards of ownership to/from the Group. All other leases are classified as operating leases.

3.10.1 The Group as lessor

Amounts due from lessees under finance leases are recognised as receivables at the amount of the Group's net investment in the leases. Finance lease income is allocated to accounting periods so as to reflect a constant periodic rate of return on the Group's net investment outstanding in respect of the leases.

Rental income from operating leases is recognised on a straight-line basis over the term of the relevant lease. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised as an expense on a straight-line basis over the lease term.

3.10.2 The Group as lessee

Assets held under finance leases are recognised as assets of the Group at their fair value at the inception of the lease or, if lower, at the present value of the minimum lease payments. Subsequent to initial recognition, the asset is accounted for in accordance with the accounting policy applicable to that asset. The corresponding liability to the lessor is included in the consolidated and separate statement of financial position as a finance lease obligation.

Lease payments are apportioned between finance charges and reduction of the lease obligation so as to achieve a constant rate of interest on the remaining balance of the liability. Finance expenses are recognised immediately in profit or loss, unless they are directly attributable to qualifying assets, in which case they are capitalised in accordance with the Group's general policy on borrowing costs (see note 3.12 below). Contingent rentals are recognised as expenses in the periods in which they are incurred.

Operating lease payments are recognised as an expense on a straight-line basis over the lease term. Benefits received and receivable as an incentive to enter into an operating lease are also spread on a straight-line basis over the lease term. Investment property held under an operating lease is recognised on the Group's statement of financial position at its fair value.

3.11 Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the entity's functional currency (foreign currencies) are recognised at the rates of exchange prevailing at the dates of the transactions. At the end of each reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing at the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences on monetary items are recognised in profit or loss in the period in which they arise except for:

- exchange differences on foreign currency borrowings relating to assets under construction for future productive use, which are included in the cost of those assets when they are regarded as an adjustment to interest costs on those foreign currency borrowings; and
- exchange differences on monetary items receivable from or payable to a foreign operation for which settlementis neither planned nor likely to occur (therefore forming part of the net investment in the foreign operation), which are recognised initially in other comprehensive income and reclassified from equity to profit or loss on repayment of the monetary items.

Foreign currencies (Continued)

For the purposes of presenting these consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated into Currency Units using exchange rates prevailing at the end of each reporting period. Income and expense items are translated at the average exchange rates for the period, unless exchange rates fluctuate significantly during that period, in which case the exchange rates at the dates of the transactions are used. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity (and attributed to non-controlling interests as appropriate).

On the disposal of a foreign operation (i.e. a disposal of the Group's entire interest in a foreign operation, a disposal involving loss of control over a subsidiary that includes a foreign operation, or a partial disposal of an interest ina joint arrangement or an associate that includes a foreign operation of which the retained interest becomesa financial asset), all of the exchange differences accumulated in equity in respect of that operation attributable to the owners of the Company are reclassified to profit or loss.

In addition, in relation to a partial disposal of a subsidiary that includes a foreign operation that does not result in the Group losing control over the subsidiary, the proportionate share of accumulated exchange differencesare re-attributed to non-controlling interests and are not recognised in profit or loss. For all other partial disposals(i.e. partial disposals of associates or joint arrangements that do not result in the Group losing significant influence or joint control), the proportionate share of the accumulated exchange differences is reclassified to profit or loss.

Goodwill and fair value adjustments to identifiable assets acquired and liabilities assumed through acquisition of a foreign operation are treated as assets and liabilities of the foreign operation and translated at the rateof exchange prevailing at the end of each reporting period. Exchange differences arising are recognised in other comprehensive income.

3.12 Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale.

Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

3.13 Employee benefits

3.13.1 Defined contribution plans

A defined contribution plan is a post-employment benefit plan under which an entity pays fixed contributions into a separate entity and will have no legal or constructive obligation to pay further amounts. Obligations for contributions to defined contribution pension plans are recognised as an employee benefit expense in profit or loss in the periods during which services are rendered by employees.

The Group contributes to a number of defined contribution pension schemes on behalf of its employees, the assets of which are kept separate from the Group. Contributions to the Fund are based on a percentage of the payroll and are recognised as an expense in the profit or loss when employees have rendered service entitling them to the contributions. Prepaid contributions are recognised as an asset to the extent that a cash refund or a reduction in future payments is available.

Once the contributions have been paid, the Group has no further payment obligations.

3.13.2 Termination benefits

A liability for a termination benefit is recognised at the earlier of when the entity can no longer withdraw the offer of the termination benefit and when the entity recognises any related restructuring costs. If benefits are payable more than 12 months after the reporting period, then they are discounted to their present value.

3.13.3 Short-term benefits

A liability is recognised for benefits accruing to employees in respect of wages and salaries, annual leave, sick leave and non-monetarybenefits in the period the related service is rendered at the undiscounted amount of the benefits expected to be paid in exchange for that service.

3.13 Employee benefits (Continued)

3.13.3 Short-term benefits (Continued)

A liability is recognised for the amount expected to be paid under short-term cash bonus or profit sharing plans if the Group has a present legal constructive obligation to pay this amount as a result of past service provided by the employee, and the obligation can be estimated reliably.

3.14 Taxation

Income tax expense represents the sum of the tax currently payable and deferred tax.

3.14.1 Current tax

The tax currently payable is based on taxable profit for the year. Taxable profit differs from 'profit before tax' as reported in the consolidated and separate statements of comprehensive income because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Additional income taxes that arise from the distribution of dividends are recognised at the same time as the liability to pay the related dividend is recognised.

3.14.2 Deferred tax

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated and separate financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profitswill be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and liabilities are not recognised if the temporary difference arises from the accounting profit. In addition, deferred tax liabilities are not recognised if the temporary difference arises from the initial recognition of goodwill.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries and associates, and interests in joint ventures, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments and interests are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax liabilities and assets are measured at the tax rates that are expected to apply in the period in whichthe liability is settled or the asset realised, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

For the purposes of measuring deferred tax liabilities and deferred tax assets for investment properties that are measured using the fair value model, the carrying amounts of such properties are presumed to be recovered entirely through sale, unless the presumption is rebutted. The presumption is rebutted when the investment property is depreciable and is held within a business model whose objective is to consume substantially all of the economic benefits embodied in the investment property over time, rather than through sale. The directors of the Company reviewed the Group's investment property portfolios and concluded that none of the Group's investment properties are held under a business model whose objective is to consume substantially all of the economic benefits embodied in the investment properties over time, rather than through sale. Therefore, the directors have determined that the 'sale' presumption set out in the amendments to IAS 12 is not rebutted. As a result, the Group has recognisedany deferred taxes on changes in fair value of the investment properties on disposal.

3.14 Taxation (Continued)

3.14.3 Current and deferred tax for the year

Current and deferred tax are recognised in profit or loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively. Where current tax or deferred tax arises from the initial accounting for a business combination, the tax effect is included in the accounting for the business combination.

3.15 Property, plant and equipment

3.15.1 Recognition and measurement

Land and buildingsheld for use in the production or supply of goods or services, or for administrative purposes, are stated in the consolidated statement of financial position at their revalued amounts, being the fair value at the date of revaluation, less any subsequent accumulated depreciation and subsequent accumulated impairment losses. Revaluations are performed by independent valuers with sufficient regularity such that the carrying amounts do not differ materially from those that would be determined using fair values at the end of each reporting period. The basis of valuation used is current market value.

Any revaluation increase arising on the revaluation of such land and buildings is recognised in other comprehensive income and accumulated in equity, except to the extent that it reverses a revaluation decrease for the sameasset previously recognised in profit or loss, in which case the increase is credited to profit or loss to the extent of the decrease previously expensed. A decrease in the carrying amount arising on the revaluation of such land and buildings and fishing vessels is recognised in profit or loss to the extent that it exceeds the balance, if any, held in the revaluation reserve relating to a previous revaluation of those assets.

Properties in the course of construction for production, supply or administrative purposes are carried at cost, less any recognised impairment loss. Cost includes professional fees and, for qualifying assets, borrowing costs capitalised in accordance with the Group's accounting policy. Such properties are classified to the appropriate categories of property, plant and equipment when completed and ready for intended use. Depreciation of theseassets, on the same basis as other property assets, commences when the assets are ready for their intended use.

Depreciation on revalued buildings is recognised in profit or loss. On the subsequent sale or retirement of a revalued property, the attributable revaluation surplus remaining in the properties revaluation reserve is transferred directly to retained earnings.

Freehold land is not depreciated.

Motor vehicles, plant, furniture and equipment are stated at cost less accumulated depreciation and accumulated impairment losses.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

3.15.2 Subsequent expenditure

Subsequent expenditure is capitalised only if it is probable that the future economic benefits associated with the expenditure will flow to the Group.

3.15.3 Depreciation

Depreciation is recognised so as to write off the cost or valuation of assets (other than freehold land and properties under construction) less their residual values over their useful lives, using the straight-line method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis. If significant parts of an item of property, plant and equipment have different useful lives, then they are accounted for as separate items (major components) of property, plant and equipment.

Assets held under finance leases are depreciated over their expected useful lives on the same basis as owned assets. However, when there is no reasonable certainty that ownership will be obtained by the end of the lease term, assets are depreciated over the shorter of the lease term and their useful lives.

3.15 Property, plant and equipment (Continued)

3.15.4 Reclassification to investment property

When the use of a property changes from owner-occupied to investment property, the property is remeasured to fair value and reclassified accordingly. Any gain arising on this re-measurement is recognised in profit or loss to the extent that it reverses a previous impairment loss on the specific property, with any remaining gain recognised in other comprehensive income and presented in the revaluation reserve. Any loss is recognised in profit and loss.

3.16 Investment property

Investment properties are properties held to earn rentals and/or for capital appreciation (including property under construction for such purposes). Investment properties are measured initially at cost, including transaction costs. Subsequent to initial recognition, investment properties are measured at fair value. All of the Group's property interests held under operating leases to earn rentals or for capital appreciation purposes are accounted for as investment properties and are measured using the fair value model. Gains and losses arising from changes in the fair value of investment properties are included in profit or loss in the period in which they arise.

When the use of a property changes such that it is reclassified as property, plant and equipment, its fair value at the date of reclassification becomes its cost for subsequent accounting.

An investment property is derecognised upon disposal or when the investment property is permanently withdrawn from use and no future economic benefits are expected from the disposal. Any gain or loss arising on derecognition of the property (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in profit or loss in the period in which the property is derecognised.

3.17 Intangible assets

3.17.1 Intangible assets acquired separately

Intangible assets with finite useful lives that are acquired separately are carried at cost less accumulated amortisation and accumulated impairment losses. Amortisation is recognised on a straight-line basis over their estimated useful lives. The estimated useful life (five years - current and comparative years) and amortisation method are reviewed at the end of each reporting period, with the effect of any changes in estimate being accounted for on a prospective basis.

Intangible assets with indefinite useful lives that are acquired separately are carried at cost less accumulated impairment losses.

3.17.2 Internally-generated intangible assets – research and development expenditure

Expenditure on research activities is recognised as an expense in the period in which it is incurred.

An internally-generated intangible asset arising from development (or from the development phase of an internal project) is recognised if, and only if, all of the following have been demonstrated:

- the technical feasibility of completing the intangible asset so that it will be available for use or sale;
- the intention to complete the intangible asset and use or sell it;
- the ability to use or sell the intangible asset;
- how the intangible asset will generate probable future economic benefits;
- the availability of adequate technical, financial and other resources to complete the development and to use or sell the intangible asset; and
- The ability to measure reliably the expenditure attributable to the intangible asset during its development.

The amount initially recognised for internally-generated intangible assets is the sum of the expenditure incurred from the date when the intangible asset first meets the recognition criteria listed above. Where no internally- generated intangible asset can be recognised, development expenditure is recognised in profit or loss in the period in which it is incurred.

Subsequent to initial recognition, internally-generated intangible assets are reported at cost less accumulated amortisation and accumulated impairment losses, on the same basis as intangible assets that are acquired separately.

3.17 Intangible assets (Continued)

3.17.3 Intangible assets acquired in a business combination

Intangible assets acquired in a business combination and recognised separately from goodwill are initially recognised at their fair value at the acquisition date (which is regarded as their cost).

Subsequent to initial recognition, intangible assets acquired in a business combination are reported at cost less accumulated amortisation and accumulated impairment losses, on the same basis as intangible assets that are acquired separately.

3.17.4 Subsequent expenditure

Subsequent expenditure on capitalised intangible assets is capitalised only when it increases the future economic benefits embodied in the specific asset to which it relates. All other expenditure is expensed as incurred

3.17.5 De-recognition of intangible assets

An intangible asset is derecognised on disposal, or when no future economic benefits are expected from use or disposal. Gains or losses arising from derecognition of an intangible asset, measured as the difference between the net disposal proceeds and the carrying amount of the asset, and are recognised in profit or loss when the asset is derecognised.

3.18 Impairment of tangible and intangible assets other than goodwill and financial assets

At the end of each reporting period, the Group reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss(if any). When it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs. When a reasonable and consistent basis of allocation can be identified, corporate assets are also allocated to individual cash-generating units, or otherwise they are allocated to the smallest group of cash-generating units for which a reasonable and consistent allocation basis can be identified.

Intangible assets with indefinite useful lives and intangible assets not yet available for use are tested for impairment at least annually, and whenever there is an indication that the asset may be impaired.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or cash-generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or cash-generating unit) is reduced to its recoverable amount. An impairment loss is recognised immediately in profit or loss, unless the relevant asset is carried at a revalued amount, in which case the impairment loss is treated as a revaluation decrease.

When an impairment loss subsequently reverses, the carrying amount of the asset (or a cash-generating unit) is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset (or cash-generating unit) in prior years. A reversal of an impairment loss is recognised immediately in profit or loss, unless the relevant asset is carried at a revalued amount, in which case the reversal of the impairment loss is treated as a revaluation increase.

3.19 Biological assets

Biological assets are measured at fair value less costs to sell, with any gain or loss recognised in profit or loss. Costs to sell include all costs that would be necessary to sell the assets including transportation costs.

The fair value of fish held for sale is based on the market price of fish of similar age, breed and genetic merit.

3.20 Inventories

Inventories are measured at the lower of cost and net realisable value. The cost of inventories is based on the first-in-first out principle, and includes expenditure incurred in acquiring the inventories and bringing them to their existing location and condition. In the case of manufactured inventories and work in progress, cost includes an appropriate share of production overheads based on normal operating capacity. Net realisable value is the estimated selling price in the ordinary course of business, less the estimated costs of completion and selling expenses.

The cost of items transferred from biological assets is their fair value less costs to sell at the date of transfer.

3.21 Provisions

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, it is probable that the Group will be required to settle the obligation, and a reliable estimate can be made of the amount of the obligation.

The amount recognised as a provision is the best estimate of the consideration required to settle the present obligation at the end of the reporting period, taking into account the risks and uncertainties surrounding the obligation. When a provision is measured using the cash flows estimated to settle the present obligation, its carrying amount is the present value of those cash flows (when the effect of the time value of money is material).

When some or all of the economic benefits required to settle a provision are expected to be recovered from a third party, a receivable is recognised as an asset if it is virtually certain that reimbursement will be received and the amount of the receivable can be measured reliably.

3.21.1 Onerous contracts

Present obligations arising under onerous contracts are recognised and measured as provisions. The provision is measured at the present value of the lower of the expected cost of terminating the contract and the expected net cost of continuing with the contract. Before a provision is established, the Group recognises any impairment loss on the assets associated with the contract.

An onerous contract is considered to exist where the Group has a contract under which the unavoidable costs of meeting the obligations under the contract exceed the economic benefits expected to be received from the contract

3.21.2 Restructuring

A restructuring provision is recognised when the Group has developed a detailed formal plan for the restructuring and has raised a valid expectation in those affected that it will carry out the restructuring by starting to implement the plan or announcing its main features to those affected by it. The measurement of a restructuring provision includes only the direct expenditures arising from the restructuring, which are those amounts that are both necessarily entailed by the restructuring and not associated with the ongoing activities of the entity. Future operating losses are not provided for.

3.21.3 Contingent liabilities acquired in a business combination

Contingent liabilities acquired in a business combination are initially measured at fair value at the acquisition date. At the end of subsequent reporting periods, such contingent liabilities are measured at the higher of the amount would be recognised in accordance with IAS 37 and the amount initially recognised less cumulative amortisation recognised in accordance with IAS 18 Revenue.

3.22 Discontinued operations

A discontinued operation is a component of the Group's business, the operations and cash flows of which can be clearly distinguished from the rest of the Group and which:

- represents a separate major line of business or geographical area of operations;
- is a part of a single co-ordinated plan to dispose of a separate major line of business or geographic area
 of operations; or
- Is a subsidiary acquired exclusively with a view to resale.

Classification as a discontinued operation occurs at the earlier of disposal or when the operation meets the criteria to be classified as held for sale.

3.22 Discontinued operations (Continued)

When an operation is classified as a discontinued operation, the comparative statement of comprehensive income is represented as if the operations had been discontinued from the start of the comparative year.

3.23 Share capital and dividends

i) Ordinary shares

> Incremental costs directly attributable to the issue of ordinary shares are recognised as a deduction from equity. Income tax relating to transaction costs of an equity transaction is accounted for in accordance with IAS 12 - Income taxes.

ii) Dividends on ordinary shares

> Dividends on ordinary shares are recognised in equity in the period in which they are approved by the directors.

iii) Dividend per share

> The calculation of dividend per share is based on the ordinary dividends recognised during the period divided by the number of ordinary shareholders on the register of shareholders on the date of payment.

iv) Earnings per share

> The calculation of basic earnings per share is based on the profit or loss attributable to ordinary shareholders for the year and the weighted average number of shares in issue throughout the year. Diluted earnings per share is determined by adjusting the profit or loss attributable to ordinary shareholders and the weighted average number of ordinary shares outstanding for the effects of all dilutive potential ordinary shares, which comprise convertible notes and share options granted to employees. Where new equity shares have been issued by way of capitalisation or subdivision, the profit is apportioned over the shares in issue after the capitalisation or subdivision and the corresponding figures for all earlier periods are adjusted accordingly.

Equity instruments V)

Equity instruments issued by the Group are recorded at the proceeds received, net of direct issue costs.

3.24 Financial instruments

Financial assets and financial liabilities are recognised when a group entity becomes a party to the contractual provisions of the instruments.

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit or loss) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at fair value through profit or loss are recognised immediately in profit or loss.

3.25 Financial assets

Financial assets are classified into the following specified categories: financial assets 'at fair value through profit or loss' (FVTPL), 'held-to-maturity' investments, 'available-for-sale' (AFS) financial assets and 'loans and receivables'. The classification depends on the nature and purpose of the financial assets and is determined at the time of initial recognition. All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the marketplace.

3.25.1 Financial assets at FVTPL

Financial assets are classified as at FVTPL when the financial asset is (i) contingent consideration that may be paid by an acquirer as part of a business combination to which IFRS 3 applies, (ii) held for trading, or (iii) it is designated as at FVTPL.

3.25 Financial assets (Continued)

3.25.1 Financial assets at FVTPL (Continued)

A financial asset is classified as held for trading if:

- · it has been acquired principally for the purpose of selling it in the near term; or
- on initial recognition it is part of a portfolio of identified financial instruments that the Group manages together and has a recent actual pattern of short-term profit-taking; or
- It is a derivative that is not designated and effective as a hedging instrument.

A financial asset other than a financial asset held for trading or contingent consideration that may be paid by an acquirer as part of a business combination may be designated as at FVTPL upon initial recognition if:

- such designation eliminates or significantly reduces a measurement or recognition inconsistency that would otherwise arise; or
- the financial asset forms part of a group of financial assets or financial liabilities or both, which is
 managed and its performance is evaluated on a fair value basis, in accordance with the Group's
 documented risk management or investment strategy, and information about the grouping is provided
 internally on that basis; or
- It forms part of a contract containing one or more embedded derivatives, and IAS 39 permits the entire combined contract to be designated as at FVTPL.

Financial assets at FVTPL are stated at fair value, with any gains or losses arising on re-measurement recognised in profit or loss. The net gain or loss recognised in profit or loss incorporates any dividend or interest earned on the financial asset and is included in the 'other gains and losses' line item. Fair value is determined in the manner described in note 6.7.

3.25.2 Held-to-maturity investments

Held-to-maturity investments are non-derivative financial assets with fixed or determinable payments and fixed maturity dates that the Group has the positive intent and ability to hold to maturity. Subsequent to initial recognition, held-to-maturity investments are measured at amortised cost using the effective interest method less any impairment.

3.25.3 Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. Loans and receivables (including trade and other receivables, bank balances and cash, and loans and advances) are measured at amortised cost using the effective interest method, less any impairment.

Interest income is recognised by applying the effective interest rate, except for short-term receivables when the effect of discounting is immaterial.

3.25.4 Available-for-sale financial assets (AFS financial assets)

AFS financial assets are non-derivatives that are either designated as AFS or are not classified as (a) loans and receivables, (b) held-to-maturity investments or (c) financial assets at fair value through profit or loss.

Listed redeemable notes held by the Group that are traded in an active market are classified as AFS and are stated at fair value at the end of each reporting period. The Group also has investments in unlisted shares that are not traded in an active market but that are also classified as AFS financial assets and stated at fair value at the end of each reporting period in separate financial statements (because the directors consider that fair value can be reliably measured). Fair value is determined in the manner described in note 6.7. Changes in the carrying amount of AFS monetary financial assets relating to changes in foreign currency rates (see below), interest income calculated using the effective interest methodand dividends on AFS equity investments are recognised in profit or loss. Other changes in the carrying amount of available-forsale financial assets are recognised in other comprehensive income and accumulated under theheading of investments revaluation reserve. When the investment is disposed of or is determined to be impaired, the cumulative gain or loss previously accumulated in the investments revaluation reserve is reclassified to profit or loss.

3.25 Financial assets (Continued)

3.25.4 Available-for-sale financial assets (AFS financial assets) (Continued)

Dividends on AFS equity instruments are recognised in profit or loss when the Group's right to receive the dividends is established.

The fair value of AFS monetary financial assets denominated in a foreign currency is determined in that foreign currency and translated at the spot rate prevailing at the end of the reporting period. The foreign exchange gains and losses that are recognised in profit or loss are determined based on the amortised cost of the monetary asset. Other foreign exchange gains and losses are recognised in other comprehensive income.

AFS equity investments that do not have a quoted market price in an active market and whose fair value cannot be reliably measured and derivatives that are linked to and must be settled by delivery of such unquoted equity investments are measured at cost less any identified impairment losses at the end of each reporting period.

3.25.5 Impairment of financial assets

Financial assets, other than those at FVTPL, are assessed for indicators of impairment at the end of each reporting period. Financial assets are considered to be impaired when there is objective evidence that, as a result of one or more events that occurred after the initial recognition of the financial asset, the estimated future cash flows of the investment have been affected.

For AFS equity investments, a significant or prolonged decline in the fair value of the security below its cost is considered to be objective evidence of impairment.

For loans and advances, the Group assess individually significant loans whether objective evidence of impairment exists for these loans. If there is objective evidence that an impairment loss has been incurred, the amount of loss is calculated as the difference between the loans' carrying amount and the present value of estimated future cash flows. If the Group determines that no objective evidence of impairment exist for individually significant loans, it includes the loan in a group of loans with similar credit characteristics and collectively assess them for impairment.

In the assessment of individual loans, if a borrower's account has remained unpaid for over three months after attaining sub-standard status and on which collection or repayment in full is highly improbable, provisioning is warranted depending on the estimated recoverable amount of the pledged collateral if any.

An account attains a sub-standard status when it has recorded two cumulative monthly instalments arrears or for those payable quarterly, biannually or yearly, an instalment has been missed.

In determining the collective loss, the Group makes collective evaluation of impairment by using estimated default rates based on historical loss experience of each group of financial asset.

For certain categories of financial assets, such as trade receivables, assets are assessed for impairment on a collective basis even if they were assessed not to be impaired individually. Objective evidence of impairment for a portfolio of receivables could include the Group's past experience of collecting payments, an increase in the number of delayed payments in the portfolio past the average credit period of 60 days, as well as observable changes in national or local economic conditions that correlate with default on receivables.

For all other financial assets, objective evidence of impairment could include:

- significant financial difficulty of the issuer or counterparty; or
- breach of contract, such as a default or delinquency in interest or principal payments; or
- it becoming probable that the borrower will enter bankruptcy or financial re-organisation; or
- The disappearance of an active market for that financial asset because of financial difficulties.

3.25 Financial assets (Continued)

3.25.5 Impairment of financial assets (Continued)

- Observable data indicating that there is a measurable decrease in the estimated future cash flows from a group of financial assets since the initial recognition of those assets, although the decrease cannot yet be identified with the individual financial assets in the group, including:
 - adverse changes in the payment status of borrowers in the group; and
 - National or local economic conditions that correlate with defaults on the assets in the group.

For financial assets carried at amortised cost, the amount of the impairment loss recognised is the difference between the asset's carrying amount and the present value of estimated future cash flows, discounted at the financial asset's original effective interest rate.

For financial assets that are carried at cost, the amount of the impairment loss is measured as the difference between the asset's carrying amount and the present value of the estimated future cash flows discounted at the current market rate of return for a similar financial asset. Such impairment loss will not be reversed in subsequent periods.

The carrying amount of the financial asset is reduced by the impairment loss directly for all financial assets withthe exception of trade receivables, where the carrying amount is reduced through the use of an allowance account. When a trade receivable is considered uncollectible, it is written off against the allowance account. Subsequent recoveries of amounts previously written off are credited against the allowance account. Changes in the carrying amount of the allowance account are recognised in profit or loss.

When an AFS financial asset is considered to be impaired, cumulative gains or losses previously recognised in other comprehensive income are reclassified to profit or loss in the period.

For financial assets measured at amortised cost, if, in a subsequent period, the amount of the impairment loss decreases and the decrease can be related objectively to an event occurring after the impairment was recognised, the previously recognised impairment loss is reversed through profit or loss to the extent that the carrying amount of the investment at the date the impairment is reversed does not exceed what the amortised cost would have been had the impairment not been recognised.

In respect of AFS equity securities, impairment losses previously recognised in profit or loss are not reversed through profit or loss. Any increase in fair value subsequent to an impairment loss is recognised in other comprehensive income and accumulated under the heading of investments revaluation reserve. In respect of AFS debt securities, impairment losses are subsequently reversed through profit or loss if an increase in the fair value of the investment can be objectively related to an event occurring after the recognition of the impairment loss.

3.25.6 De-recognition of financial assets

The Group derecognises a financial asset when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another party. If the Group neither transfers nor retains substantially all the risks and rewards of ownership and continues to control the transferred asset, the Group recognises its retained interest in the asset and an associated liability for amounts it may have to pay. If the Group retains substantially all the risks and rewards of ownership of a transferred financial asset, the Group continues to recognise the financial asset and also recognises a collateralised borrowing for the proceeds received.

On de-recognition of a financial asset in its entirety, the difference between the asset's carrying amount and the sum of the consideration received and receivable and the cumulative gain or loss that had been recognised in other comprehensive income and accumulated in equity is recognised in profit or loss.

On de-recognition of a financial asset other than in its entirety (e.g. when the Group retains an option to repurchase part of a transferred asset), the Group allocates the previous carrying amount of the financial asset between the part it continues to recognise under continuing involvement, and the part it no longer recognises on the basis of the relative fair values of those parts on the date of the transfer. The difference between the carrying amount allocated to the part that is no longer recognised and the sum of the constitution received for the part no longer recognised and any cumulative gain or loss allocated to it that had been recognised in other comprehensive income is recognised in profit or loss. A cumulative gain or loss that had been recognised in other comprehensive income is allocated between the part that continues to be recognised and the part that is no longer recognised on the basis of the relative fair values of those parts.

3.26 Financial liabilities

Debt and equity instruments issued by a group entity are classified as either financial liabilities or as equity in accordance with the substance of the contractual arrangements and the definitions of a financial liability and an equity instrument.

Financial liabilities are classified as either financial liabilities 'at FVTPL' or 'other financial liabilities'.

3.26.1 Financial liabilities at FVTPL

Financial liabilities are classified as at FVTPL when the financial liability is:

- contingent consideration that may be paid by an acquirer as part of a business combination to which IFRS 3 applies,
- (ii) held for trading, or
- (iii) It is designated as at FVTPL.

A financial liability is classified as held for trading if:

- it has been incurred principally for the purpose of repurchasing it in the near term; or
- on initial recognition it is part of a portfolio of identified financial instruments that the Group manages together and has a recent actual pattern of short-term profit-taking; or
- It is a derivative that is not designated and effective as a hedging instrument.

Financial liabilities at FVTPL are stated at fair value, with any gains or losses arising on re-measurement recognised in profit or loss. The net gain or loss recognised in profit or loss incorporates any interest paid on the financial liability and is included in the 'other gains and losses' line item. Fair value is determined in the manner described in note 6.7.

3.26.2 Other financial liabilities

Other financial liabilities (including borrowings and trade and other payables) are subsequently measured at amortised cost using the effective interest method.

The effective interest method is a method of calculating the amortised cost of a financial liability and of allocating interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash payments (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial liability, or (where appropriate) a shorter period, to the net carrying amount on initial recogni-

3.26.3 Financial guarantee contracts

A financial guarantee contract is a contract that requires the issuer to make specified payments to reimburse the holder for a loss it incurs because a specified debtor fails to make payments when due in accordance with the terms of a debt instrument. These contracts have several legal forms such as Letters of credit (LCs). Guarantees and performance bonds.

Letters of credit (LCs) relate to standby LCs issued on behalf of selected customers. By issuing these LCs, the Group entity is guaranteeing payment to the third party in the event that the customer defaults on their contractual obligations on the transaction. These are non-cash upfront LCs.

Guarantees and performance bonds represent acceptances, guarantees, indemnities and credits which will crystallise into an asset and a liability only in the event of default on the part of the relevant counterparty.

These financial guarantee contract are initially measured at fair value and subsequently at the higher of the amount initially recognised less amortisation or the amount determined in accordance with IAS 37 Provisions, Contingent Liabilities and Contingent Assets.

3.26.4 De-recognition of financial liabilities

The Group derecognises financial liabilities when, and only when, the Group's obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable is recognised in profit or loss.

3.27 Equity instruments

An equity instrument is any contract that evidences a residual interest in the assets of an entity after deducting all of its liabilities. Equity instruments issued by a group entity are recognised at the proceeds received, net of direct

Repurchase of the Company's own equity instruments is recognised and deducted directly in equity. No gain or loss is recognised in profit or loss on the purchase, sale, issue or cancellation of the Company's own equity instruments.

3.28 Derivative financial instruments

The Group enters into a variety of derivative financial instruments to manage its exposure to interest rate and foreign exchange rate risks.

Derivatives are initially recognised at fair value at the date the derivative contracts are entered into and are subsequently remeasured to their fair value at the end of each reporting period. The resulting gain or loss is recognised in profit or loss immediately unless the derivative is designated and effective as a hedging instrument, in which event the timing of the recognition in profit or loss depends on the nature of the hedge relationship.

Certain derivatives embedded in other financial instruments, such as the conversion option in a convertible bond, are treated as separate derivatives when their economic characteristics and risks are not closely related to those of the host contract and the host contract is not carried at fair value through profit or loss. These embedded derivatives are measured at fair value with changes in fair value recognised in the statement of comprehensive income

3.29 Offsetting financial instruments

Financial assets and liabilities are offset and the net amount reported in the statement of financial position when there is a legally enforceable right to offset the recognised amounts and there is an intention to settle on a net basis, or realise the assets and settle the liability simultaneously.

3.30 Fiduciary activities

The Group commonly acts as trustees and in other fiduciary capacities that result in the holding or placing of assets on behalf of individuals, trusts, retirement benefit plans and other institutions.

These assets and income arising thereon are excluded from these financial statements, as they are not assets of the Group.

3.31 Sale and repurchase agreements

Securities sold subject to repurchase agreements ('repos') are reclassified in the financial statements as pledged assets when the transferee has the right by contract or custom to sell or repledge the collateral; the counterparty liability is included in amounts due to other banks, deposits from banks, other deposits or deposits due to customers, as appropriate, Securities purchased under agreements to resell ('reverse repos') are recorded as loans and advances to other banks or customers, as appropriate. The difference between sale and repurchase price is treated as interest and accrued over the life of the agreements using the effective interest rate method. Securities lent to counterparties are also retained in the financial statements.

Critical accounting judgements and key sources of estimation uncertainty

In the application of the Group's accounting policies, which are described in note 3, the directors of the Company are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

4.1 Critical judgements in applying accounting policies

The following are the critical judgements, apart from those involving estimations (see note 4.2 below), that the directors have made in the process of applying the Group's accounting policies and that have the most significant effect on the amounts recognised in the consolidated financial statements.

Critical accounting judgements and key sources of estimation uncertainty (Continued)

Critical judgements in applying accounting policies (Continued)

4.1.1 Control over Telekom Networks Malawi (TNM)

The directors of the Company assessed whether or not the Group has control over TNM based on whether the Group has the practical ability to direct the relevant activities of TNM unilaterally. In making their judgement, the directors considered the Group's absolute size of holding in TNM of 41.31% (2016: 41.31%) and the relative size of and dispersion of the shareholdings owned by the other shareholders. After assessment, the directors concluded that the Group has a sufficiently dominant voting interest to direct the relevant activities of TNM Limited and therefore the Group has control over TNM.

4.1.2 Held-to-maturity financial assets

The Group follows the guidance of IAS 39 on classifying non-derivative financial assets with fixed or determinable payments and fixed maturity as held to maturity. This classification requires significant judgment. In making this judgment, the Group evaluates its intention and ability to hold such investments to maturity. If the Group fails to keep these investments to maturity other than for the specific circumstances- for example, selling an insignificant amount close to maturity- it will be required to reclassify the entire class as available for sale. Details of assets held for sale are set out in note 23.

4.1.3 Deferred taxation on investment properties

For the purposes of measuring deferred tax liabilities or deferred tax assets arising from investment properties that are measured using the fair value model, the directors have reviewed the Group's investment property portfolios and concluded that the Group's investment properties are not held under a business model whose objective is to consume substantially all of the economic benefits embodied in the investment properties over time, rather than through sale. Therefore, in determining the Group's deferred taxation on investment properties, the directors have determined that the presumption that the carrying amounts of investment properties measured using the fair value model are recovered entirely through sale is not rebutted. As a result, the Group has recognised any deferred taxes on changes in fair value of investment properties as the Group is subject to income taxes on the fair value changes of the investment properties on disposal.

4.1.4 Income taxes

Significant judgment is required in determining the provision for income taxes. There are many transactions and calculations for which the ultimate tax determination is uncertain. The Group recognizes liabilities for anticipated tax audit issues based on estimates of whether additional taxes will be due. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the current and deferred income tax assets and liabilities in the period in which such determination is made.

4.2 Key sources of estimation uncertainty

The following are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period that may have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

4.2.1 Fair value measurements and valuation processes

Some of the Group's assets and liabilities are measured at fair value for financial reporting purposes. In estimating the fair value of an asset or a liability, the Group uses market-observable data (level 1 inputs) to the extentit is available. Where Level 1 inputs are not available, the Group engages third party qualified valuers to perform the valuation. Management works closely with the qualified external valuers to establish the appropriate valuation techniques and inputs into the model.

Information about the valuation techniques and inputs used in determining the fair value of various assets and liabilities are disclosed in the notes specific to those assets or liabilities.

4.2.2 Impairment losses on financial assets

The Group reviews its financial assets to assess impairment at least on a quarterly basis. The impairment evaluation is done both individually and collectively.

Key assumptions used:

- Cash flows arising from collateral realisation crystallise at an average period of 12 months and arise at the end of the 12 months period. Where cash flows are doubtful, they are assumed to be nil.
- b) Where there is a borrowing agreement but no collateral in place, expected future cash flows are assumed to be nil
- Unsupported guarantees which are not backed by any tangible asset (by companies or individuals
 except bank guarantees) are assumed to result in nil cash flows; and
- d) No cash flows are assumed to arise where there is no repayment agreement i.e. in instances of unsanctioned borrowing for exampleexceeding authorised overdraft limits.

4.2.3 Residual values and useful lives of tangible assets

The estimated residual values and useful lives of property, plant and equipment are reviewed and adjusted, if appropriate, at each reporting date to reflect current thinking on their remaining lives in the light of technological change, prospective economic utilisation and physical conditions of the assets concerned as described in note 3.15.

4.2.4 Impairment of goodwill

In determining whether goodwill is impaired, the Group estimates the value in use of the cash-generating unit to which goodwill has been allocated. In calculating the value in use, the Group estimates the future cash flows expected to arise from the cash-generating unit and a suitable discount rate in order to calculate present value. Where the value in use is less than the carrying amount of the assets and liabilities of the cash-generating unit plus its goodwill, an impairment is recognised.

5. Capital management

The Group manages its capital to ensure that entities in the Group will be able to continue as going concerns while maximising the returns to stakeholders through optimisation of the debt and equity balance. The overall Group strategy remains unchanged from 2016.

The capital structure of the Group consists of equity of the Group (comprising issued capital, reserves, retained earnings and non-controlling interests as detailed in notes 27 and 28).

The banking business of the Group is subjected to the following capital requirements:

5.1 Regulatory capital

The Reserve Bank of Malawi sets and monitors capital requirements for the Group's banking business as a whole. Regulatory capital requirement is the minimum amount of capital required by the Reserve Bank of Malawi, which if not maintained will usually permit or require supervisory intervention.

In implementing current capital requirements, The Reserve Bank of Malawi requires the Group's banking business to maintain a prescribed ratio of total capital to total risk-weighted assets. The minimum capital ratios under the implemented Basel II are as follows:

- A core capital (Tier 1) of not less than 10% of total risk-weighted on statement of financial position assets
 plus risk-weighted off-statement of financial position items; and
- A total capital (Tier 2) of not less than 15% of its total risk-weighted on statement of financial position assets
 plus risk-weighted off-statement of financial position items.

The Group's banking business regulatory capital is analysed into two tiers as follows:

- Core capital (Tier 1) which consists of ordinary share capital, share premium, retained profits, 60% of after-tax profits in the current year (or less 100% of current year loss), less any unconsolidated investment in financial companies.
- Total capital (Tier 2), which consists of revaluation reserves and general provisions, when such general
 provisions have received prior approval of the Reserve Bank of Malawi plus tier 1 capital. Supplementary
 capital must not exceed core capital i.e. shall be limited to 100% of total core capital.

5. Capital management (Continued)

Regulatory capital (Continued) 5.1

Banking operations are categorised as either trading book or banking book and risk-weighted assets are determined according to specified requirements that seek to reflect the varying levels of risk attached to assets and off-statement of financial position exposures.

The Board of Directors are responsible for establishing and maintaining at all times an adequate level of capital. The Group's policy is to maintain a strong capital base so as to maintain investor, creditor and market confidence and to sustain future development of the business. The impact of the level of capital on shareholders' return is also recognised and the Group recognises the need to maintain a balance between the higher returns that might be possible with greater gearing and the advantages and security afforded by a lower gearing position.

The Group and individually regulated operations have complied with all externally imposed capital requirements throughout the period. The Group also complied with these requirements in prior years.

62 Financial risk management

The Group has exposure to the following risks from its transactions in financial instruments:

- Credit risk;
- Liquidity risk; and
- Market risk (Currency risk, interest rate risk and price risk);

This note presents information about the Group's exposure to each of the above risks, the Group's objectives, policies and processes for identification, measurement, monitoring and controlling risk, and the Group's management of capital.

6.3 Risk management framework

The Group's approach to risk management is based on a well-established governance process and relies both on individual responsibility and collective oversight, supported by comprehensive reporting. This approach balances stringent corporate oversight with independent risk management structures within the business units.

The Board of Directors has overall responsibility for the establishment and oversight of the Group's risk management framework. The Board approves the risk appetite and risk tolerance limits appropriate to the Group's strategy and requires that management maintains an appropriate system of internal controls to ensure that these risks are managed within the agreed parameters. The Board delegates risk related responsibilities to the Risk Committeewhich is responsible for developing and monitoring Group risk management policies.

The Risk Committee is responsible for monitoring compliance with the Group's risk management policies and procedures, and for reviewing the adequacy of the risk management framework in relation to the risks faced by the Group. The Risk Committee is assisted in these functions by the Group Risk Department which undertakes both regular and ad-hoc reviews of risk management controls, the results of which are reported back to the Risk Committee

At management level, there is Risk Department which provides a holistic oversight of the risks affecting the Group and the control measures that should be put in place to mitigate the risks and thereby reduce the potential losses.

The Group's risk management policies are established to identify and analyse the risks faced by the Group, to set appropriate risk limits and controls, and to monitor risks and adherence to limits. Risk management policies and systems are reviewed regularly to reflect changes in market conditions, products and services offered. The Group strives to maintain a disciplined and constructive control environment, in which all employees understand their roles and obligations.

Credit risk 64

Credit risk refers to the risk that a counterparty will default on its contractual obligations resulting in financial loss to the Group. Group's credit risk arises principally from the Group's receivables from customers, cash and cash equivalents, investment securities and loans and advances. The amounts presented in the statement of financial position are net of provisions for impairment. The specific provision represents allowances for estimated irrecoverable amounts when there is objective evidence that the asset is impaired.

6.4.1 Exposure of credit risk

The table below shows the maximum exposure to credit risk by class of financial instrument without taking into account any collateral or other credit enhancements. Financial instruments include financial instruments defined and recognized under IAS39 Financial instruments: recognition and measurement as well as other financial instruments not recognised. The maximum exposure is shown gross, before the effect of mitigation through the use of master netting and collateral agreements.

In respect of certain financial assets, the Group has legally enforceable rights to offset them with financial liabilities. However, in normal circumstances, there would be no intention of settling net, or of realising the financial assets and settling the financial liabilities simultaneously. Consequently, the financial assets are not offset against the respective financial liabilities for financial reporting purposes. As at the end of the year, the Group had financial liabilities in the form of cash deposits amounting to K8,150 million (2016: K3,314 million) held as security for some loans and advances which in the event of default will be offset against such loans and advances.

6.4.2 Trade and other receivables

The Group's exposure to credit risk is influenced mainly by the individual characteristics of each customer. However, geographically there is no concentration of credit risk.

The Group has established a credit policy under which each new customer is analysed individually for creditworthiness before the Group's standard payment and delivery terms and conditions are offered. The Group's review includes external ratings, if they are available, financial statements and in some cases bank references. Sales limits are established for each customer, which represents the maximum open amount without requiring approval from the credit control department; these limits are reviewed regularly. Customers that fail to meet the Group's benchmark creditworthiness may transact with the Group only on a prepayment or cash basis.

Most of the Group's customers have been transacting with the Group for many years, and losses have occurred infrequently. In monitoring customer credit risk, customers are grouped according to their credit characteristics, including whether they are an individual or legal entity, whether they are a wholesale, retail or end-user customer, industry, aging profile, maturity and existence of previous financial difficulties.

The average credit period on sales of goods and services is 30 days except for international incoming receivables whose credit period is 60 days. No interest is charged on the trade and other receivables settled beyond these periods. The Group has provided fully for all receivables over 120 days, except those deemed recoverable based on past payments pattern or settlement agreements in place. Trade and other receivables between 30 days and 120 days are provided for based on the estimated recoverable amounts determined by reference to past default experience and prevailing economic conditions.

The Group does not require collateral in respect of credit sales.

6.4.3 Cash and cash equivalents

The Group held cash and cash equivalents comprising of cash and bank balances net of bank overdrafts amounting to K72,358 million as at 31 December 2017(2016: K50,331 million). The cash and cash equivalents are held with bank and financial institution counterparties which have high credit ratings.

The Group's banking business deposits its cash with the Reserve Bank of Malawi and other highly reputable banks in and outside Malawi.

6.4.4 Investments

The Group limits its exposure to credit risk by only investing in liquid securities and only with counterparties that have a good credit rating and ventures into profitable businesses. Given these high credit ratings and a track record of profitable business management, the Group does not expect any counterparty to fail to meet its obligations.

6.4.5 Loans and advances

Loans and advances are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market and that the Group's banking business does not intend to sell immediately or in the near term.

When the Group's banking business is the lessor in a lease agreement that transfers substantially all of the risks and rewards incidental to ownership of an asset to the lessee, the arrangement is presented within loans and advances.

When the Group's banking business purchases a financial asset and simultaneously enters into an agreement to resell the asset (or a substantially similar asset) at a fixed price on a future date ("reverse repo"), the arrangement is accounted for as a loan or advance, and the underlying asset is not recognised in the Group's financial statements.

Impaired loans and advances

Impaired loans and advances are loans and advances for which the Group determines that it is probable that it will be unable to collect all principal and interest due according to the contractual terms of the loan / advances agreement(s). These loans are graded 9 in the Group's internal credit risk grading system.

Past due but not impaired loans

These are loans and advances where contractual interest or principal payments are past due but the Group believes that impairment is not appropriate on the basis of the level of security/collateral available and/or the stage of collection of amounts owed to the Group. These are graded 7 and 8 in the Group's internal credit risk grading system.

Neither past due nor impaired loans

These are performing loans that have no indication of impairment and the Group expects to fully recover the estimated future cash flows. These are graded 1 to 6 in the Group's internal credit risk grading system.

In ensuring this, the Group puts in place the following credit quality measures;

- For corporate and business accounts with overdraft facilities, the Group ensures that it receives customer initiated deposits at least once every fortnight that will swing the account into a credit balance or at least decrease in exposure to below 50% of the marked limit at least once a month. For personal accounts, there should be such a deposit or salary at least once a month.
- (iii) For unauthorised overdrawn accounts with no limit or in excess of marked limits the Group ensures that the situation is regularised within a month (30 days).
- For loans, repayable monthly, quarterly, biannually or yearly, the Group expect the amount due to be (iv) settled on the agreed date and that any arrears are cleared before the expiry of 30 days.
- (v) Where the exposure emanates from seasonal facilities, full repayment is expected to be made 1 month (30 days) after end of the selling period or expiry date just as is the case where bullet or balloon arrangements are in place.

Allowance for impairment

The Group establishes an allowance for impairment losses that represents its estimate of incurred losses in its loan portfolio. The components of this allowance are a specific loss component that relates to individual significant exposures and collective allowance based on sector performance.

Write-off policy

The Group writes off a loan balance (and any related allowances for impairment losses) when it is determined that the loans are uncollectible. This determination is reached after considering information such as the occurrence of significant changes in the borrower/issuer's financial position such that the borrower/issuer can no longer pay the obligation, or that proceeds from collateral will not be sufficient to pay back the entire exposure.

Collateral held as security against loans and advances

The Group holds collateral against loans and advances to customers in the form of mortgage interests over property, cash, equities, registered securities over assets, guarantees and other forms of collateral. Estimates of fair value are based on the value of collateral assessed at the time of borrowing, and generally are only updated when performing the annual review except when a loan is individually assessed as impaired. Collateral generally is not held over loans and advances to banks, except when securities are held as part of reverse repurchase and securities lending activity.

Collateral repossessed

It is the Group's policy to dispose of repossessed collateral in an orderly fashion. The proceeds are used to reduce or repay the outstanding loan balance. In general the Group does not occupy repossessed properties for its business.

6.5 Liquidity risk

Liquidity risk is the risk that the Group will encounter difficulty in meeting the obligations associated with its financial liabilities that are settled by delivering cash or another financial asset.

6.5.1 Management of liquidity risk

The Group's approach to managing liquidity is to ensure, as far as possible, that it will always have sufficient liquidity to meet its liabilities when they are due, under both normal and stressed conditions, without incurring unacceptable losses or risking damage to the Group's reputation.

Ultimate responsibility for liquidity risk management rests with the board of directors which has built an appropriate liquidity risk management framework for the management of the Group's short, medium and long-term funding and liquidity requirements. The responsibility for the day to day management of these risks lies with management.

The Group manages liquidity risk by maintaining adequate reserves and banking facilities, by continuously monitoring forecast and actual cash flows, by matching the maturity profiles of financial assets and liabilities.

The Group's banking business has a Liquidity and Funds Management Policy that provides guidance in the management of liquidity.

The daily management of liquidity of the Group's banking business is entrusted with the Treasury and Financial Institutions Division (TFID). TFID receives information from other business units regarding the liquidity profile of their financial assets and liabilities and details of other projected cash flows arising from projected future business. TFID then maintains a portfolio of short-term liquid assets, largely made up of short-term liquid investment securities, loans and advances to banks and other inter-bank facilities, to ensure that sufficient liquidity is maintained within the Group's banking business. The liquidity requirements of business units are funded through deposits from customers. Any short-term fluctuations are funded through treasury activities such as inter-bank facilities, repurchase agreements and others.TFID monitors compliance of all operating units of the Group's banking business with local regulatory limits on a daily basis.

The daily liquidity position is monitored and regular liquidity stress testing is conducted under a variety of scenarios covering both normal and more severe market conditions. All liquidity policies and procedures are subject to review and approval by Asset and Liability Committee (ALCO). Daily reports cover the liquidity position of both the Group and operating units. A summary report, including any exceptions and remedial action taken, is submitted regularly to ALCO.

6.5.2 Measurement of liquidity risk – Group's banking business

The key measure used by the Group's banking business for managing liquidity risk is the ratio of net liquid assets to deposits from customers. For this purpose net liquid assets are considered as including cash and cash equivalents and investment securities for which there is an active and liquid market less any deposits from banks, other borrowings and commitments maturing within the next month. A similar, but not identical, calculation is used to measure the Group's banking business compliance with the liquidity limit established by the Reserve Bank of Malawi. Details of the reported Group's banking business ratio of net liquid assets to deposits from customers at the year-end date and during the reporting period were as follows:

6.6 Market risk

Market risk is the risk that changes in market prices, such as foreign exchange rates, interest rates and equity and commodity prices will affect the Group's income or the value of holding financial instruments. The objective of market risk management is to manage and control market risk exposures within acceptable parameters, while optimising the return on risk.

The Group monitors this risk on a continuing basis. There has been no change to the Group's exposure to market risks or the manner in which these risks are managed and measured.

6.6.1 Currency risk

The Group undertakes transactions denominated in foreign currencies consequently, exposure to exchange rate fluctuations arise.

The Group is exposed to currency risk mainly on commercial transactions and borrowings that are denominated in a currency other than the functional currencies of Group entities, primarily U.S. Dollars (USD), Great British Pound (GBP), Euro and South African Rand (ZAR) and in foreign exchange deals in the financial services sector.

Management of currency risk

To manage foreign currency risk arising from future commercial transactions and recognized assets and liabilities, some of the Group's goods and services pricing is pegged to the United States dollar. Management monitors the exchange rate exposure on a daily basis.

The Group also mitigates currency risk by utilising borrowing facilities from local banks and minimizing foreign supplier credit.

In respect of other monetary assets and liabilities denominated in foreign currencies, the Group ensures that its net exposure is kept to an acceptable level by buying or selling foreign currencies at spot rates when necessary to address short-term imbalances.

The Group's investments in subsidiaries are not hedged as those currency positions are considered to be long-term in nature.

6.6.2 Interest rate risk

The Group is exposed to interest rate risk because entities in the Group borrow funds at floating interest rates.

Management of interest rate risk

The risk is managed by the Group by maintaining an appropriate mix betweenfixed and floating interest rates on borrowings.

The Group's banking business principal risk to which non-trading portfolio are exposed is the risk of loss from fluctuations in the future cash flows or fair values of financial instruments because of a change in market interest rates. Interest rate risk is managed principally through monitoring interest rate gaps and by having pre-approved limits for repricing bands. The Asset and Liability Committee is the monitoring body for compliance with these limits and is assisted by Treasury and Financial Institutions Division in its day-today monitoring activities.

Exposure to interest rate risk on financial assets and financial liabilities

7 **Operating segments**

An operating segment is a component of the Group that engages in business activities from which it may earn revenues and incur expenses, including revenues and expenses that relate to transactions with any of the Group's other components. All operating segments' operating results are reviewed regularly by the Group's Chief Executive Officer ("CEO") to make decisions about resources to be allocated to the segment and assess its performance, and for which discrete financial information is available.

Segment results that are reported to the CEO include items directly attributable to a segment as well as those that can be allocated on a reasonable basis. Unallocated items comprise mainly corporate assets (primarily the Company's headquarters), head office expenses, and income tax assets and liabilities.

Segment capital expenditure is the total cost incurred during the year to acquire property, plant and equipment, investment property and intangible assets other than goodwill.

7.1 **Basis for segmentation**

The Group has five reportable segments which are based on the type of business among its subsidiary, associated companies and joint ventures. These segments are: Financial Services, Telecommunication, Energy, Consumer Goods, and All Other Reportable Segments. The segments offer different products and services, and are managed separately because they require different technology and marketing strategies.

The following summary describes the operations in each of the Group's reportable segments:

7.3 Information about major customers

The Group revenues are earned from a range of customers, none of which constitute ten percent or more of the total Group's revenues.

7.4 Information about reportable segments

Information regarding the results of each reportable segment is set out below. Performance is measured based on segment profit after income tax, as included in the internal management reports that are reviewed by the Group's CEO. Segment profit is used to measure performance as management believes that such information is the most relevant in evaluating the results of certain segments relative to other entities that operate within these industries.

Inter-segment pricing is determined on an arm's length basis.

Segment results, assets and liabilities include items directly attributable to a segment as well as those that can be allocated on a reasonable basis. Unallocated items mainly comprise income earning assets and revenue, interest bearing loans, borrowings and expenses, and corporate assets and expenses.

Segment capital expenditure is the total cost incurred during the year to acquire segment assets that are expected to be used for more than one year.

8.2 Fair value measurement of the Group's land and buildings

The Group's land and buildings are stated at their revalued amounts, being the fair value at the date of revaluation, less any subsequent accumulated depreciation and subsequent impairment losses. The fair value measurements of the Group's land and buildings were performed by qualified valuers as detailed below. There has been no change in the valuation technique this year.

Land and buildings relating to Malawi Telecommunications Limited were revalued as at 31 December 2015 by Simeon D. Banda Bsc (Hons) MSIM MRICS Chartered Quantity Surveyor of SFS Property Consultants in association with Sam M. Nhlane (Hons) Lond, MSIM Registered Valuation Surveyor of SMN Property Professionals. Valuations were carried out on the basis of open market value. Directors consider that the carrying amounts are not materially different from the fair values as determined in the last valuation.

Land and buildings relating to the banking business were fair valued as at 31 December 2017 by Nickson S. C. Mwanyali BSc (Est. Out of the K3,195m (2016: K2,110m) gross revaluation surplus, K501m(2016: K404m) was credited to the statement of comprehensive income to reverse decreases in fair values previously charged to the statement of comprehensive income and the balance of K2,694m (2016: K1,706m) was credited to the revaluation reserve through the statement of other comprehensive income.

Revaluation of freehold land and buildings relating to the Foods Company Limited as at 31 December 2017 were performed by Samuel Nhlane BSc (Hons), MSIM, a Chartered Valuation Surveyor of SMN Property Professionals, Independent Registered Valuation Surveyor. Valuations were carried out based on the market comparable approach that reflects recent transaction prices for similar properties in similar geographical locations.

8.3 Impairment losses recognised in the year

In prior year, the Group impaired its CDMA 450 and WiMAX Networks for the mobile data and mobile voice cash generating units. The total amount impaired was K2.1 billion and was recognised in profit and loss.

The cash generating units were incurring losses and their technologies had come to the end of their lives with their support contracts ending. Chances of the cash generating units recovering from such losses were unlikely. Accordingly, management made a decision to de-commission the networks.

In the current year, the impairment assessment of its cash generating units in line with International Accounting Standard 36 *Impairment of Assets* did not result in any impairment.

8.4 Assets pledged as security

The Group's assets with a carrying amount of approximately K60 billion (2016: K48 billion) have been pledged to secure borrowings. The Group is not allowed to sell these assets to another entity without prior approval of the lenders. The carrying amount of the related borrowings amount to K24.8 billion (2016: K 20.1 billion) – see note 26 and 29 below.

The valuation of fish in the ponds and cages, fingerlings and brood stock is based on the selling value of the projected weight of fish to be harvested on maturity less any estimated costs to be incurred in growing the fish to table size and in selling and distributing the fish after harvest. The valuation takes into account mortality of the fish which is based on past experience and actual mortality experienced during the period to harvest.

In determining the fair value of the fish, the following procedures are used:

- The Group estimates the weight of the fish that is in cages or ponds through sampling. This estimate is used to determine the projected harvest, which takes into account a factor of mortality.
- The projected harvest is valued using average selling price based on fish categories.
- The cost to harvest is estimated and this includes cost of feed, both starter and grower and all direct costs to be incurred to produce the fish.
- The value of the fish is then the difference between the value of the projected harvest and the costs to be incurred to harvest.
- Fingerlings are valued at the current selling price of each fingerling achieved during the year.

9.3 Financial risk management strategies related to agricultural activities

The Group is exposed to the following risks relating to its fish breeding business:-

Regulatory and environmental risks

The Group is subject to laws and regulations relating to fish breeding and protection of the environment. The Group has established environmental policies and procedures aimed at compliance with environmental laws relating to effluent disposal, certification of hatchery activities and environmental impact assessments of new fish breeding projects.

Supply, demand and commodity risks

The Group is exposed to risks arising from fluctuations in the prices of fish and fish products which are based on general supply of fish in the country. The bigger the general supply of fish in the country the lower the fish prices. The Group manages this risk by aligning its harvest volumes with the market supply and demand. Management performs regular industry trend analyses for projected harvest volumes and pricing.

Climate, weather, diseases and other risks

The Group's fish stocks are exposed to the risk of damage from climatic changes (including annual upwelling of water, temperature variations including stratification of water and low dissolved oxygen levels), diseases, theft of brood stock and breeding fish and predation from birds, otters and others. The Group has extensive processes in place aimed at monitoring and mitigating those risks, including monitoring and prevention of diseases, theft and bird predation prevention, monitoring of water temperatures and dissolved oxygen.

Consumer goods segment

The goodwill associated with consumer goods segment arose when the company (Press Corporation plc) acquired 50% shareholding in Peoples Trading Centre Limited in 2012 from Metcash Investment Holdings Limited to become a wholly owned subsidiary.

The recoverable amount of this cash generating unit is determined based on a value in use calculation which uses cash flow projections based on financial budgets approved by the directors covering a five-year period, and a discount rate of 25% (2016: 23%) per annum. Cash flows beyond that five-year period have been extrapolated using a steady 10% (2016: 10%) per annum growth rate. This growth rate does not exceed the long-term average growth rate for the retail industry.

Inflation was expected to be around 10% (2016: 10%) in the long-term with long term real GDP of 6% (2016: 6%). The directors believe that any reasonably possible change in the key assumptions on which the recoverable amount is based would not cause the aggregate carrying amount to exceed the aggregate recoverable amount of the cash-generating unit. The recoverable amount of the Cash Generating Unit is calculated to be K4.0 billion (2016: K4.3 billion) and its carrying amount is K2.1 billion (2016: K2.3 billion) as such the related goodwill is not impaired.

TNM Business services unit

The goodwill associated with TNM Business services unit arose when the Group's subsidiary, Telekom Networks Malawi Limited acquired Burco Electronics Systems Limited in 2014.

The recoverable amount of this cash generating unit is determined based on a value in use calculation which uses cash flow projections based on financial budgets approved by the directors covering a five-year period, and a discount rate of 21% (2016: 33%) per annum.

The recoverable amount of the Cash Generating Unit is calculated to be K4.1 billion (2016: K2.7 billion) and its carrying amount is K0.9 billion (2016: K1 billion) as such the related goodwill is not impaired.

Whole Banking Division

The banking business of the Group, National Bank of Malawi acquired a 97.05% interest in Indebank Limited on 31 October 2015. In 2016, the Bank acquired an additional 2.95% in Indebank previously held by the Indebank employee share ownership program(ESOP)thus increasing its shareholding to 100%. This broughtthe purchase consideration to K6,616million and the goodwill arising on acquisition to K3,959 million.

The carrying amount of this goodwill was allocated to the Wholesale Banking Division (WBD) as a cash generating unit.

The recoverable amount of this cash generating unit is determined based on a value in use calculation which uses cash flow projections based on financial budgets approved by the Directors covering a five-year period, and discounted at a weighted average cost of capital of 19.32% (2016:33.37%). Cash flows beyond that five-year period have been extrapolated using an average of 21% per annum growth rate which is the projected long term average growth rate for Wholesale Banking Business. The Directors believe that any reasonably possible change in the key assumption on which the recoverable amount is based would not cause the aggregate carrying amount to exceed the aggregate recoverable amount of the cash generating unit.

The recoverable amount of the Cash Generating Unit (WBD) is calculated to be K363.6 billion(2016: K143 billion) and its carrying amount is K148.2 billion (2016: K135 billion) as suchthe related goodwill is not impaired.

Subsequent to year end, the subsidiary restructured the Malawi Government guaranteed loans to long term with a repayment period of 10 years effective 1st January 2019.

PTA bank loan was restructured in 2015 and agreed with the lender for the loan to be settled using proceeds to be realised from the sale of the Fibre Optic Cable business. The late settlement of the PTA loan is due to the delay in the finalisation of a deal for the sale of the Fibre Optic Cable business.

The adjustment resulted in an increase in administrative expenses by K617 million (bad debts provision) and a decrease in cash of K617 million. In addition, another adjustment was made in respect of misclassification between cost of sales and bank and cash. The adjustment resulted in an increase in cost of sales by K40 million and a decrease in cash of K40 million.

Trade and other payables

Prior year adjustment related to correction of understatement of prior year liabilities following a detailed analysis of the creditors ledger. The adjustment to trade and other payables resulted in an increase in other income by K90 million, cost of sales by K1,006 million and decrease in administrative expenses by K68 million and an increase in trade and other payables by K848 million.

49 1 Restatement impact on comparatives
