Fund Objective

To outperform (after deduction of costs) the MSCI Europe ex UK Index, as stated in sterling, by at least 1.5% per annum over rolling five-year periods.

The manager believes this is an appropriate target given the investment policy of the Fund and the approach taken by the manager when investing. In addition, the manager believes an appropriate performance comparison for this Fund is the Investment Association Europe Excluding UK Sector.



Investment Proposition

The Fund invests in high quality, well managed businesses that are able to grow significantly. We aim to buy shares in these companies cheaply, and expect to hold them for a long time. Companies in which we invest will typically have a strong competitive position and be managed by owner-oriented people.

Portfolio construction is team-based, with the overall weighting of stocks in the portfolio a function of the collective conviction of the Fund's managers. We believe this approach helps us to avoid some of the behavioural challenges of group decision-making.

We expect our annual portfolio turnover to be below 20% and for the Fund to hold between 30-50 stocks.

We have chosen to show Active Share against the MSCI Europe ex UK Index.

Turnover is calculated by taking the smaller figure of either total purchases or total sales for the month and dividing it by an average market value. The Annual Turnover is then calculated as the sum of the monthly turnover figures for the 12 month period.
