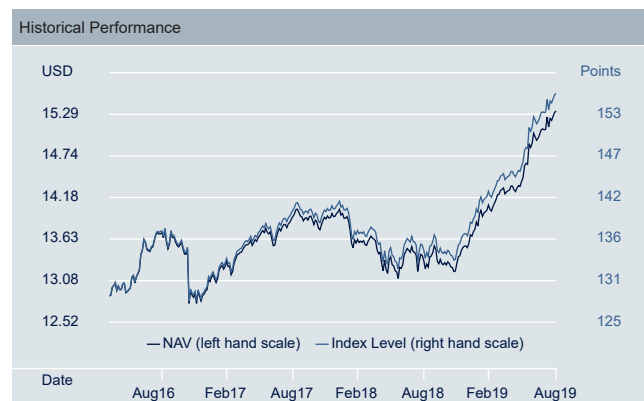

The Markit iBoxx USD Emerging Markets Sovereigns Quality Weighted Index aims to reflect the performance of the following market:

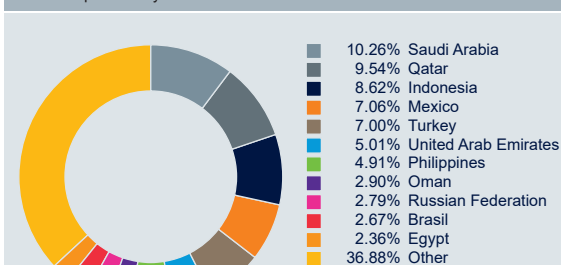
- USD-denominated bonds issued by governments of Emerging countries
- Exposure across the whole yield curve (minimum time to maturity of 1 year)
- Minimum bond rating of B-
- Minimum amount outstanding of USD 500 million per bond

This index offers an alternative weighting approach, countries with favourable fundamental economic indicators will have higher representation in the index compared to countries with weaker economic fundamental indicators (weights are re-evaluated every 6 months).

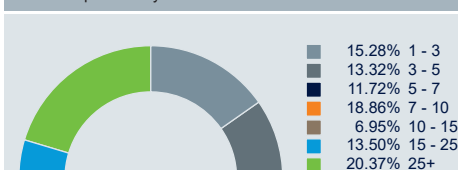

USD Emerging Markets Bond Quality Weighted UCITS ETF

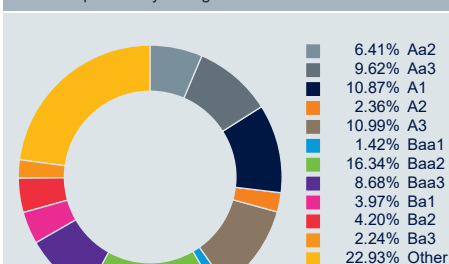
ETF Composition by Countries
