What is this product?

Objectives:

WisdomTree Short JPY Long GBP is designed to enable investors to gain exposure to Japanese Yen ("JPY") relative to Pounds Sterling ("GBP") by tracking the MSFX Short Japanese Yen/GBP Index (TR) (the "Index"), which aims to reflect the performance of a position in forward contracts which are rolled on a daily basis. The product provides a short exposure to JPY relative to GBP. For example, if JPY were to rise in value relative to GBP, the Index (tracked by the ETC) would decrease in value. Conversely if JPY were to decrease in value relative to GBP, the Index would increase in value. The Index return also includes a component based on the interest rate differentials, reflecting the difference between the JPY and the GBP exchange rates. The Index is a total return Index, which means that it also provides a collateral yield. The product is an exchange traded product ("ETP"). Securities in this ETP are structured as debt securities and not as shares (equity). They are traded on exchange just like shares in a company. The ETP is backed by swaps with Morgan Stanley & Co. International plc. The payment obligations of the Issuer are protected by collateral held in a segregated account at an independent custodian, The Bank of New York Mellon.

Intended retail investor:

The product is intended for basic retail investors who: (i) can bear loss of capital, are not seeking to preserve capital and who are not looking for capital guarantee; (ii) have specific knowledge or experience of investing in similar products and in financial markets; and (iii) seek a product offering an exposure to the performance of the underlying asset(s) and have an investment horizon in line with the recommended holding period stated below.
