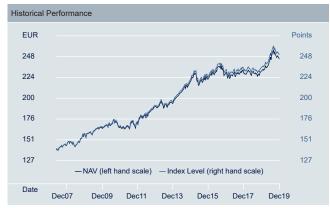

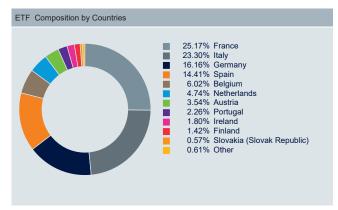
#### iBoxx® Euro Sovereigns Eurozone TR Index

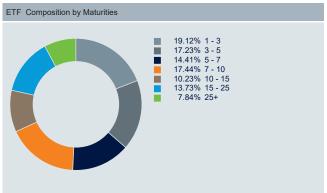

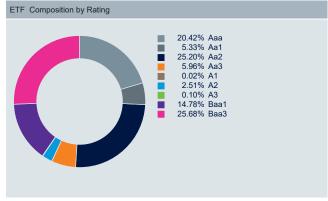
