Objectives and Investment Policy

Investment Objective

The objective of the Fund is to track the performance of the global infrastructure market represented by publicly traded infrastructure related equity and bonds.

Investment Policy

The Fund seeks to track the performance of the Morningstar Global Multi-Asset Infrastructure Index (the "Index") as closely as possible.

The Fund invests primarily in securities included in the Index. These securities include a broadly diversified portfolio of publically traded global equity and global fixed income securities within social and economic infrastructure related industries. As it may be difficult to purchase all securities in the Index efficiently, in seeking to track the performance of the Index, the Fund will use a sampling strategy, for the fixed income assets and an optimisation strategy, for the equity assets to build a representative portfolio. Consequently, the Fund will typically hold only a subset of the securities included in the Index. In limited circumstances the Fund may purchase securities that are not included in the Index.

The Fund may use financial derivative instruments (that is, financial contracts whose prices are dependent on one or more underlying assets) in order to manage the portfolio efficiently.

Save in exceptional circumstances, the Fund will generally only issue and redeem shares to certain institutional investors. However, shares of the Fund may be purchased or sold through brokers on one or more stock

Risk Disclaimer
