Fund investment objective and policy

The objective of the Fund is to achieve long-term (5 years plus) capital growth. The Fund invests at least 80% of its assets in shares of companies incorporated, domiciled or carrying out the main part of their economic activity in Asia and Australasia, excluding Japan. The Fund may use derivatives (complex instruments) to manage the Fund more efficiently, with the aim of reducing risk, reducing costs and/or generating additional capital or income.

Fund strategy

We seek to invest in companies whose share prices are substantially below our estimate of fair value. Our investment process leads us to focus on undervalued areas of the market, as this is where many undervalued companies can be found. The fund continues to have a number of key identifiable areas of exposure, including: Chinese consumer, South Korea and what we consider to be undervalued balance sheets.

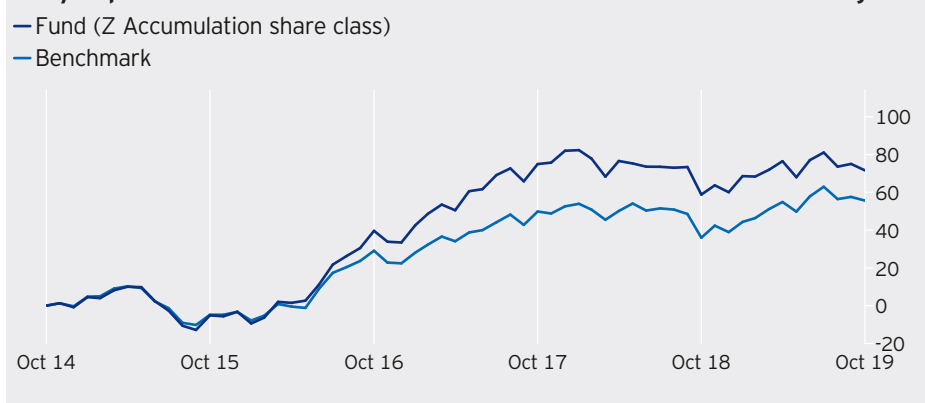
Benchmark

Investment risks
