#### Fund manager's report

- The European HY market continued to move higher, returning 1.5% over April. The year-to-date return is 6.7%, compared to 8.9% for the US high yield market (in local currency terms).
- April differentiated itself from the first quarter as lower rated parts of the market outperformed. BBs returned 1.2%, Bs
- Cyclical sectors also bounced and autos led the way by returning 2.8%, while basic industrials returned 1.7%.
- The primary market picked up in April, with 16 companies printing new issues.
- The International Monetary Fund revised its 2019 global growth forecast down and is now predicting 1.2% real GDP growth in the UK, 0.8% in Germany and 0.1% in Italy.
