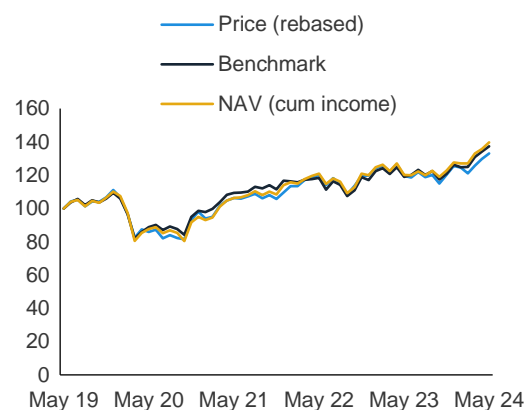
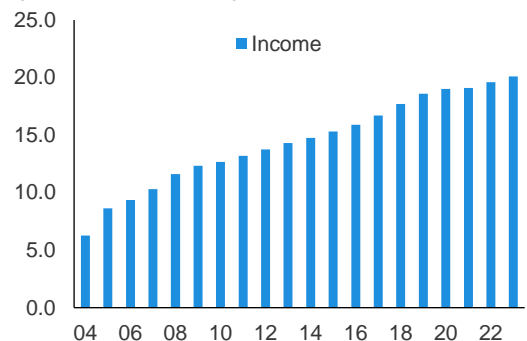


## Share price performance (total return)

## Commentary at a glance

### Performance

In the month under review the Company's NAV total return was 2.9% and the FTSE All-Share Index total return was 2.4%.

### Contributors/detractors (for the quarter)

The biggest positive relative contributor was the underweight position in Shell, which underperformed due to the weak oil price. The biggest detractor was not holding Experian.

### Outlook

We think the valuation of UK equities is compelling compared to their equivalents overseas, with the dividend yield particularly attractive relative to the main alternatives.

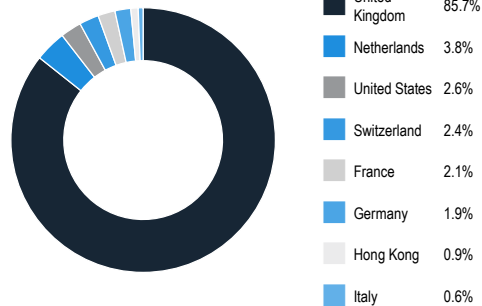

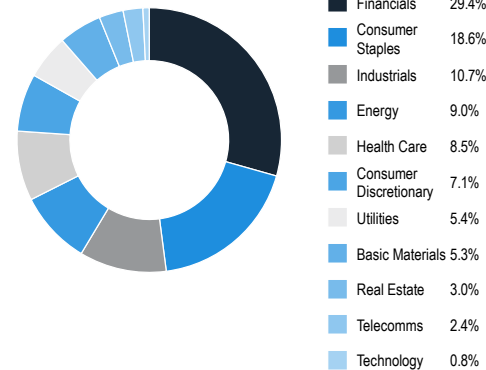

**Geographical focus (%)**



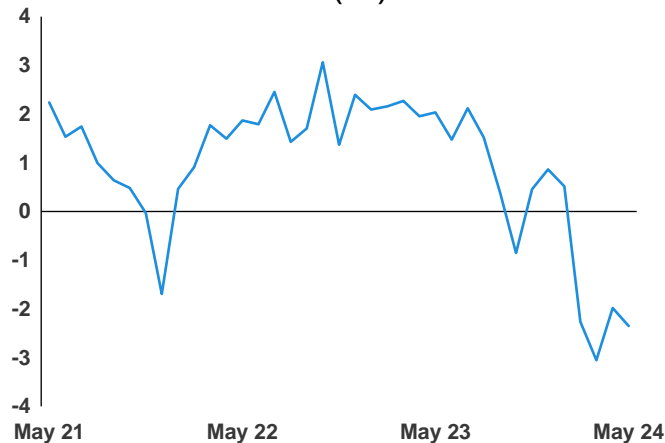

## Fund Manager commentary

### Investment environment

The FTSE All-Share Index rose 2.4% in May.

It was revealed that the UK economy grew by a stronger-than-expected 0.6% over the first quarter. Inflation fell to 2.3% in April, down from 3.2% in March.

The Bank of England (BoE) left interest rates unchanged at 5.25%. Meanwhile, Prime Minister Rishi Sunak called a 4 July general election.

In the US, data released during the month indicated a softening economy with non-farm payroll growth in April lower than forecast.

In Europe, minutes from the European Central Bank (ECB)'s April meeting (released in May) appeared to open the way for a cut in interest rates.

### Portfolio review

The biggest single positive contributor to relative performance was the underweight position in Shell, which underperformed due to the weak oil price. Munich Re was the second biggest positive contributor as the share price benefited from the continuing strong pricing of reinsurance rates.

The two biggest relative detractors were stocks not held in the portfolio which performed well. These were Experian, the credit and marketing services company, and Rolls Royce, the aircraft engine manufacturer.

Our most significant activity was to take some profits in Holcim, the building materials company, which has rerated ahead of a spin-off of its US operations, which will be listed on the New York Stock Exchange. We made an addition to British Land, the real estate investment trust that owns London offices and retail warehouses, as we like the improving valuation trends for its properties.

### Manager outlook

The opinion polls show Labour as overwhelming favourite to win the UK general election, and this should already be discounted in stock market expectations. The next move in interest rates is likely to be down, but the continuing high level of wage growth may lead to a cautious approach from the BoE.

Some two-thirds of revenues earned by companies that we invest in are from overseas, which provides useful diversification. However, there is considerable uncertainty for the global economy and elevated geopolitical tensions. Nonetheless, we think the valuation of UK equities is compelling compared to their equivalents overseas, possibly due to the low allocation from domestic, institutional investors. In particular, the dividend yield of UK equities is attractive relative to the main alternatives.

## Glossary

### Discount/Premium

The amount by which the price per share of an investment company is either lower (at a discount) or higher (at a premium) than the net asset value per share (cum income), expressed as a percentage of the net asset value per share.

### Gearing

The effect of borrowing money for investment purposes (financial gearing). The amount a company can “gear” is the amount it can borrow in order to invest. Gearing is used in the expectation that the returns on the investments bought will exceed the costs of the borrowings that funded the purchase. This Company can also use synthetic gearing through derivatives and foreign exchange hedging and/or other non-fully funded instruments or techniques.

### Leverage

The Company's leverage is the sum of financial gearing and synthetic gearing. Details of the Company's leverage limits can be found in both the Key Information Document and Annual Report. Where a company utilises leverage, the profits and losses incurred by the company can be greater than those of a company that does not use leverage.

### Market capitalisation

Share price multiplied by the number of shares in issue, excluding treasury shares, at month end. Shares typically priced mid-market at month-end closing.

### Net Asset Value (NAV)

The total value of a Company's assets less its liabilities.

### NAV (Cum Income)

The value of investments and cash, including current year revenue, less liabilities (prior charges such as loans, debenture stock and preference shares at fair value).

### NAV (Ex Income)

The value of investments and cash, excluding current year revenue, less liabilities (prior charges such as loans, debenture stock and preference shares at fair value).

### NAV total return

The theoretical total return on shareholders' funds per share reflecting the change in Net Asset Value (NAV) assuming that dividends paid to shareholders were reinvested at NAV at the time the shares were quoted ex-dividend. A way of measuring investment management performance of investment trusts which is not affected by movements in discounts/premiums.

### Net assets

Total assets minus any liabilities such as bank loans or creditors.

### Net cash

A company's net exposure to cash/cash equivalents expressed as a percentage of shareholders' funds, after any offset against its gearing. This is only shown for companies that have gearing in place.

### Net gearing

A company's total assets (less cash/cash equivalents) divided by shareholders' funds expressed as a percentage.

### Ongoing charges

The total expenses for the financial year (excluding performance fee), divided by the average daily net assets, multiplied by 100.

### Risk rating

The key measure used to assess risk is volatility of returns, using historic net asset value (NAV) performance of the Company over 1 and 3 years. In this instance volatility measures how much a company's NAV fluctuates over time in relation to the UK Equity market. The higher a volatility figure, the more the NAV has fluctuated (both up and down) over time. Please note that risk categorisations are indicative and based principally on historic data and should not be solely relied upon when making investment decisions.

### Share price

Closing mid-market share price at month end.

### Share price total return

The theoretical total return to the investor assuming that all dividends received were reinvested in the shares of the company at the time the shares were quoted ex-dividend. Transaction costs are not taken into account.

### Total assets

Cum Income NAV multiplied by the number of shares, plus prior charges at fair value.

### Yield

Calculated by dividing the current financial year's dividends per share (this will include prospective dividends) by the current price per share, then multiplying by 100 to arrive at a percentage figure.
