# **Objectives and Investment Policy**

# **Investment Objective**

The investment objective of the Fund is to track the performance of the short maturity (0-5 year) USD-issued emerging market government bond market.

# **Investment Policy**

The Fund seeks to track the performance of the ICE BofAML 0-5 Year EM USD Government Bond ex-144a Index (the "Index") as closely as possible.

The Fund is passively managed. This means State Street Global Advisors Limited (the "Investment Manager") is attempting to track the performance of the Index. The Fund invests primarily in securities included in the Index. These securities include U.S. dollar-denominated emerging markets government debt publicly issued in the U.S. domestic market and Eurobond Markets. Qualifying securities must be denominated in U.S. dollars, that have a remaining maturity of less than 5 years and a fixed coupon and at least US\$500 million in outstanding face value. As it may be difficult to purchase all securities in the Index efficiently, in seeking to track the performance of the Index, the Fund will use a stratified sampling strategy to build a representative portfolio. Consequently, the Fund will typically hold only a subset of the securities included in the Index. In limited circumstances the Fund may purchase securities that are not included in the Index.

The Fund may use financial derivative instruments (that is, financial contracts whose prices are dependent on one or more underlying assets) in order to manage the portfolio efficiently.

Save in exceptional circumstances, the Fund will generally only issue and redeem shares to certain institutional investors. However, shares of the

# **Risk Disclaimer**

The risk category above is not a measure of capital loss or gains but of how significant the rises and falls in the Fund's return have been historically.

# Why is this Fund in this category?

The Fund is in risk category 2 as its return has experienced relatively low rises and falls historically.

The following are material risks relevant to the Fund which are not adequately captured by the risk category.

**Concentration Risk:** When the Fund focuses its investments in a particular way, the issues affecting the investments will have a greater effect than if the Fund was more diversified. This concentration may also limit the Fund's liquidity.

Fund may be purchased or sold through brokers on one or more stock exchanges. The Fund trades on these stock exchanges at market prices which may fluctuate throughout the day. Market prices may be greater or less than the daily net asset value of the Fund.

The Fund does not currently engage in securities lending.

Shareholders may redeem shares on any UK business day (other than days on which relevant financial markets are closed for business and/or the day preceding any such day provided that a list of such closed market days will be published for the Fund on www.spdrs.com); and any other day at the Directors' discretion (acting reasonably) provided Shareholders are notified in advance of any such days.

Any income earned by the Fund will be paid to shareholders in respect of the shares.


