Summary Investment Objective

The objective of the Fund is to obtain a yield higher than that generally available from investment in global equities whilst, over the longer term, achieving growth in both capital and income.

Investment Process

Valu-Trac's investment approach is based on Intrinsic Value Yield which is an objective and globally consistent measure of the potential income return of a stock. Intrinsic Value Yields are compared and used in conjunction with Behaviour measurements (e.g. overbought/oversold and momentum) to help with timing and risk control.

Managers Comment

In April the Fund delivered a return of +0.92% (Net Acc share class) to its valuation point on April 30th. This performance resulted in a new month end high Price for the Fund. The MSCI Developed World Index rose +3.50% in Sterling terms with Net Dividends Reinvested.

There were several changes to the portfolio during April, resulting in a small, 1.5% increase of the exposure to the US.

During April there were complete disposals of three holdings. China Resources Power Holdings (Hong Kong) was sold as the dividend yield on offer had reduced to a relatively low level. There were also disposals of Marston's Plc (UK) and Marks & Spencer Plc (UK). The Intrinsic value Yield of both these UK stocks is no longer as attractive as it has been and there are potential concerns on the quality of the dividend. In addition Flowers Foods Inc. (USA) was reduced, in line with recent price strength which has lowered the Intrinsic Value on offer.

There were purchases of Keller Group Plc (UK) and Pennon Group Plc (UK) and an increase to the existing position held in Iron Mountain Inc. (USA). All of these were at an attractive level of Value with promising income prospects.




