

# iShares Dow Jones U.S. Energy Sector Index Fund

## Fund Description

The iShares Dow Jones U.S. Energy Sector Index Fund seeks investment results that correspond generally to the price and yield performance, before fees and expenses, of U.S. energy stocks, as represented by the Dow Jones U.S. Oil & Gas Index ("the Index").

## Index Description

The Index measures the performance of the energy sector of the U.S. equity market, including oil and gas producers and oil equipment, services and distribution. The Index is a subset of the Dow Jones U.S Index and is capitalization-weighted. Component companies are adjusted for available float and must meet objective criteria for inclusion to the Index. Reconstitution is quarterly.

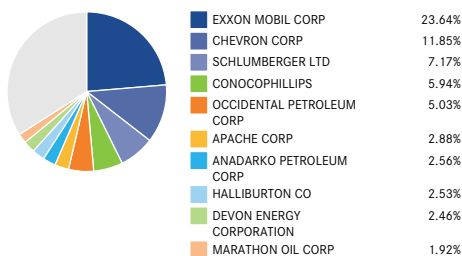

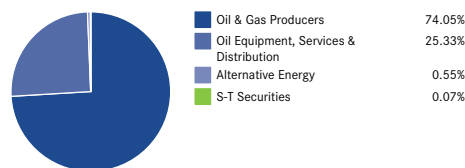
