# **Fund Objective**

To outperform (after deduction of costs) the MSCI AC Asia ex Japan Index, as stated in sterling, by at least 2% per annum over rolling five-year periods.



The Fund is relatively index and sector agnostic, as we primarily focus on finding the best long-term Asian investments irrespective of their country or sector.

The Fund benefits from Baillie Gifford's substantial global investment resources, helping to produce a portfolio that typically holds 50–100 stocks with low turnover.

We have chosen to show Active Share against the MSCI AC Asia ex Japan Index.

Turnover is calculated by taking the smaller figure of either total purchases or total sales for the month and dividing it by an average market value. The Annual Turnover is then calculated as the sum of the monthly turnover figures for the 12 month period.
