### What is this product?

#### Type:

The Company is a closed-ended investment company whose shares are listed on the premium segment of the Official List of the UK Listing Authority and traded on the main market of London Stock Exchange. The Company's ordinary shares are therefore available to the general public.

Shares of the Company are bought and sold via markets. Typically at any given time on any given day, the price you pay for a share will be higher than the price at which you could sell it.

#### Objectives:

To grow money invested in the company over the long-term by investing in a diversified portfolio of listed US smaller and medium-sized companies.

The Company takes a conservative approach to investment, with the investment adviser focusing on capital preservation rather than trying to chase growth aggressively. The approach emphasises taking a long term view of company

prospects as well as buying when shares appear lowly valued and have significant growth potential.

The Company has a flexible loan facility it can use for investment purposes (known as gearing) with a view to enhancing returns.

The Company is not restricted to investing in constituent companies of the Benchmark (Sterling Adjusted Russell 2000 Index).
