WisdomTree Brent Crude Oil 1yr is designed to enable investors to gain a total return exposure to movements in the price of ICE 1 year Brent crude oil futures contracts plus a collateral yield. The product reflects the performance of the underlying futures contracts such that, for example, if the futures contracts were to rise in value by 5% over a period, the product would increase in value by 5% over that same period (before fees, expenses and adjustments) and if the futures contracts were to fall in value by 5% over a period, the product would fall in value by 5% over that same period (before fees, expenses and adjustments). The product is an exchange traded product ("ETP"). Securities in this ETP are structured as debt securities and not as shares (equity). They are traded on exchange just like shares in a company. The ETP is backed by swaps with Shell Trading Switzerland AG, a member of the Royal Dutch Shell Group.
