### The Fund

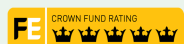

Typically between 45% and 85% will be invested in shares. Up to 55% will be invested in bonds and cash. 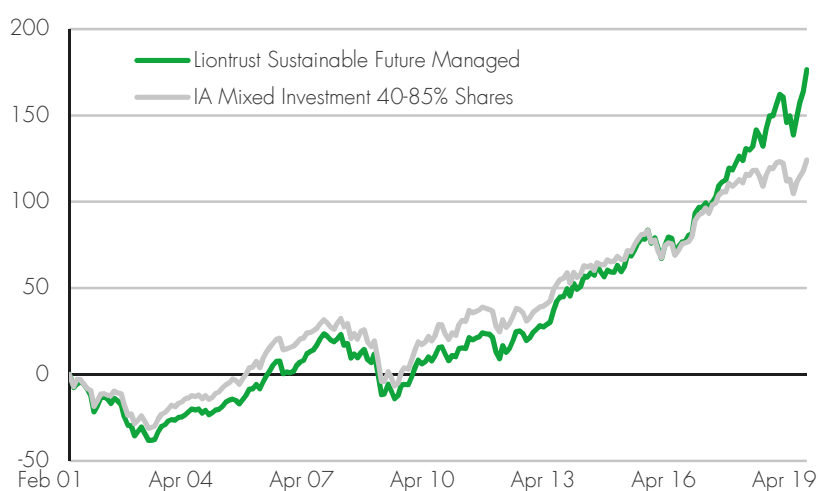
