1. FUND INFORMATION

Investment objective

The Lyxor FTSE Europe Minimum Variance (DR) UCITS ETF - Acc is a UCITS compliant exchange traded fund that aims to track the FTSE Developed Europe Minimum Variance Net Tax Index Index

The FTSE Developed Europe Minimum Variance Net Tax Index seeks to provide exposure to developed European large and mid caps with reduced risk. The strategy aims to achieve this by selecting stocks with low correlation with one another. Stock selection is subject to strict diversification rules to avoid excess concentration risk.

Risk Factors
