a share class of WisdomTree Global Quality Dividend Growth UCITS ETF (the "Fund") which is a sub-fund of WisdomTree Issuer plc. Managed by WisdomTree Management Limited.

Objectives and Investment Policy

- The Fund seeks to track the price and yield performance, before fees and expenses of the WisdomTree Global Developed Quality Dividend Growth Index (the "Index").
- The Index is a fundamentally weighted index and is comprised of dividend paying securities with growth and quality characteristics.
- The Index gauges growth and quality by weighting securities with long term estimated earnings growth, historical three-year average return on equity and historical three year average return on assets.
- To be included in the Index, securities must meet certain eligibility requirements such as: (1) incorporated and headquartered in the United States or incorporated in Europe, Israel, Japan, Australia, New Zealand, Hong Kong, Singapore or Canada, (2) meet the minimum market capitalisation, (3) have an average daily dollar trading volume of at least \$100,000 for three months preceding the Index screening date, and (4) have an earnings yield greater than the dividend yield.
- Securities are weighted annually in the Index to reflect the proportionate share of the aggregate cash dividends each component company paid over the prior annual cycle.
- The Index is "reconstituted" annually on the basis of the above eligibility and weighting methodology. At that time, securities are screened to determine whether they comply with WisdomTree Investment, Inc.'s proprietary Index methodology and are eligible to be included in the Index.
- In order to achieve its objective, the Fund will employ a "passive management" (or indexing) investment approach and will invest in a portfolio of equity securities that so far as possible and

practicable consists of a representative sample of the component securities of the Index.

- As it may be difficult, expensive or otherwise inefficient to purchase all the securities in the Index, the Fund may also hold shares or other securities which produce a similar investment return to securities in the Index or may invest in collective investment schemes.
- The Fund may enter into repurchase/reverse repurchase agreements and stock lending arrangements solely for the purposes of efficient portfolio management, subject to the conditions and within the limits set out in the prospectus for WisdomTree Issuer plc (the "Prospectus").
- Shares of the Fund ("Shares") are listed on one or more stock exchanges. Typically, only Authorised Participants (i.e. brokers) can purchase Shares from or sell Shares back to the Fund. Other investors can purchase and sell Shares on exchange on each day the relevant stock exchange is open.
- Distribution policy: Income received by the Fund's investments will normally be distributed Semi-annually in respect of the Shares of this class.
- Recommendation: This Fund may not be appropriate for shortterm investment.
- Currency: The base currency of the Fund is US Dollar. The currency of denomination of this share class is US Dollar.
