This fund is managed by Schroder Unit Trusts Limited, which is a member of the Schroders Group.

### Objectives and investment policy

#### Objectives

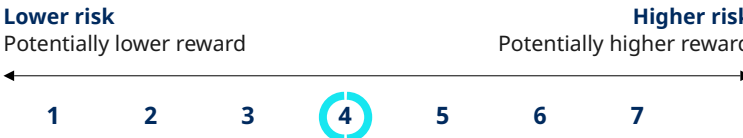
The fund aims to provide capital growth and income in excess of the benchmark\* (after fees have been deducted) over a 3 to 5 year period by investing in a diversified portfolio of bonds worldwide.  
\* The fund's benchmark is a composite of 50% of the iBoxx GBP Gilts Total Return and 50% of the iBoxx GBP Non-Gilts (Gross Total Return) index.

#### Investment policy

The fund is actively managed and invests at least 80% of its assets in bonds denominated in sterling (or in other currencies and hedged back into sterling) issued by governments, government agencies, supra-nationals and companies worldwide.  
The fund may invest up to 10% of its assets in convertible bonds.  
The fund may invest more than 20% of its assets in below investment grade securities (as measured by Standard & Poor's or any other equivalent credit rating agencies) or in unrated securities.  
The fund may also invest directly or indirectly in other securities (including in

other asset classes), countries, regions, industries or currencies, collective investment schemes (including Schroder funds) and money market instruments, and hold cash.  
The fund may use derivatives with the aim of achieving investment gains, reducing risk and managing the fund more efficiently. The fund may use leverage and take short positions.  
**Benchmark**  
The fund's performance should be assessed against its target benchmark, being to exceed the 50% of the iBoxx GBP Gilts Total Return and 50% of the iBoxx GBP Non-Gilts (Gross Total Return) index. The investment manager invests on a discretionary basis and is not limited to investing in accordance with the composition of the benchmark.  
**Dealing frequency**  
You may redeem your investment upon demand. This fund deals daily.  
**Distribution policy**  
This unit class pays income received from the fund's investments to you annually.

### Risk and reward profile



#### The risk and reward indicator

The risk category was calculated using historical performance data and may not be a reliable indicator of the fund's future risk profile.

#### Risk factors

**Credit risk:** A decline in the financial health of an issuer could cause the value of its bonds to fall or become worthless.  
**Currency risk:** The fund may lose value as a result of movements in foreign exchange rates.  
**High yield bond risk:** High yield bonds (normally lower rated or unrated) generally carry greater market, credit and liquidity risk.

**Interest rate risk:** The fund may lose value as a direct result of interest rate changes.  
**Liquidity risk:** In difficult market conditions, the fund may not be able to sell a security for full value or at all. This could affect performance and could cause the fund to defer or suspend redemptions of its shares.  
**Operational risk:** Operational processes, including those related to the safekeeping of assets, may fail. This may result in losses to the fund.  
**Performance risk:** Investment objectives express an intended result but there is no guarantee that such a result will be achieved. Depending on market conditions and the macro economic environment, investment objectives may become more difficult to achieve.  
**IBOR:** The transition of the financial markets away from the use of interbank offered rates (IBORs) to alternative reference rates may impact the valuation of certain holdings and disrupt liquidity in certain instruments. This may impact the investment performance of the fund.  
**Derivatives risk:** A derivative may not perform as expected, may create losses greater than the cost of the derivative and may result in losses to the fund. The fund may also materially invest in derivatives including using short selling and leverage techniques with the aim of making a return. When the value of an asset changes, the value of a derivative based on that asset may change to a much greater extent. This may result in greater losses than investing in the underlying asset.

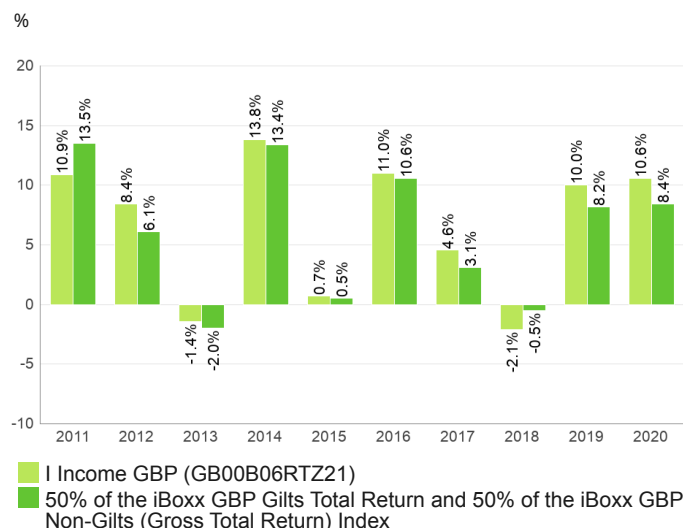
The charges you pay are used to pay the costs of running the fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

The charges are mostly, if not exclusively, the Schroders Annual Charge (as may be discounted for retail unit classes depending on the size of the fund) but certain additional expenses may be charged as set out in the prospectus. The Schroders Annual Charge (without any discount) for this unit class of the fund is 0.33%. The fund's annual report for each financial year will include details on the exact charges made including any discounts.
