STRATEGIC REPORT

The directors present their strategic report for the year ended 31 March 2015.

BUSINESS REVIEW

The loss for the year, after taxation is £63,000 (2014: loss £63,000)

The principal activity of Investec Investment Trust PLC (the "company") is to source funds from the financial markets for group activities and it will continue to operate in this capacity for the foreseeable future. The company's 3.5 per cent and 5 per cent cumulative preference shares are listed on the London Stock Exchange.

The company's ultimate parent is Investec plc. The company's parent company, Investec Group Investments (UK) Limited, a wholly owned subsidiary of Investec plc, owns all of the company's ordinary shares, £266,586 nominal of the company's 3.5 per cent cumulative preference shares and £96,612 nominal of the company's 5 per cent cumulative preference shares.

The preference shares are classified as a liability and not equity (refer to note 1, Accounting Policies).

The company had no employees in the current year or prior year.

Given the straight forward nature of the business the company's directors are of the opinion that analysis using key performance indicators is not necessary for an understanding of the development, performance or financial position of the business.

At 31 March 2015 the company had net assets of £25,894,000 (2014: £25,957,000)

PRINCIPAL RISKS AND UNCERTAINTIES

The company's financial risks are managed at the Investec plc group level. Surplus liquidity arising from time to time was loaned by the company during the year in which it arose on an interest free basis to its immediate parent company. The loan is repayable on demand and the company has the right, at any time and at its sole discretion, to charge interest thereon at a commercial rate. Preference dividend payments are funded from the loan. The company's exposure to financial risks is further discussed in note 12.

DIRECTORS' REPORT

The directors present their report and financial statements for the year ended 31 March 2015.

DIVIDENDS

The directors do not recommend the payment of a final ordinary dividend for the year ended 31 March 2015 (2014 - £nil). Dividends paid on the preference shares in the year amounted to £62,772 (2014: £62,772).

DIRECTORS AND THEIR INTERESTS

The current directors of the company are listed on page 1. Mr B M Johnson was appointed as a director of the company on 16 July 2014. Messrs C S Heyworth and K P McKenna were appointed as directors of the company on 8 December 2014. Mr S M Burgess resigned as a director of the company on 28 November 2014. According to the register of directors' interests, no director holding office at 31 March 2015 had any beneficial interest in the shares of the company during the year.

DISCLOSURE OF INFORMATION TO THE AUDITOR

So far as each person who was a director at the date of approving this report is aware, there is no relevant audit information, being information needed by the company's auditor in connection with preparing its report, of which the company's auditor is unaware. Having made enquiries of fellow directors, each director has taken all the steps that he is obliged to take as a director in order to make himself aware of any relevant audit information and to establish that the company's auditor is aware of that information.

The directors confirm that, to the best of each person's knowledge:

- (a) the financial statements in this report, which have been prepared in accordance with UK GAAP and the Companies Act 2006, give a true and fair view of the assets, liabilities, financial position and loss of the company; and
- (b) the directors' report includes a fair review of the development and performance of the business and the position of the company together with a description of the principal risks and uncertainties that they face.

DIRECTORS' INDEMNITY AND DIRECTORS' & OFFICERS' LIABILITY INSURANCE

The company maintains a Directors' and Officers' Liability Insurance policy. In accordance with the Company's Articles of Association, the board may also indemnify a director from the assets of the company against any costs or liability incurred as a result of their office, to the extent permitted by law. Neither the insurance policy nor any indemnities that may be provided by the company provide cover for fraudulent or dishonest actions by the directors. However, costs may be advanced to directors for their defence in investigations or legal actions.

CORPORATE GOVERNANCE

The company has issued preference shares that are listed on the London Stock Exchange. The company is part of the Investec Plc group and is therefore subject to the group's system of risk management, internal control and financial reporting. The corporate governance statements and disclosures, as required by section 7.2.1. of the Disclosure and Transparency Rules are detailed in the Investec Plc consolidated financial statements which are publicly available at www.investec.com.

GOING CONCERN

On the basis of current financial projections the directors have a reasonable expectation that the company has adequate resources to continue in operational existence for the foreseeable future and accordingly the going concern basis is adopted in the preparation of the annual financial statements.

DIRECTORS' REPORT

SUBSEQUENT EVENTS

The directors confirm that there were no significant events occurring after the balance sheet date to the date of this report that would meet the criteria to be disclosed in the financial statements for the year ended 31 March 2015.

ANNUAL GENERAL MEETING AND AUDITOR

Ernst & Young LLP have indicated their willingness to continue in office as auditor of the company. A resolution to re-appoint Ernst & Young LLP as auditor will be proposed at the next Annual General Meeting.

NOTES TO THE FINANCIAL STATEMENTS

at 31 March 2015

1. ACCOUNTING POLICIES

Basis of presentation

The financial statements have been prepared in accordance with applicable United Kingdom law and Generally Accepted Accounting Practice and on a going concern basis. The financial statements have been prepared under the historical cost convention.

With effect from 1 April 2015 the company will be producing its financial statements in accordance with FRS 101. FRS 101 forms part of the new UK financial reporting regime and allows UK qualifying subsidiaries to apply EU adopted International Financial Reporting Standards ('IFRS') but with reduced disclosure. There is not expected to be a material impact of this change on valuation or measurement.

Cash flow statement

The company is exempt from the requirements to prepare a cash flow statement under Financial Reporting Standard 1 (revised), because a consolidated cash flow statement is included in the publicly available consolidated financial statements of its ultimate parent undertaking, Investec plc.

Classification of preference shares as debt

The preference shares issued by the company create a financial liability as defined by Financial Reporting Standard 25 as they contain a contractual obligation to deliver cash and are therefore presented as a liability in the balance sheet. Shares classified as debt are initially measured at fair value net of transaction costs and thereafter at amortised cost until extinguished on redemption. The corresponding dividends relating to the preference shares classified as a liability are charged as interest expense in the profit and loss account on an accruals basis.

Disclosure of financial instruments

The directors have taken advantage of the disclosure exemptions available to subsidiary undertakings in Financial Reporting Standard 29.

Taxation

Corporation tax is provided on taxable profits at the current rate.

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date where transactions or events that result in an obligation to pay more tax in the future or a right to pay less tax in the future have occurred at the balance sheet date. This is subject to deferred tax assets only being recognised if it is considered more likely than not that there will be sustainable profits from which the future reversal of the underlying timing differences can be deducted. Timing differences are differences between the Company's taxable profits and its results as stated in the financial statements, which are capable of reversal in one or more subsequent periods.

Deferred tax is measured at a non-discounted basis at the tax rates that are expected to apply in the periods in which the timing differences are expected to reverse, based on tax rates and laws that have been enacted or substantively enacted at the balance sheet date.

Related party transactions

The company has taken advantage of the exemptions available in Financial Reporting Standard 8 from disclosing transactions with related parties which are wholly owned members of the Investec pic group.

2. AUDITOR'S REMUNERATION

In the current year, the auditor's remuneration of £15,602 (2014: £15,335) in respect of the audit of the company's financial statements has been borne by another group company. Statutory information for other services provided by the company's auditor is given in the consolidated financial statements of its ultimate parent company which are publicly available. There were no non-audit services provided to the company during the year and in the prior year.

3. EMOLUMENTS OF DIRECTORS

The directors were employed and remunerated as directors or executives of Investec plc and its subsidiaries ("the Investec plc group") in respect of their services to the Investec plc group as a whole and their remuneration has been paid by other group companies. It is estimated that the remuneration for their services to the company in the year totalled £19,583 (2014: £15,000). The company had no employees during the year (2014: none).

- there is no prescribed redemption or repayment date for either class of preference shares.

12. RISK MANAGEMENT

As a subsidiary of Investec plc, the company falls under the Investec Group's Risk Management Framework which is set out in the Investec plc and Investec Limited 2015 combined consolidated financial statements, Risk Management and Corporate Governance report.

Credit risk

The company has no exposure to credit risk other than on the loan advanced to the parent undertaking.

Liquidity risk

The company's only financial obligations in the foreseeable future are payment of dividend on the preference shares and administrative expenses. The company is able to recall the loan to the parent undertaking (or part thereof) at any time and therefore does not foresee any risk of being unable to meet its financial commitments.

Interest rate risk

The company has a fixed interest obligation in respect of the dividend on the preference shares and is therefore not exposed to fluctuation in interest rates. The loan to the parent is interest free. However, the company has the right at any time and at its sole discretion to charge interest thereon at a commercial rate.

Capital Management

The company manages and monitors its capital on an ongoing basis and with consideration for the ongoing commitments of the entity. The company is not regulated and therefore it is not subject to any capital adequacy requirements.

13. ULTIMATE PARENT UNDERTAKING

The company's immediate parent undertaking is Investec Group Investments (UK) Limited.

The company's ultimate parent undertaking and controlling party is Investec plc, a company incorporated in the United Kingdom and registered in England and Wales. Investec Bank plc is the smallest group and Investec plc is the largest group in which the results of the company are consolidated. The consolidated financial statements of Investec plc and Investec Bank plc are available to the public and may be obtained from Investec plc at 2 Gresham Street, London, EC2V 7QP.
