Objectives and Investment Policy

Investment Objective

The objective of the Fund is to track the performance of the Japanese equity market.

Investment Policy

The Fund seeks to track the performance of the MSCI Japan Index (the "Index") as closely as possible.

The Fund invests primarily in securities included in the Index. These securities include large and mid cap equities issued by companies in Japan. As it may be difficult to purchase all securities in the Index efficiently, in seeking to track the performance of the Index the Fund will use an optimisation strategy to build a representative portfolio which should reflect the performance of the Index. Consequently, the Fund will typically hold only a subset of the securities included in the Index. In limited circumstances the Fund may purchase securities that are not included in the Index.

This Acc class is made available to reduce exchange rate fluctuations between the currency of this share class and the currency in which the underlying assets of the Fund are denominated. The share class will be hedged back to EUR and consequently should more closely track the corresponding hedged version of the Index (MSCI Japan 100% Hedged to EUR Index).

The Fund may use financial derivative instruments (that is, financial contracts whose prices are dependent on one or more underlying assets) for currency hedging and to manage the portfolio efficiently.

Save in exceptional circumstances, the Fund will generally only issue and redeem shares to certain institutional investors. However, shares of the Fund may be purchased or sold through brokers on one or more stock

exchanges. The Fund trades on these stock exchanges at market prices which may fluctuate throughout the day. Market prices may be greater or less than the daily net asset value of the Fund.

The Fund does not currently engage in securities lending.

Shareholders may redeem shares on any UK business day (other than days on which relevant financial markets are closed for business and/or the day preceding any such day provided that a list of such closed market days will be published for the Fund on www.spdrs.com); and any other day at the Directors' discretion (acting reasonably) provided Shareholders are notified in advance of any such days.

Any income earned by the Fund will be retained and reflected in an increase in the value of the shares.

The Shares of the Acc are issued in Euro.

Why is this Fund in this category?

The Fund is in risk category 6 as its return has experienced very high rises and falls historically.
