# **Objectives and Investment Policy**

# **Investment Objective**

The objective of the Fund is to track the performance of the intermediate maturity U.S. Treasury bond market.

# **Investment Policy**

The investment policy of the Fund is to track the performance of the Bloomberg Barclays U.S. 5-7 Year Treasury Bond Index (the "Index") as closely as possible.

The Fund invests primarily in securities included in the Index. These securities will only include bonds that have a maturity of between five and up to (but not including) seven years remaining and must be fixed rate and rated investment grade (high quality) as defined by the Index methodology. Certain special issues, such as state and local government series bonds (SLGs), Treasury Inflation Protected Securities (TIPS) and Separate Trading of Registered Interest and Principal of Securities (STRIPS) are excluded.

As it may be difficult to purchase all securities in the Index efficiently, in seeking to track the performance of the Index, the Fund will use a stratified sampling strategy to build a representative portfolio. Consequently, the Fund will typically hold only a subset of the securities included in the Index. In limited circumstances the Fund may purchase securities that are not included in the Index.

The Fund may use financial derivative instruments (that is, financial contracts whose prices are dependent on one or more underlying assets) in order to manage the portfolio efficiently.

Save in exceptional circumstances, the Fund will generally only issue and redeem shares to certain institutional investors. However, shares of the Fund may be purchased or sold through brokers on one or more stock

# Why is this Fund in this category?

The Fund is in risk category 3 as its return has experienced medium rises and falls historically.


