## **Objectives and Investment Policy**

#### **Investment Objective**

The objective of the Fund is to track the performance of the Eurozone government bond market for securities with a short-term maturity of between 1 and up to (but not including) 3 years.

#### **Investment Policy**

The Fund seeks to track the performance of the Bloomberg Barclays Euro 1-3 Year Treasury Bond Index (the "Index") as closely as possible.

The Fund invests primarily in securities included in the Index. These securities currently include bonds issued by governments from the Eurozone. Only bonds issued in Euros or legacy Euro currencies with a maturity between one and up to (but not including) three years are included. As it may be difficult to purchase all securities in the Index efficiently, in seeking to track the performance of the Index the Fund will use a stratified sampling strategy to build a representative portfolio. Consequently, the Fund will typically hold only a subset of the securities included in the Index.

The Fund may use financial derivative instruments (that is, financial contracts whose prices are dependent on one or more underlying assets) in order to manage the portfolio efficiently.

Save in exceptional circumstances, the Fund will generally only issue and redeem shares to certain institutional investors. However, shares of the Fund may be purchased or sold through brokers on one or more stock exchanges. The Fund trades on these stock exchanges at market prices which may fluctuate throughout the day. Market prices may be greater or less than the daily net asset value of the Fund.

#### **Risk Disclaimer**

The risk category above is not a measure of capital loss or gains but of how significant the rises and falls in the Fund's return have been historically.

For example a fund whose return has experienced significant rises and falls will be in a higher risk category, whereas a fund whose return has

experienced less significant rises and falls will be in a lower risk category. The lowest category (i.e., category 1) does not mean that a fund is a risk free

investment.

As the Fund's risk category has been calculated using historical data, it may not be a reliable indication of the Fund's future risk profile.

#### Why is this Fund in this category?

The Fund is in risk category 2 as its return has experienced relatively low rises and falls historically.

The Fund does not currently engage in securities lending.

Shareholders may redeem shares on any UK business day (other than days on which relevant financial markets are closed for business and/or the day preceding any such day provided that a list of such closed market days will be published for the Fund on www.spdrs.com); and any other day at the Directors' discretion (acting reasonably) provided Shareholders are notified in advance of any such days.

Any income earned by the Fund will be paid to shareholders in respect of the shares.

The Fund's shares are issued in Euros.


