# **Xtrackers**

## Xtrackers MSCI Europe UCITS ETF Share Class: 1D (ISIN: LU1242369327), (WKN: DBX0P1), (Currency: USD) a sub fund of Xtrackers. The Fund is managed by Deutsche Asset Management S.A., part of the DWS Group.

#### **Objectives & Investment Policy**

The aim is for your investment to reflect the performance of the MSCI Total Return Net Europe Index (Index) which is designed to reflect the performance of the listed shares of certain companies from European developed markets.

The companies making up the Index are large and medium sized companies based on the combined value of a company's readily available shares as compared to other companies. A company's weighting on the Index depends on its relative size. The Index is calculated on a total return net basis which means that all dividends and distributions by the companies are reinvested in the shares after tax. The Index is reviewed and rebalanced at least quarterly.

To achieve the aim, the Fund will attempt to replicate the Index by buying all (or, on an exceptional basis, a substantial number



To the extent the Fund undertakes securities lending to reduce costs, the Fund will ultimately be allocated 70% of the associated revenue generated, Deutsche Asset Management (UK) Limited, as Sub-Portfolio Manager, will be allocated 15%, and Deutsche Bank AG, as securities lending agent, will be allocated 15%. To facilitate this, the Fund will initially receive 85% of the associated revenue generated from which Deutsche Asset Management (UK) Limited will receive its allocation. As securities lending revenue sharing does not increase the costs of running the Fund, this has been excluded from the ongoing charges.
