Objective


To generate income and some growth over the long term (5 years or more) by investing in UK equities (company shares).

Performance Target: To exceed the Investment Association UK Equity Income Sector Average return over 1 year and to be top quartile over three years or longer and deliver a yield greater than that of the FTSE 350 Index over rolling three year periods. The Performance Target is the level of performance that the management team hopes to achieve for the fund. There is however no certainty or promise that they will achieve the Performance Target. Portfolio securities

Management process

- The management team use their discretion (active management) to maintain a diverse asset mix at sector and stock level.
- Their primary focus is on stock selection using research techniques to select individual holdings.
 The research process is focused on identifying companies where the management team have a different view of a companys prospects than that of the market, and which align with their views regarding future economic and business conditions.
- The combined average yield on assets in the fund is expected to be higher than the broad UK equity market, as represented by the FTSE 350 Index.
- In seeking to achieve the Performance Target, the FTSE 350 Index is used as a reference point for
 portfolio construction and as a basis for setting risk constraints. The expected variation (tracking
 error) between the returns of the fund and the index is not ordinarily expected to exceed 8%. Due
 to the income nature of the management process, the funds performance profile may deviate
 significantly from that of the FTSE 350 Index.
