
## Objectives and investment policy

- The Fund seeks to track the performance of the FTSE Emerging Index (the "Index").
- The Index is comprised of large and mid-sized company stocks in emerging markets.
- The Fund attempts to:
- 1. Track the performance of the Index by investing in a representative sample of Index constituent securities.
- Remain fully invested except in extraordinary market, political or similar conditions.
- The Fund may invest in financial derivative instruments that could increase
  or reduce exposure to underlying assets and result in greater fluctuations
  of the Fund's net asset value. Some derivatives give rise to increased
  potential for loss where the Fund's counterparty defaults in meeting its
  payment obligations.
- · The base currency of the Fund is USD.
- The Fund invests in securities which are denominated in currencies other than the listing currency. Movements in currency exchange rates can affect the return of investments

- The Fund may engage in short term secured lending of its investments to certain eligible third parties. This is used as a means of generating additional income and to off-set the costs of the Fund.
- · The Fund may not be appropriate for short-term investment.
- · Income from the ETF Shares will normally be paid out quarterly.
- ETF Shares are listed on one or more stock exchange(s). Subject to certain exceptions set out in the prospectus, investors who are not Authorised Participants may only sell ETF Shares through a company that is a member of a relevant stock exchange at any time when that stock exchange is open for business.
- Portfolio transaction costs will have an impact on performance.
- Shares in the Fund can be bought or sold on a daily basis (save on certain bank holidays or public holidays and subject to certain restrictions described in Appendix 1 of the prospectus) by submitting an application in writing or by telephone. - Index tracking risk. The Fund is not expected to track the performance of the Index at all times with perfect accuracy. The Fund is, however, expected to provide investment results that, before expenses, generally correspond to the price and yield performance of the Index.
- Index sampling risk. As the Fund uses an index sampling technique whereby a representative sample of securities are selected to represent the Index, there is the risk that the securities selected for the Fund may not, in the aggregate, approximate the full Index.



Investors who are not APs will not pay these fees or costs.
