
#### Objectives and Investment Policy

The Fund seeks to replicate (with a maximum tracking error\* of 1%) the performance of the S&P GSCI® Energy & Metals Capped Component 35/20 Total Return (the «Index») by investing in a substitute basket, composed of, inter alia, shares of companies, debt securities or cash (synthetic replication).

When investing in a basket of securities called substitute basket the performance is swapped with the performance of the index, generating counterparty risk. Income are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days)

### Risk and Reward Profile

- Why is the Fund in this specific category?

The risk category is justified by the investment in Commodity markets that may experience significant, sudden price variations. Thus, the underlying assets may evolve in a markedly different way from traditional securities markets (share markets, bond markets etc).

• The higher the risk, the longer the recommended investment horizon.

Other risks materially relevant to the Fund which are not adequately captured by the indicator are described below:

- <u>Credit Risk:</u> This risk relates to the ability of an issuer to honour its commitments: downgrades of an issue or issuer rating may lead to a drop in the value of associated bonds.
- <u>Liquidity Risk</u>: This risk arises from the difficulty of selling an asset at a fair market price and at a desired time due to lack of buyers.
- <u>Counterparty Risk</u>: This risk is associated with the ability of a counterparty in an
  Over The Counter financial transaction to fulfil its commitments like payment,
  delivery and reimbursement.
- <u>Derivatives Risk</u>: When investing in over the counter or listed derivatives, the Fund
  aims to hedge and/or to leverage the yield of its position. The attention of the
  investor is drawn to the fact that leverage increases the volatility of the subfund.


