# BMO Managed Portfolio Trust PLC Growth Portfolio

Manager Commentary

Equity markets across most developed countries, especially in the US and Europe, continued to make positive headway during April. The only notable laggards were, rather surprisingly, China and Japan. Confidence in the recovery from the pandemic has increased, in part due to the successful vaccination programme in the US and UK. which has played a key role in driving down infection rates. There are signs too that Europe, after a chaotic first quarter, is seeing its various vaccination programmes picking up momentum. In the UK, estimates for growth for this year and next are being sharply raised, with the expectation that most restrictions will be lifted in the next two or three months. Corporate results have reflected this, with a wide swathe of companies across many different sectors beating estimates and accompanying the results with more optimistic statements regarding prospects.

Against this background, the FTSE All Share Index rose 4.3%, while the FTSE Close End Investment Company Index gained a healthy 5.2%% (both in total return terms).

The Net Asset Value of the Growth Portfolio gained by 5.3% (also in total return terms). The leading performer was Henderson Opportunities Trust, which rose 16.5%, helped by a strong performance from the smaller company element of the portfolio.




