SECTION 1
MEMORANDUM OF ASSOCIATION
OF
INVESCO MARKETS II PUBLIC LIMITED COMPANY

- 1 The name of the Company is “Invesco Markets II Public Limited Company”.
- 2 The Company is a public limited company being an investment company with variable capital and segregated liability between sub-funds having as its sole object the collective investment in transferable securities and/or other liquid financial assets referred to in Regulation 68 of the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011 as amended and as may be further amended, supplemented or consolidated from time to time including any condition that may from time to time be imposed thereunder by the Central Bank of Ireland (the “**Regulations**”). The Company may take any measures and carry out any operations including the exercise of ancillary powers listed hereafter in the pursuit of the accomplishment and development of its sole object to the full extent permitted by applicable law.
- 3 The powers of the Company to attain the said object are:
 - 3.1 to carry on business as an investment company and to acquire, dispose of, invest in and hold by way of investment, shares, stocks, securities, bonds, obligations, certificates of deposit, treasury bills, trade bills, bank acceptances, bills of exchange, fixed rate securities, variable or floating rate securities, securities in respect of which the return and/or repurchase amount is calculated by reference to any index, price or rate, monetary and financial instruments of all kinds, futures contracts, swaps, options contracts, contracts for differences, commodities, forward rate agreements, debentures, debenture stock, warrants, commercial paper, promissory notes, mortgage backed securities, asset backed securities and securities of all kinds created, issued or guaranteed by any government, sovereign, ruler, commissioners, body or authority, supreme, state, municipal, local, supranational or otherwise, in any part of the world, or by any company, bank, association or partnership, whether with limited or unlimited liability constituted or carrying on business or activities in any part of the world, units of or participation in any unit trust scheme, mutual fund or collective investment scheme in any part of the world, policies of insurance and assurance, domestic and foreign currency and any present or future rights and interests to or in any of the foregoing, to subscribe for the same either conditionally or otherwise, to enter into underwriting, stock-lending and repurchase and similar contracts with respect thereto, to exercise and enforce all rights and powers conferred by or incidental to the ownership thereof and from time to time to sell, exchange, lend, vary or dispose of and grant and dispose of options over any of the foregoing and to deposit money (or place money on current account) with such persons in such currencies and otherwise on such terms as may seem expedient;
 - 3.2 to deposit money, securities and/or property to or with such persons, and on such terms as may seem expedient and to discount, buy and sell bills, notes, warrants, coupons and other negotiable or transferable instruments, securities or documents of whatsoever nature;
 - 3.3 to establish or acquire any wholly owned subsidiary or subsidiaries of the Company for the benefit of the Company as a whole and in accordance with the conditions identified in the Regulations (the investments, assets and shares of which are held by the Depositary or sub-custodian appointed by the Depositary with the prior approval of the Competent Authority) and to capitalise any such subsidiary in any manner as the Directors of the Company may from time to time consider appropriate including by way of share capital, loan or otherwise;
 - 3.4 where required for the direct pursuit of the business of the Company, to acquire by purchase, lease, exchange, hire or otherwise lands and real or personal property wheresoever situate of any kind or of any tenure or any interest in the same; to erect and construct houses, buildings or works

of every description on any land of the Company, or on any other lands or property, and to pull down, rebuild, enlarge, alter or improve existing houses, buildings or works thereon and generally to manage deal with and improve the property of the Company; and to sell, lease, let, mortgage or otherwise dispose of the lands, houses, buildings, and other property of the Company;

- 3.5 to carry on business as capitalists and financiers, and to undertake and carry on all kinds of financial, trust, agency, broking, and other operations including underwriting, issuing on commission or otherwise of stocks and securities of all kinds;
- 3.6 to receive money on loan and to borrow or raise money in any currency and secure or discharge any debt or obligation of or binding on the Company in any manner and in particular by the issue of debentures and to secure the repayment of any money borrowed, raised or owing by mortgage, charge or lien against the whole or any part of the Company's property or assets (whether present or future) including uncalled capital and also by a similar mortgage charge or lien to secure or guarantee the performance of any obligation or liability undertaken by the Company;
- 3.7 to guarantee the payment of money by or the performance of any contracts, liabilities, obligations, or engagements of any company, firm or person and to grant guarantees and indemnities of every description, and to undertake obligations of every description;
- 3.8 to enter into any arrangements with any government, or authority, supreme, municipal, local or otherwise, and to obtain from any such government or authority any rights, concessions and privileges that may seem conducive to the objects of the Company or any of them;
- 3.9 to employ any person, firm, company or other body to investigate and examine the conditions, prospects, values, character and circumstances of any business concern or undertaking and generally of any assets, concessions, properties or rights;
- 3.10 to take out, acquire, surrender and assign policies of assurance with any insurance company or companies it may think fit payable at fixed or uncertain dates or on the happening of any contingency whatsoever and to pay the premiums thereon;
- 3.11 to promote and aid in promoting, constitute, form or organise companies, syndicates or partnerships of all kinds for the purpose of acquiring and undertaking any property and liabilities of the Company, or of advancing directly or indirectly the objects thereof, or for any purpose that the Company may think expedient;
- 3.12 to promote and aid in promoting, constitute, form or organise any company or companies, syndicates or partnerships of all kinds in any part of the world and to subscribe for shares therein or other securities thereof for the purpose of carrying on any business that the Company is authorised to carry on or of advancing directly or indirectly the objects thereof, or for any other purpose that may seem directly or indirectly calculated to benefit the Company;
- 3.13 to amalgamate or enter into partnership or into any arrangement for sharing profits, union of interest, joint venture, reciprocal concessions or co-operation with any person or company carrying on, engaged in, or about to carry on or engage in any business or transaction that the company is authorised to carry on or engage in, or any business or transaction capable of being conducted so as directly or indirectly to benefit the Company, and to take or otherwise acquire and hold, sell, re-issue, or otherwise deal with shares or stock in or securities or obligations of, and to subsidise or otherwise assist any such securities or obligations or any dividends on any such shares or stock;
- 3.14 to apply for, purchase or otherwise acquire any patents, trademarks, copyrights, designs, licences, and like rights, conferring an exclusive or limited right to use, or any secret or other information as to any invention that may seem capable of being used for any of the purposes of the Company or the acquisition of which may seem calculated directly or indirectly to benefit the Company and to use, exercise, develop, sell, mortgage, grant licences in respect of, or otherwise turn to account the rights and information so acquired;

- 3.15 to establish and/or carry on any other business or businesses that may seem to the Company capable of being conveniently carried on in connection with any business that the Company is authorised to carry on, or may seem to the Company calculated directly or indirectly to benefit the Company or to enhance the value of or render profitable any of the Company's properties or rights;
- 3.16 to acquire and carry on all or any part of the business, goodwill or property, and to undertake any liabilities of any person, firm, association or company possessed of property suitable for any of the purposes of the Company, or carrying on or proposing to carry on any business that the Company is authorised to carry on, and as the consideration for the same to pay cash or to issue any fully or partly paid up shares, debentures, or obligations of the Company or undertake all or any of the liabilities of such person, firm association or company;
- 3.17 to create, issue, make, draw, accept and negotiate redeemable debentures or bonds or other obligations, bills of exchange, promissory notes or other negotiable instruments;
- 3.18 to distribute among the members of the Company in specie any assets of the Company or any proceeds of sale or disposal of any assets of the Company;
- 3.19 to sell, let, develop, dispose of or otherwise deal with the undertaking or all or any part of the property real or personal, rights or privileges of the Company on such terms as the Company may think fit, with power to accept as the consideration, any shares, stocks, debentures, securities or obligations of or interest in any other company;
- 3.20 to establish and support or aid in the establishment and support of associations, institutions and conveniences calculated to benefit any of the employees or ex-employees of the Company or any associated company, or the dependants or connections of such persons, and to grant pensions and allowances and to make payment towards insurance and to subscribe or guarantee money for charitable or benevolent objects or for any exhibition, or for any public general or useful object;
- 3.21 to remunerate any companies, firm or person for services rendered or to be rendered in placing or assisting to place or guaranteeing the placing of any of the shares in the Company's capital or any debentures or other securities of the Company or in or about the promotion of the Company or the conduct of its business and whether by cash payment or by the allotment to him or them of stocks, shares, debentures, bonds or other securities of the Company, credited as paid up in full in part or otherwise;
- 3.22 to promote any company or companies for the purpose of its or their acquiring all or any of the property, rights and liabilities of the Company, or for any other purpose that may seem directly or indirectly calculated to benefit the Company and to pay all the expenses of or incidental to such promotion;
- 3.23 to pay out of the funds of the Company all expenses that the Company may lawfully pay incidental to the formation, registration and advertising of or raising money for the Company and the issue of its capital or any class thereof, including brokerage and commissions for obtaining applications for or taking, placing or procuring the underwriting of shares, stocks, debentures, bonds or other securities of the Company and any other expenses that the directors shall consider to be in the nature of preliminary expenses and to amortise such expenses over such period or periods as the directors may determine;
- 3.24 to pay for any property or rights acquired by the Company either in cash or by the issue of fully paid shares of the Company;
- 3.25 to withhold or deduct from any payment to be made to a shareholder of the Company any amount for or on account of any taxes imposed or required to be withheld by any jurisdiction or, where no payment is due to be made, to appropriate or cancel the number of shares required to meet any such tax liability;

- 3.26 to exercise all or any of the powers aforesaid in any part of the world, and as principals, agents, contractors, trustees or otherwise, and by or through trustees, agents, attorneys or otherwise, and either alone or in conjunction with others;
- 3.27 to do all such other things as the Company may deem incidental or conducive to the attainment of any of the objects of the Company; and
- 3.28 to procure the Company to be registered or recognised in any part of the world outside Ireland.
- 4 Each of the ancillary powers of the Company (whether enumerated or not) is to be interpreted and exercised as ancillary to the objects of the Company but separate from and ranking equally to any other ancillary power.
- 5 The word "company" (except where used in reference to this Company) in this item shall be deemed to include any partnership or other body of persons, whether incorporated or not incorporated.
- 6 The liability of the members is limited.
- 7 The share capital of the Company shall be equal to the value for the time being of the issued share capital of the Company.
- 8 The initial authorised share capital of the Company is 2 Subscriber Shares of EUR 1 each and 1,000,000,000,000 shares of no par value initially designated as unclassified participating shares. The capital may be divided into different classes of shares with any restrictions or preferential, deferred or special rights or privileges attached thereto and from time to time may be varied so far as may be necessary to give effect to any such restrictions or rights or privileges. The minimum issued share capital of the Company is EUR 2 or its equivalent in another currency.

PART I - PRELIMINARY

1 Interpretation

- 1.1 Sections 65, 69(4), 77 to 81, 88(10), 95(1), 96(2) to (11), 124, 125(3), 144(3), 144(4), 148(2), 155, 159 to 165, 178(2), 180(5), 182(2), 182(5), 183(3), 186(c), 187, 188, 218(3), 218(4), 218(5), 229, 338(5), 338(6), 618(1)(b), 620(8), 1090, 1092, and 1113 of the Act shall not apply to the Company.
- 1.2 Expressions in these Articles referring to writing shall be construed, unless the contrary intention appears, as including references to printing, lithography, photography and any other modes of representing or reproducing words in a visible form. Expressions in these Articles referring to execution of any document shall include any mode of execution, whether under seal or under hand.
- 1.3 Unless specifically defined herein or in Appendix I or unless the context otherwise requires, words or expressions contained in these Articles shall bear the same meaning as in the Companies Act but excluding any statutory modification thereof not in force when these Articles become binding on the Company.
- 1.4 The table of contents, headings and captions included in these Articles are inserted for convenience of reference only and shall not be considered a part of or affect the construction or interpretation of these Articles.
- 1.5 References in these Articles to any enactment or any section or provision thereof shall mean such enactment, section or provision as the same may be amended and may be from time to time and for the time being in force.
- 1.6 In these Articles, the masculine gender shall include the feminine and neuter, and vice versa, and the singular number shall include the plural, and vice versa, and words importing persons shall include firms or companies.
- 1.7 References in these Articles to "EUR" are to the currency for the time being of the European Monetary Union Member States. References to the foregoing currency shall include any successor currency.

PART II - SHARE CAPITAL, UMBRELLA FUND AND RIGHTS

2 Share Capital

The authorised share capital of the Company is 2 Subscriber Shares of EUR 1 each and 1,000,000,000,000 shares of no par value initially designated as unclassified participating shares. The minimum issued share capital of the Company is EUR 2 or its equivalent in another currency.

3 Umbrella Fund

The Company is an "umbrella fund" comprising separate portfolios of assets and liabilities attributable thereto, referred to herein as Fund(s) as further described in item 8 of Appendix II, by reference to which shares are issued.

4 Issue of shares

- 4.1 Shares may only be issued as fully paid and shall have no par value.
- 4.2 The amount of the paid up share capital of the Company shall at all times be equal to the Net Asset Value of the Company.

- 4.3 The Directors may from time to time issue fractions of shares. Notwithstanding anything contained in these Articles, the holder of a fraction of a share may not exercise any voting rights in respect of such share.
- 4.4 The Directors may issue any of the unclassified shares as participating shares in a Fund with such rights or restrictions as the Directors may determine. The Directors may issue more than one class of shares that participate in a Fund. The provisions contained in items 1 to 7 of Appendix II shall govern the terms and conditions relating to the issue of shares.
- 4.5 The Directors, on the allotment and issue of any shares, may impose restrictions on the transferability or disposal of the shares as may be considered by the Directors to be in the best interests of the Shareholders as a whole.
- 4.6 The Directors may in their absolute discretion refuse to accept any application for shares in the Company or accept any application in whole or in part.
- 4.7 The Directors are generally and unconditionally authorised to exercise all powers of the Company to allot relevant securities, including fractions thereof, (as defined for the purposes of section 1021 of the Companies Act) up to an amount equal to the authorised but as yet unissued share capital of the Company.
- 4.8 Shares issued solely for the purposes of the incorporation of the Company and to enable the Company to seek authorisation under the Regulations from the Competent Authority will be issued at an issue price of EUR1 per share and shall be known as Subscriber Shares. Subscriber Shares may be redeemed by the Company at any time after the first issue of shares is effected after the Initial Offer Period. The price at which each Subscriber Share may be redeemed shall be EUR1 (or the price received for such Shares).
- 4.9 Notwithstanding any other provision of these Articles, the Directors may permit title to the shares to be transferred by means of a computer-based system and the Directors shall have the power to implement any arrangements that they think fit for evidencing title and arranging transfer of such shares and may implement any ancillary arrangements (including any anti-money laundering requirements) that seem to them necessary or desirable in respect of shares to be transferred through such a system.

5 Variation of rights

- 5.1 Whenever the share capital is divided into different classes of shares, the rights attached to any class may be varied or abrogated with the consent in writing of the Shareholders of three-fourths in number of the issued shares of that class, or with the sanction of a special resolution passed at a separate general meeting of the Shareholders of the shares of the class, and may be so varied or abrogated either while the Company is a going concern or during or in contemplation of a winding-up but such consent or sanction will not be required in the case of a variation, amendment or abrogation of the rights attached to any shares of any class if, in the view of the Directors, such variation, amendment or abrogation does not materially prejudice the interests of the relevant Shareholders or any of them. Any such variation, amendment or abrogation will be set out in a supplement to (or re-statement of) the Prospectus or the relevant Supplement originally issued in connection with the relevant shares, a copy of which will be sent to the relevant Shareholders entered on the Register on the date of issue of such document and will be binding on the relevant Shareholders. The quorum at any such separate general meeting, other than an adjourned meeting, shall be one person holding or representing by proxy at least one-third of the issued shares of the class in question and the quorum at an adjourned meeting shall be one person holding or representing by proxy shares of the Class in question or his proxy.
- 5.2 The rights conferred on the Shareholders of the shares of any class issued with preferred or other rights shall not, unless otherwise expressly provided by these Articles or the terms of the issue of

the shares of that Class, be deemed to be varied by the creation or issue of further shares ranking pari passu therewith or subordinate thereto.

6 Trusts not recognised

Except as required by law, no person shall be recognised by the Company as holding any share on any trust, and the Company shall not be bound by or be compelled in any way to recognise (even when having notice thereof) any equitable, contingent, future or partial interest in any share or any interest in any fractional part of a share or (except only as by these Articles or by law otherwise provided) any other rights in respect of any share except an absolute right to the entirety thereof in the Shareholder. This shall not preclude the Company from requiring the Shareholders or a transferee of shares to furnish the Company with information as to the beneficial ownership of any share when such information is reasonably required by the Company.

7 Disclosure of interests

7.1 Notwithstanding the provisions of the immediately preceding Article, the Directors, at any time and from time to time if, in their absolute discretion, they consider it to be in the interests of the Company to do so, may give a notice to the Shareholder or Shareholders of any share (or any of them) requiring such Shareholder or Shareholders to notify the Company in writing within such period as may be specified in such notice (which shall not be less than 28 days from the date of service of such notice) of full and accurate particulars of all or any of the following matters, namely:

7.1.1 his interest in such share;

7.1.2 if his interest in the share does not consist of the entire beneficial interest in it, the interests of all persons having any beneficial interest in the share (provided that one joint Shareholder of a share shall not be obliged to give particulars of interests of persons in the share that arise only through another joint Shareholder); and

7.1.3 any arrangement (whether legally binding or not) entered into by him or any person having any beneficial interest in the share whereby it has been agreed or undertaken or the Shareholder of such share can be required to transfer the share or any interest therein to any person (other than a joint Shareholder of the share) or to act in relation to any meeting of the Company or of any class of shares of the Company in a particular way or in accordance with the wishes or directions of any other person (other than a person who is a joint Shareholder of such share).

7.2 If, pursuant to any notice given under Article 7.1, the person stated to own any beneficial interest in a share or the person in favour of whom any Shareholder (or other person having any beneficial interest in the share) has entered into any arrangements referred to in Article 7.1.3, is a body corporate, trust, society or any other legal entity or association of individuals and/ or entities, the Directors, at any time and from time to time if, in their absolute discretion, they consider it to be in the best interests of the Company to do so, may give a notice to the Shareholder or Shareholders of such share (or any of them) requiring such Shareholder or Shareholders to notify the Company in writing within such period as may be specified in such notice (which shall not be less than 28 days from the date of service of such notice) of full and accurate particulars of the name and addresses of the individuals who control (whether directly or indirectly and through any number of vehicles, entities or arrangements) the beneficial ownership of all the shares, interests, units or other measure of ownership of such body corporate, trust, society or other entity or association wherever the same shall be incorporated, registered or domiciled or wherever such individuals shall reside provided that if at any stage of such chain of ownership the beneficial interest in any share shall be established to the satisfaction of the Directors to be in the ownership of any body corporate any of whose share capital is listed or dealt in on any bona fide stock exchange, unlisted securities market or over-the-counter securities market, it shall not be necessary to disclose details of the individuals ultimately controlling the beneficial interests in the shares of such body corporate.

- 7.3 The Directors, if they think fit, may give notices under Articles 7.1 and 7.2 at the same time on the basis that the notice given pursuant to Article 7.2 shall be contingent on disclosure of certain facts pursuant to a notice given pursuant to Article 7.1.
- 7.4 The Directors may require (before or after the receipt of any written particulars under this Article) any such particulars to be verified by statutory declaration.
- 7.5 The Directors may serve any notice pursuant to the terms of this Article irrespective of whether or not the Shareholder on whom it shall be served may be dead, bankrupt, insolvent or otherwise incapacitated and no such incapacity or any unavailability of information or inconvenience or hardship in obtaining the same shall be a satisfactory reason for failure to comply with any such notice provided that if the Directors in their absolute discretion think fit, they may waive compliance in whole or in part with any notice given under this Article in respect of a share in any case of bona fide unavailability of information or genuine hardship or where they otherwise think fit but no such waiver shall prejudice or affect in any way any non-compliance not so waived whether by the Shareholder concerned or any other joint Shareholder of the share or by any person to whom a notice may be given at any time.
- 7.6 For the purpose of establishing whether or not the terms of any notice served under this Article shall have been complied with, the decision of the Directors in this regard shall be final and conclusive and shall bind all persons interested.

8 Payment of commission

The Company may exercise the powers of paying commissions conferred by the Companies Act. Subject to the provisions of the Companies Act and these Articles, any such commission may be satisfied by the payment of cash or by the allotment of fully paid shares or partly in one way and partly in the other. On any issue of shares, the Company may also pay such brokerage as may be lawful.

PART III - REPURCHASE AND EXCHANGE OF SHARES

9 Right of repurchase

Shareholders shall have the right to request the Company to repurchase their shares in accordance with the terms and conditions set out in items 11 to 14 of Appendix II.

10 Right of Exchange

Shareholders shall have the right to exchange all or any of their shares in accordance with the terms and conditions set out in item 9 of Appendix II.

PART IV - SHARE CERTIFICATES/ SHARE WARRANTS

11 Computerised Securities

- 11.1 Subject to the Securities Regulations, the Directors (without consulting the Shareholders of any class of Participating Shares) may resolve that a class of Participating Shares is to become a Computerised Security or that a class of Shares must cease to be a Computerised Security.
- 11.2 Subject to the Securities Regulations and the facilities and requirements of the Relevant System, the Directors may implement any arrangements in relation to the holding of Participating Shares of a class in dematerialised form and the transfer of the title to the Participating Shares of that class by means of a Relevant System.
- 11.3 Subject to the Securities Regulations, the facilities and requirements of the Relevant System and the consent of the Company, a Member may change a Participating Share which is a

Computerised Security from a Participating Share held in certificated form to a Participating Share held in dematerialised form and vice versa.

- 11.4 While a class of Participating Shares is a Computerised Security, these Articles only apply to a Participating Share of that class to the extent that they are consistent with the holding of Participating Shares of that class in dematerialised form, the transfer of title to Shares of that class by means of a Relevant System and the Securities Regulations.
- 11.5 While a class of Participating Shares is a Computerised Security, the Company shall enter on the Register the number of Participating Shares each Member holds in dematerialised form and certificated form and shall maintain the Register in accordance with the Securities Regulations and the Relevant System.
- 11.6 Notwithstanding any provision of these Articles, a class of Participating Shares is not to be treated as two classes by virtue only of that class comprising both Shares in certificated and dematerialised form or as a result of any provision of these Articles or the Securities Regulations applying only in respect of Participating Shares in certificated or dematerialised form.

12 Confirmation of Ownership/Share Certificates

- 12.1 Every person whose name is entered as a Member in the Register shall receive a written confirmation of entry on the register and of ownership of the relevant class(es) of Participating Shares and (subject to Article 12.2) if specifically requested in writing by him, be entitled subject to such fee as the Directors may determine (not exceeding Stg£50 per certificate) to receive within two months after request for a certificate one certificate for such class of Participating Share in certificated form held by him. Bearer certificates will not be issued.
- 12.2 If the relevant Prospectus provides, in relation to any class of Shares, that the Directors shall issue certificates in relation to Shares thereof held in certificated form (without being requested by the relevant Shareholders), then such certificate will be issued, free of charge.

13 Balance and Exchange Certificates

- 13.1 If any Member shall surrender for cancellation a Share certificate representing Participating Shares of a particular class held by him and request the Company to issue in lieu thereof two or more Share certificates representing such Participating Shares in such proportions as he may specify, the Directors may, if they think fit, comply with such request. Where a Member transfers part only of the Participating Shares comprised in a certificate, the old certificate shall be cancelled and a new certificate, for the balance of such Participating Shares, issued in lieu without charge. Any two or more certificates of Participating Shares of any one class held by any Member at his request may be cancelled and a single new certificate for such Participating Shares issued in lieu without charge unless the Directors otherwise determine.
- 13.2 However, the Company shall not be bound to register more than four persons as the joint holders of any Participating Shares (except in the case of executors or trustees of a deceased member) and, in the case of a Participating Share held jointly by several persons and in respect of which the issue of a Share certificate has been requested, the Company shall not be bound to issue more than one certificate in respect of such holding and delivery of a certificate to one of such persons shall be sufficient delivery to all.
- 13.3 Every certificate shall be signed by the Depositary and the Company (and such signatures may be reproduced mechanically) and shall specify the name(s) of the holder(s) and the number and class of the Shares to which it relates and the fact that they are fully paid.

14 Replacement of Certificates

If a Share certificate be defaced, lost, stolen or destroyed, a new certificate shall be issued in lieu on such terms (if any) as to evidence and indemnity (and without charge other than for exceptional out-of-pocket expenses) as the Directors think fit.

15 Calls on Subscriber Shares

15.1 The Directors may from time to time make calls upon the Members in respect of any moneys unpaid on the Subscriber Shares provided that (except as otherwise fixed by the conditions of application or allotment) no call on any Shares shall be payable at less than 14 days from the date fixed for the payment of the last preceding call, and each Member shall (subject to being given at least 14 days' notice specifying the time or times and place of payment) pay to the Company at the time or times and place so specified the amount called on his Subscriber Shares. A call may be payable by instalments. A call may be revoked or postponed as the Directors may determine. A call shall be deemed to have been made at the time when the resolution of the Directors authorising the call was passed.

15.2 The Directors may, if they think fit, receive from any Member willing to advance the same all or any part of the money uncalled and unpaid upon the Subscriber Shares held by him beyond the sums actually called up thereon as a payment in advance of calls, and such payment in advance of calls shall extinguish, so far as the same shall extend, the liability upon the Subscriber Shares in respect of which it is advanced, and upon the money so received, or so much thereof as from time to time exceeds the amount of the calls then made upon the Shares in respect of which it has been received.

PART V - TRANSFER OF SHARES

16 Transfer of Shares in Certificated Form

16.1 A transfer of a Participating Share in certificated form requires the prior consent of the Directors or their delegate and may be effected by transfer in writing in any usual or common form or in any other form which the Directors may approve.

16.2 The instrument of transfer of a Participating Share in certificated form shall be executed by or on behalf of the transferor.

16.3 A transfer need not be under seal. However, a transfer by corporation shall be under seal unless the Company decides to recognise a transfer under hand by a person properly authorised to sign on the corporation's behalf.

16.4 No transfer of Subscriber Shares may be effected without the prior written consent of the Company.

17 Transfer of Shares in Dematerialised Form

17.1 A transfer of a Participating Share in dematerialised form shall be made in accordance with and subject to the Securities Regulations and the facilities and requirements of the Relevant System and in accordance with any arrangements made by the Board pursuant to Article 26.

18 Payment of taxation on transfer

The Directors may repurchase and cancel a sufficient portion of the transferor's shares to discharge any taxation payable to the Irish Tax Authorities in Ireland in respect of a transfer of shares by a Shareholder who is or is deemed to be an Irish Resident or a person Ordinarily Resident in Ireland or is acting on behalf of such a person.

If the Company is required to deduct, withhold or account for tax including any penalties and interest thereon upon the transfer of Shares by a Shareholder the provisions of item 13.6 of Appendix II hereof shall apply mutatis mutandis as if repeated in full herein.

19 Refusal to register transfers

19.1 The Directors in their absolute discretion and without assigning any reason therefor may decline to register any transfer of a share:

19.1.1 to a person who is not a Permitted Investor;

19.1.2 to an individual who is under 18 years of age (or such other age as the Directors may determine) or of unsound mind;

19.1.3 unless the transferee of such shares would, following such transfer, be the holder of shares with a value at the then current Subscription Price equal to or greater than the Minimum Initial Investment Amount;

19.1.4 in circumstances where as a result of such transfer the transferor or transferee would hold less than the Minimum Shareholding;

19.1.5 in regard to which any payment of taxation remains outstanding; and

19.1.6 to a person who does not clear such anti-money laundering checks as the Directors may determine.

19.2 The Directors may decline to recognise any instrument of transfer unless:

19.2.1 the instrument of transfer is accompanied by the certificate (if issued) for the shares to which it relates and such other evidence as the Directors may reasonably require to show the right of the transferor to make the transfer;

19.2.2 the instrument of transfer is in respect of one class of share only;

19.2.3 the instrument of transfer is in favour of not more than four transferees; and

19.2.4 the instrument of transfer is lodged at the Office or at such other place as the Directors may appoint.

20 Procedure on refusal

If the Directors refuse to register a transfer then, within two months after the date on which the transfer was lodged with the Company, they or their delegate shall send notice of the refusal to the transferee.

21 Entry in Register and the Closing of transfer books

21.1 The transferor shall be deemed to remain the holder of the Share until the name of the transferee is entered in the Register in respect of such Share.

21.2 The registration of transfers of shares or of transfers of any class of shares may be deferred at such times and for such periods as the Directors may determine.

22 Registration fees

A fee may be charged for the registration of any instrument of transfer or other document relating to or affecting the title to any share.

23 Retention of transfer instruments

The Company shall be entitled to retain any instrument of transfer that is registered, but any instrument of transfer that the Directors refuse to register shall be returned to the person lodging it when notice of the refusal is given.

24 Renunciation of allotment

Nothing in these Articles shall preclude the Directors from recognising a renunciation of the allotment of any shares by the allottee in favour of some other person, provided such other person is a Permitted Investor.

25 Compulsory transfer of shares

The Directors shall have the power to arrange for the compulsory transfer of shares acquired by or on behalf of a person who is not a Permitted Investor in accordance with the provisions set out in item 18 of Appendix II.

25A General transfer provisions of the Companies Act

The foregoing Articles of Part IX are without any prejudice to any other powers the Company may have under the provisions of section 94 of the Companies Act.

PART VI - TRANSMISSION OF SHARES

26 Death of Shareholder

If a Shareholder dies, the survivor or survivors where he was a joint Shareholder, or his personal representatives where he was a sole Shareholder or the only survivor of joint Shareholders, shall be the only persons recognised by the Company as having any title to his interest in the shares; but nothing herein contained shall release the estate of a deceased Shareholder from any liability in respect of any share that had been jointly held by him.

27 Transmission on death or bankruptcy/minors

Any guardian of an infant Shareholder and any curator or other legal representative of a Shareholder under legal disability and any person entitled to a share in consequence of the death or bankruptcy of a Shareholder may elect, on such evidence being produced as the Directors may properly require, either to become the Shareholder of the share or to make such transfer thereof as the deceased or bankrupt Shareholder or Shareholder under a disability could have made. If he elects to become the Shareholder, he shall give notice to the Company to that effect. If he elects to have another person registered, he shall execute an instrument of transfer of the share to that person. All of these Articles relating to the transfer of shares shall apply to the notice or instrument of transfer as if it were an instrument of transfer executed by the Shareholder and the death or bankruptcy or disability of the Shareholder had not occurred.

28 Rights before registration

A person becoming entitled to a share by reason of the death or bankruptcy of a Shareholder (on supplying to the Company such evidence as the Directors may reasonably require to show his title to the share) shall have the rights to which he would be entitled if he were the holder of the share, except that, before being registered as the Shareholder of the share, he shall not be entitled in respect of it to attend or vote at any meeting of the Company or at any separate meeting of the Shareholders of any class of shares in the Company, so, however, that the Directors, at any time, may give notice requiring any such person to elect either to be registered himself or to transfer the share and, if the notice is not complied with within 90 days, the Directors thereon may withhold payment of all dividends, bonuses or other money payable in respect of the share until the requirements of the notice have been complied with.

PART VII - ALTERATION OF SHARE CAPITAL

29 Increase of capital

- 29.1 The Company from time to time by ordinary resolution may increase the share capital by such amount and/or number as the resolution shall prescribe.
- 29.2 Subject to the provisions of the Companies Act and these Articles, the new shares shall be issued to such persons, on such terms and conditions and with such rights and privileges annexed thereto as the Directors shall determine.

30 Consolidation, sub-division and cancellation of capital

The Company, by ordinary resolution, may:

- 30.1 consolidate and divide all or any of its share capital into shares of larger amount;
- 30.2 subject to the provisions of the Companies Act, subdivide its shares, or any of them, into a larger number of shares than that fixed by Section 1 of this Constitution so however, that in the sub-division the proportion between the amount paid and the amount, if any, unpaid on each reduced share shall be same as it was in the case of the share from which the reduced share is derived;
- 30.3 increase the nominal value of any of its shares by the addition to them of any un-denominated capital;
- 30.4 increase its share capital by new shares of such amount as it thinks expedient;
- 30.5 cancel any shares that, at the date of the passing of the resolution, have not been taken or agreed to be taken by any person and reduce the amount of its authorised share capital by the amount of the shares so cancelled; or
- 30.6 redenominate the currency of any class of shares.

PART VIII - GENERAL MEETINGS

31 Annual general meetings

The Company shall hold in each year a general meeting as its annual general meeting in addition to any other meeting in that year and shall specify the meeting as such in the notice calling it. Not more than 15 months shall elapse between the date of one annual general meeting and that of the next PROVIDED THAT so long as the Company holds its first annual general meeting within 18 months of its incorporation, it need not hold it in the year of its incorporation or in the following year. Subsequent annual general meetings shall be held once in each year.

32 Extraordinary general meetings

All general meetings other than annual general meetings shall be called extraordinary general meetings.

33 Convening general meetings

The Directors may convene general meetings. Extraordinary general meetings may also be convened on such requisition, or in default may be convened by such requisitionists, and in such manner as may be provided by the Companies Act. If at any time there are not within the State sufficient Directors capable of acting to form a quorum, any Director or any one Shareholder may convene an extraordinary general meeting in the same manner as nearly as possible as that in which general meetings may be convened by the Directors.

34 Notice of general meetings

- 34.1 Subject to the provisions of the Companies Act allowing a general meeting to be called by shorter notice, an annual general meeting and an extraordinary general meeting called for the passing of a special resolution shall be called by at least 21 Clear Days' notice and all other extraordinary general meetings shall be called by at least 14 Clear Days' notice.
- 34.2 Any notice convening a general meeting shall specify the time and place of the meeting and, in the case of special business, the general nature of that business and, in reasonable prominence, that a Shareholder entitled to attend and vote is entitled to appoint a proxy to attend, speak and vote in his place and that a proxy need not be a Shareholder. Subject to any restrictions imposed on any shares, the notice shall be given to all the Shareholders, the Secretary, the Depositary, the Manager, the Investment Manager, the Directors and the Auditors.
- 34.3 The accidental omission to give notice of a meeting to, or the non-receipt of notice of a meeting by, any person entitled to receive notice shall not invalidate the proceedings at the meeting.
- 34.4 Where, by any provision contained in the Companies Act, extended notice is required of a resolution, the resolution shall not be effective (except where the Directors have resolved to submit it) unless notice of the intention to move it has been given to the Company not less than 28 days (or such shorter period as the Companies Act permit) before the meeting at which it is moved, and the Company shall give to the Shareholders notice of any such resolution as required by and in accordance with the provisions of the Companies Act.

PART IX - PROCEEDINGS AT GENERAL MEETINGS

35 Quorum for general meetings

- 35.1 No business other than the appointment of a chairman shall be transacted at any general meeting unless a quorum of Shareholders or holders of Subscriber Shares is present at the time when the meeting proceeds to business. Except as provided in relation to an adjourned meeting, one person entitled to vote on the business to be transacted, being a Shareholder or a holder of Subscriber Shares or a proxy for such holder or a duly authorised representative of a corporate Shareholder, shall be a quorum.
- 35.2 If such a quorum is not present within half an hour from the time appointed for the meeting, or if during a meeting a quorum ceases to be present, the meeting shall stand adjourned to the same day in the next week at the same time and place, or to such other time (which may be shorter or longer) and place as the Directors may determine. If at the adjourned meeting such a quorum is not present within half an hour from the time appointed for the meeting, the meeting, if convened otherwise than by resolution of the Directors, shall be dissolved, but if the meeting shall have been convened by resolution of the Directors, one person entitled to be counted in a quorum present at the meeting shall be a quorum.

36 Special business

All business shall be deemed special that is transacted at an extraordinary general meeting. All business that is transacted at an annual general meeting shall also be deemed special, with the exception of declaring a dividend, the consideration of the accounts, balance sheets and reports of the Directors and Auditors, the re-appointment of the retiring Auditors and the fixing of the remuneration of the Auditors.

37 Chairman of general meetings

The chairman of the board of Directors or, in his absence, the deputy chairman (if any) or, in his absence, some other Director nominated by the Directors shall preside as chairman at every general meeting of the Company. If at any general meeting none of such persons shall be present

within 15 minutes after the time appointed for the holding of the meeting and willing to act, the Directors present shall elect one of their number to be chairman of the meeting and, if there is only one Director present and willing to act, he shall be chairman. If at any meeting no Director is willing to act as chairman or if no Director is present within 15 minutes after the time appointed for holding the meeting, the Shareholders present (in person or by proxy or by representative) and entitled to vote shall choose one of the Shareholders (including his proxy or its duly authorised representative) personally present to be chairman of the meeting.

38 Directors' and Auditors' right to attend general meetings

A Director shall be entitled, notwithstanding that he is not a Shareholder, to attend and speak at any general meeting and at any separate meeting of the Shareholders of any class of shares in the Company. The Auditors shall be entitled to attend any general meeting and to be heard on any part of the business of the meeting that concerns them as the Auditors.

39 Adjournment of general meetings

The chairman, with the consent of a meeting at which a quorum is present, may (and if so directed by the meeting, shall) adjourn the meeting from time to time (or sine die) and from place to place, but no business shall be transacted at any adjourned meeting other than business that might properly have been transacted at the meeting had the adjournment not taken place. Where a meeting is adjourned sine die, the time and place for the adjourned meeting shall be fixed by the Directors. When a meeting is adjourned for 14 days or more or sine die, at least seven Clear Days' notice shall be given specifying the time and meeting and the general nature of the business to be transacted. Except as aforesaid it shall not be necessary to give any notice of an adjourned meeting.

40 Determination of resolutions

At any general meeting, a resolution put to the vote of the meeting shall be decided on a show of hands unless before, or on the declaration of the result of, the show of hands, a poll is duly demanded. Unless a poll is so demanded, a declaration by the chairman that a resolution has been carried or carried unanimously, or by a particular majority, or lost, or not carried by a particular majority, and an entry to that effect in the minutes of the meeting shall be conclusive evidence of the fact without proof of the number or proportion of the votes recorded in favour of or against the resolution. The demand for a poll may be withdrawn before the poll is taken but only with the consent of the chairman, and a demand so withdrawn shall not be taken to have invalidated the result of a show of hands declared before the demand was made.

41 Entitlement to demand poll

Subject to the provisions of the Companies Act, a poll may be demanded:

- 41.1 by the chairman of the meeting;
- 41.2 by at least one Shareholder present (in person or by proxy) having the right to vote at the meeting;
or
- 41.3 by any Shareholder or Shareholders present (in person or by proxy) representing not less than one-tenth of the total voting rights of all the Shareholders having the right to vote at the meeting.

42 Taking of a poll

- 42.1 Except as provided in Article 42.2, a poll shall be taken in such manner as the chairman directs and he may appoint scrutineers (who need not be Shareholders) and fix a time and place for declaring the result of the poll. The result of the poll shall be deemed to be the resolution of the meeting at which the poll was demanded.

- 42.2 A poll demanded on the election of a chairman or on a question of adjournment shall be taken immediately. A poll demanded on any other question shall be taken either immediately or at such time (not being more than 30 days after the poll is demanded) and place as the chairman of the meeting may direct. The demand for a poll shall not prevent the continuance of a meeting for the transaction of any business other than the question on which the poll was demanded. If a poll is demanded before the declaration of the result of a show of hands and the demand is duly withdrawn, the meeting shall continue as if the demand had not been made.
- 42.3 No notice need be given of a poll not taken immediately if the time and place at which it is to be taken are announced at the meeting at which it is demanded. In any other case at least seven Clear Days' notice shall be given specifying the time and place at which the poll is to be taken.

43 Votes of Shareholders

- 43.1 Votes may be given either personally or by proxy. Subject to any rights or restrictions for the time being attached to any class or classes of shares:
- 43.1.1 on a show of hands, every Shareholder, who is present in person or by proxy, shall have one vote and the holder(s) of Subscriber Shares present in person or by proxy shall have one vote in respect of all of the Subscriber Shares in issue;
- 43.1.2 on a poll, every Shareholder present in person or by proxy shall have one vote for every share of which he is the Shareholder and every holder of a Subscriber Share present in person or by proxy shall have one vote in respect of his holding of Subscriber Shares;
- 43.1.3 on a poll of all the Shareholders of shares in a Fund, where there is more than one class of shares in existence in that Fund, the voting rights of such Shareholders may at the discretion of the Directors be adjusted in such manner, determined by the Directors, so as to reflect the most recently calculated price at which the shares of each of the classes in question may be repurchased by the Company;
- 43.1.4 a Shareholder or Shareholders who hold a fraction of a share may not exercise any voting rights, whether on a show of hands or on a poll, in respect of such fraction of a share.

44 Written Resolutions

A resolution in writing may be passed in the following manner:

- a) If executed by or on behalf of each Shareholder who would have been entitled to vote on it if it had been proposed at a meeting at which he was present shall be as effectual as if it had been passed at a general meeting duly convened and held and may consist of several instruments in the like form, each executed by or on behalf of one or more Shareholders. In the case of a corporation, a resolution in writing may be signed on its behalf by a director or the secretary thereof or by its duly appointed attorney or duly authorised representative; or
- b) If executed in accordance with Section 194 of the Companies Act.

45 Chairman's casting vote

Where there is an equality of votes, whether on a show of hands or on a poll, the chairman of the meeting at which the show of hands takes place or at which the poll is demanded shall be entitled to a casting vote in addition to any other vote he may have.

46 Voting by joint Shareholders

Where there are joint Shareholders of a share, the vote of the senior who tenders a vote, whether in person or by proxy, in respect of such share shall be accepted to the exclusion of the votes of the other joint Shareholders and for this purpose seniority shall be determined by the order in which the names of the Shareholders stand in the Register in respect of the share.

47 Voting by incapacitated Shareholders

A member of unsound mind, or in respect of whom an order has been made by any court having jurisdiction (whether in the State or elsewhere) in matters concerning mental disorder, may vote, whether on a show of hands or on a poll, by his committee, receiver, guardian or other person appointed by that court and any such committee, receiver, guardian or other person may vote by proxy on a show of hands or on a poll. Evidence to the satisfaction of the Directors of the authority of the person claiming to exercise the right to vote shall be deposited at the Office or at such other place as is specified in accordance with these Articles for the deposit of instruments of proxy by such time as the Directors may determine before the time appointed for holding the meeting or adjourned meeting at which the right to vote is to be exercised and in default the right to vote shall not be exercisable.

48 Restriction of voting rights

- 48.1 If at any time the Directors shall determine that a Specified Event (as defined in Article 48.5) shall have occurred in relation to any share or shares, the Directors may serve a notice to such effect on the Shareholder or Shareholders thereof. On the service of any such notice (in these Articles referred to as a "restriction notice"), no Shareholder or Shareholders of the share or shares specified in such restriction notice shall be entitled, for so long as such restriction notice shall remain in force, to attend or vote at any general meeting, either personally or by proxy.
- 48.2 A restriction notice shall be cancelled by the Directors as soon as reasonably practicable, but in any event not later than forty-eight hours, after the Shareholder or Shareholders concerned shall have remedied the default by virtue of which the Specified Event shall have occurred. A restriction notice shall automatically cease to have effect in respect of any share transferred on registration of the relevant transfer provided that a restriction notice shall not cease to have effect in respect of any transfer where no change in the beneficial ownership of the share shall occur and for this purpose it shall be assumed that no such change has occurred where a transfer form in respect of the share is presented for registration having been stamped at a reduced rate of stamp duty by virtue of the transferor or transferee claiming to be entitled to such reduced rate as a result of the transfer being one where no beneficial interest passes.
- 48.3 The Directors shall cause a notation to be made in the Register against the name of any Shareholder or Shareholders in respect of whom a restriction notice shall have been served indicating the number of shares specified in such restriction notice and shall cause such notation to be deleted on cancellation or cesser of such restriction notice.
- 48.4 Any determination of the Directors and any notice served by them pursuant to the provisions of this Article shall be conclusive as against the Shareholder or Shareholders of any share and the validity of any notice served by the Directors in pursuance of this Article shall not be questioned by any person.
- 48.5 For the purpose of these Articles the expression "Specified Event" in relation to any share shall mean the failure by the Shareholder thereof or any of the Shareholders thereof to comply, to the satisfaction of the Directors, with all or any of the terms of Article 7 in respect of any notice or notices given to him or any of them thereunder.

49 Time for objection to voting

No objection shall be raised to the qualification of any voter except at the meeting or adjourned meeting at which the vote objected to is tendered and every vote not disallowed at such meeting shall be valid. Any such objection made in due time shall be referred to the chairman of the meeting whose decision shall be final and conclusive.

50 Appointment of proxy

Every Shareholder entitled to attend and vote at a general meeting may appoint a proxy to attend, speak and vote on his behalf. The instrument appointing a proxy shall be in writing in any usual form or in any other form that the Directors may approve and shall be executed by or on behalf of the Shareholder. The signature on such instrument need not be witnessed. A body corporate may execute a form of proxy under its common seal or under the hand of a duly authorised officer thereof. A proxy need not be a Shareholder.

51 Bodies corporate acting by representatives at meetings

Any body corporate that is a Shareholder may by resolution of its directors or other governing body authorise such person as it thinks fit to act as its representative at any meeting of the Company or of any class of Shareholders of the Company and the person so authorised shall be entitled to exercise the same powers on behalf of the body corporate that he represents as that body corporate could exercise if it were an individual Shareholder.

52 Deposit of proxy instruments

The instrument appointing a proxy and any authority under which it is executed or a copy, certified notarially or in some other way approved by the Directors, shall be deposited at the Office or (at the option of the Shareholder) at such other place or places (if any) as may be specified for that purpose in or by way of note to the notice convening the meeting or adjourned meeting at such time as may be determined by the Directors before the time appointed for the holding of the meeting or adjourned meeting or (in the case of a poll taken otherwise than at or on the same day as the meeting or adjourned meeting) for the taking of the poll at which it is to be used, and in default shall not be treated as valid. Provided that an instrument of proxy relating to more than one meeting (including any adjournment thereof) having once been so delivered for the purposes of any meeting shall not require to be delivered again for the purposes of any subsequent meeting to which it relates.

53 Effect of proxy instruments

Deposit of an instrument of proxy in respect of a meeting or adjourned meeting shall not preclude a Shareholder from attending and voting at the meeting or at any adjournment thereof. The instrument appointing a proxy shall be valid, unless the contrary is stated therein, as well for any adjournment of the meeting as for the meeting to which it relates.

54 Effect of revocation of proxy or of authorisation

- 54.1 A vote given or poll demanded in accordance with the terms of an instrument of proxy or a resolution authorising a representative to act on behalf of a body corporate shall be valid notwithstanding the death or insanity of the principal, or the revocation of the instrument of proxy or of the authority under which the instrument of proxy was executed or of the resolution authorising the representative to act or transfer of the share in respect of which the instrument of proxy or the authorisation of the representative to act was given, provided that no intimation in writing of such death, insanity, revocation or transfer shall have been received by the Company at the Office at least one hour before the commencement of the meeting or adjourned meeting at which the instrument of proxy is used or at which the representative acts.
- 54.2 The Directors may send, at the expense of the Company, by post or otherwise, to the Shareholders instruments of proxy (with or without stamped envelopes for their return) for use at any general meeting or at any class meeting, either in blank or nominating any one or more of the Directors or any other persons in the alternative. If for the purpose of any meeting invitations to appoint as proxy a person or one of a number of persons specified in the invitations are issued at the expense of the Company, such invitations shall be issued to all (and not to some only) of the Shareholders entitled to be sent a notice of the meeting and to vote thereat by proxy.

55 Class Meetings

Except as otherwise provided in these Articles, the provisions of Articles 31 to 54 shall apply mutatis mutandis to class meetings and meetings of Shareholders of shares in a Fund as they apply to general meetings.

PART X - DIRECTORS

56 Number of Directors

Unless otherwise determined by the Company in general meeting, the number of Directors shall not be less than two.

57 Share qualification

A Director shall not be required to hold any shares in the Company.

58 Ordinary remuneration of Directors

Unless otherwise determined from time to time by the Company in general meeting, the ordinary remuneration of each Director shall be determined from time to time by resolution of the Directors.

59 Special remuneration of Directors

Any Director who is appointed as an executive director (including for this purpose the office of chairman or deputy chairman) or who serves on any committee, or who otherwise performs services that in the opinion of the Directors are outside the scope of the ordinary duties of a Director, may be paid such extra remuneration by way of fees, commission or otherwise as the Directors may determine.

60 Expenses of Directors

The Directors may be paid all travelling, hotel and other out-of-pocket expenses properly incurred by them in connection with their attendance at meetings of the Directors or committees established by the Directors or general meetings or separate meetings of the Shareholders of any class of shares of the Company or otherwise in connection with the discharge of their duties.

61 Alternate Directors

61.1 Any Director may appoint by writing under his hand any person (including another Director) to be his alternate, provided always that no such appointment of a person other than a Director as an alternate shall be operative unless and until such appointment shall have been approved by the Competent Authority. Any such authority may be sent by delivery, post, cable, telegram, telex, telefax, electronic mail or any other means of communication approved by the Directors and may bear a printed or facsimile signature of the Director giving such authority.

61.2 An alternate Director shall be entitled to receive notices of all meetings of the Directors and of all meetings of committees established by the Directors of which his appointor is a member, to attend and vote at any such meeting at which the Director appointing him is not personally present and in the absence of his appointor to exercise all the powers, rights, duties and authorities of his appointor as a Director (other than the right to appoint an alternate hereunder).

61.3 Except as otherwise provided in these Articles, an alternate Director shall be deemed for all purposes to be a Director and shall alone be responsible for his own acts and defaults and he shall not be deemed to be the agent of the Director appointing him. The remuneration of any such alternate Director shall be payable out of the remuneration paid to the Director appointing him and shall consist of such portion of the remuneration of the Director as shall be agreed between the alternate and the Director appointing him.

- 61.4 A Director may revoke at any time the appointment of any alternate appointed by him. If a Director shall die or cease to hold the office of Director, the appointment of his alternate shall thereon cease and determine, but if a Director retires by rotation or otherwise but is reappointed or deemed to have been reappointed at the meeting at which he retires, any appointment of an alternate Director made by him that was in force immediately prior to his retirement shall continue after his reappointment.
- 61.5 Any appointment or revocation by a Director under this Article shall be effected by notice in writing given under his hand to the Secretary or deposited at the Office or in any other manner approved by the Directors.

PART XI - POWERS OF DIRECTORS

62 Directors' powers

- 62.1 Subject to the provisions of the Companies Act, the Regulations, the Central Bank UCITS Regulations, Section 1 of this Constitution and these Articles and to any directions by the Shareholders given by ordinary resolution, not being inconsistent with these Articles, with the Companies Act or with the Regulations, the business of the Company shall be managed by the Directors who may do all such acts and things and exercise all the powers of the Company as are not by the Companies Act, the Regulations, the Central Bank UCITS Regulations or by these Articles required to be done or exercised by the Company in general meeting. Without prejudice to the generality of the foregoing, the Directors may exercise all powers of the Company in relation to the investment of the Assets in accordance with item 19 of Appendix II.
- 62.2 No alteration of the Constitution and no such direction shall invalidate any prior act of the Directors that would have been valid if that alteration had not been made or that direction had not been given. The powers given by this Article shall not be limited by any special power given to the Directors by these Articles and a meeting of Directors at which a quorum is present may exercise all powers exercisable by the Directors.

63 Power to delegate

Without prejudice to the generality of the last preceding Article, the Directors may delegate any of their powers to any committee comprising at least one Director. Any such delegation may be made subject to any conditions that the Directors may impose, and either collaterally with or to the exclusion of their own powers and may be revoked. Subject to any such conditions, the proceedings of a committee with two or more members shall be governed by the provisions of these Articles regulating the proceedings of Directors so far as they are capable of applying.

64 Appointment of attorneys/agents/delegates

- 64.1 The Directors, from time to time and at any time by power of attorney under seal or otherwise, may appoint any company, firm or person or fluctuating body of persons, whether nominated directly or indirectly by the Directors, to be the attorney or agent or delegate of the Company for such purposes and with such powers, authorities and discretions (not exceeding those vested in or exercisable by the Directors under these Articles) and for such period and subject to such conditions as they may think fit. Any such power of attorney may contain such provisions for the protection of persons dealing with any such appointee as the Directors may think fit, may contain indemnities in favour of any attorney and may authorise any such attorney to sub-delegate all or any of the powers, authorities and discretions vested in him.
- 64.2 The Directors may appoint any person, firm or corporation which is qualified to act as manager of a UCITS pursuant to the Regulations and which has been approved in advance by the Competent Authority to act as manager of the Company, and may entrust to and confer on the manager so appointed any of the powers exercisable by them as Directors, on such terms and conditions

including the right to remuneration payable by the Company and with such restrictions as they think fit and either collaterally with or to the exclusion of their own powers. The appointment of a new or replacement manager shall be subject to the prior approval by the Competent Authority and any such new or replacement manager must be authorised to act as manager of a UCITS pursuant to the Regulations.

- 64.3 Without prejudice to the generality of the foregoing, the Directors may in accordance with the requirements of the Competent Authority appoint an investment manager and/or investment adviser, and an Administrator and/or other similar entity to manage and/or advise on the investment of the Assets and the administration of the Company, on such terms and conditions as the Directors may deem fit. The remuneration and expenses of such appointees may be charged to the Company as disclosed in the Prospectus.
- 64.4 Notwithstanding the generality of 64.1 above, the Directors may appoint an agent for the purposes of exercising their power to allot relevant securities in accordance with the provisions of Article 4.
- 64.5 Without prejudice to the generality of the foregoing, the Directors shall appoint a Depositary to all of the Assets (including cash) of the Company in accordance with the provisions of items 20-23 of Appendix II.
- 64.6 Any dealings (including, but not limited to, dealing in shares of the Company) by any person referred to in this Article will be subject to such rules and conditions as may be laid down by the Competent Authority from time to time.

65 Borrowing powers

Subject to the Regulations, the Directors may exercise all the powers of the Company to borrow or raise money and to transfer, mortgage, pledge or charge its undertaking, property and assets (both present and future), and uncalled capital or any part thereof and to issue securities, whether outright or as collateral security for any debt, liability or obligation of the Company provided that all such borrowings shall be within the limits and conditions laid down by the Competent Authority.

66 Execution of negotiable instruments

All cheques, promissory notes, drafts, bills of exchange and other negotiable instruments and all receipts for money paid to the Company shall be signed, drawn, accepted, endorsed or otherwise executed, as the case may be, by such person or persons and in such manner as the Directors shall determine from time to time.

PART XII - APPOINTMENT AND RETIREMENT OF DIRECTORS

67 No retirement by rotation

No Director will be required to retire by rotation.

68 Eligibility for appointment

To be eligible for appointment as a Director at a general meeting of the Company, a person must be recommended by the Directors or, not less than six nor more than thirty Clear Days before the date appointed for the meeting, notice executed by a Shareholder qualified to vote at the meeting must have been given to the Company of the intention to propose that person for appointment stating the particulars that would be required, if he were so appointed, to be included in the Company's register of Directors together with notice executed by that person of his willingness to be appointed.

69 No retirement on account of age

No Director shall be required to retire on account of age.

70 Appointment of additional Directors

- 70.1 Subject as aforesaid, the Company by ordinary resolution may appoint a person to be a Director either to fill a vacancy or as an additional Director.
- 70.2 The Directors may appoint a person who is willing to act to be a Director, either to fill a vacancy or as an additional Director, provided that the appointment does not cause the number of Directors to exceed any number as fixed by or in accordance with these Articles as the maximum number of Directors. Any Director so appointed shall not be required to retire at any subsequent annual general meeting of the Company.
- 70.3 The continuing Directors may act notwithstanding any vacancy in their body, provided that if the number of the Directors is reduced below two, the remaining Director shall appoint immediately an additional Director or additional Directors to make up a quorum or shall convene a general meeting of the Company for the purpose of making such appointment or appointments. If, in such circumstances, there be no Director or Directors able or willing to act then any one Shareholder may summon a general meeting for the purpose of appointing Directors. Any additional Director so appointed shall not be required to retire at any subsequent annual general meeting of the Company.

PART XIII - DISQUALIFICATION AND REMOVAL OF DIRECTORS

71 Disqualification of Directors

The office of a Director shall be vacated ipso facto if:

- 71.1 he ceases to be a Director by virtue of any provision of the Companies Act or he becomes prohibited by law from being a Director;
- 71.2 he becomes bankrupt or makes any arrangement or composition with his creditors generally;
- 71.3 in the opinion of a majority of his co-Directors, he becomes incapable by reason of mental disorder of discharging his duties as a Director;
- 71.4 he resigns his office by notice in writing to the Company signed by him and delivered to the Office;
- 71.5 he is convicted of an indictable offence, unless the Directors otherwise determine;
- 71.6 he shall have been absent for more than six consecutive months without permission of the Directors from meetings of the Directors held during that period and his alternate Director (if any) shall not have attended any such meeting in his place during such period, and the Directors pass a resolution that by reason of such absence he has vacated office;
- 71.7 he is required in writing by all his co-Directors to resign; or
- 71.8 the Competent Authority requires him to resign.

72 Removal of Directors

The Company, by ordinary resolution of which extended notice has been given in accordance with the provisions of the Companies Act, may remove any Director notwithstanding anything in these Articles or in any agreement between the Company and such Director and may, if thought fit, by ordinary resolution appoint another Director in his stead. Nothing in this Article shall be taken as depriving a person removed hereunder of compensation or damages payable to him in respect of the termination of his appointment as Director or of any appointment terminating with that of the Director.

PART XIV - DIRECTORS' INTERESTS

73 Directors' interests

73.1 Subject to the provisions of the Companies Act, and provided that he has disclosed to the Directors the nature and extent of any material interest of his, a Director notwithstanding his office:

73.1.1 may be a party to, or otherwise interested in, any transaction or arrangement with the Company or any subsidiary or associated company thereof or in which the Company or any subsidiary or associated company thereof is otherwise interested;

73.1.2 may be a director or other officer of, or employed by, or a party to any transaction or arrangement with, or otherwise interested in, any body corporate promoted by the Company or in which the Company or any subsidiary or associated company thereof is otherwise interested; and

73.1.3 shall not be accountable, by reason of his office, to the Company for any benefit that he derives from any such office or employment or from any such transaction or arrangement or from any interest in any such body corporate and no such transaction or arrangement shall be liable to be avoided on the ground of any such interest or benefit.

73.2 No Director or intending Director shall be disqualified by his office from contracting with the Company either as vendor, purchaser or otherwise, nor shall any such contract or any contract or arrangement entered into by or on behalf of the other company in which any Director shall be in any way interested be avoided nor shall any Director so contracting or being so interested be liable to account to the Company for any profit realised by any such contract or arrangement by reason of such Director holding that office or of the fiduciary relationship thereby established. The nature of a Director's interest must be declared by him at the meeting of the Directors at which the question of entering into the contract or arrangement is first taken into consideration, or if the Director was not at the date of that meeting interested in the proposed contract or arrangement at the next meeting of the Directors held after he became so interested, and in a case where the Director becomes interested in a contract or arrangement after it is made, at the first meeting of the Directors held after he becomes so interested.

73.3 A copy of every declaration made and notice given under this Article shall be entered within three days after the making or giving thereof in a book kept for this purpose. Such book shall be open for inspection without charge by any Director, Secretary, Auditor or Shareholder at the Office and shall be produced at every general meeting of the Company and at any meeting of the Directors if any Director so requests in sufficient time to enable the book to be available at the meeting.

73.4 For the purposes of this Article:

73.4.1 a general notice given to the Directors that a Director is to be regarded as having an interest of the nature and extent specified in the notice in any transaction or arrangement in which a specified person or class of persons is interested shall be deemed to be a disclosure that the Director has an interest in any such transaction of the nature and extent so specified; and

73.4.2 an interest of which a Director has no knowledge and of which it is unreasonable to expect him to have knowledge shall not be treated as an interest of his.

74 Restriction on Directors' voting

74.1 Except as otherwise provided by these Articles, a Director shall not vote at a meeting of the Directors or any committee established by the Directors on any resolution concerning a matter in which he has, directly or indirectly, an interest that is material (other than an interest arising by virtue of his interest in shares or debentures or other securities or otherwise in or through the

Company) or a duty that conflicts or may conflict with the interests of the Company. A Director shall not be counted in the quorum present at a meeting in relation to any such resolution on which he is not entitled to vote.

74.2 A Director shall be entitled to vote (and be counted in the quorum) in respect of any resolutions concerning any of the following matters, namely:

74.2.1 the giving of any security, guarantee or indemnity to him in respect of money lent by him to the Company or any of its subsidiary or associated companies or obligations incurred by him at the request of or for the benefit of the Company or any of its subsidiary or associated companies;

74.2.2 the giving of any security, guarantee or indemnity to a third party in respect of a debt or obligation of the Company or any of its subsidiary or associated companies for which he himself has assumed responsibility in whole or in part and whether alone or jointly with others under a guarantee or indemnity or by the giving of security;

74.2.3 any proposal concerning any offer of shares or debentures or other securities of or by the Company or any of its subsidiary or associated companies for subscription, purchase or exchange in which offer he is or is to be interested as a participant in the underwriting or sub-underwriting thereof; or

74.2.4 any proposal concerning any other company in which he is interested, directly or indirectly and whether as an officer or shareholder or otherwise howsoever.

74.3 Where proposals are under consideration concerning the appointment (including fixing or varying the terms of appointment) of two or more Directors to offices or employments with the Company or any company in which the Company is interested, such proposals may be divided and considered in relation to each Director separately and in such case each of the Directors concerned (if not debarred from voting under Article 74.2.4) shall be entitled to vote (and be counted in the quorum) in respect of each resolution except that concerning his own appointment.

74.4 If a question arises at a meeting of the Directors or of any committee established by the Directors as to the materiality of a Director's interest or as to the right of any Director to vote and such question is not resolved by his voluntarily agreeing to abstain from voting, such question may be referred, before the conclusion of the meeting, to the chairman of the meeting and his ruling in relation to any Director other than himself shall be final and conclusive.

74.5 The Company by ordinary resolution may suspend or relax the provisions of this Article to any extent or ratify any transaction not duly authorised by reason of a contravention of this Article.

PART XV - PROCEEDINGS OF DIRECTORS

75 Convening and regulation of Directors' meetings

75.1 Subject to the provisions of these Articles, the Directors may regulate their proceedings as they think fit. A Director may, and the Secretary at the request of a Director shall, call a meeting of the Directors. Any Director may waive notice of any meeting and any such waiver may be retrospective. If the Directors so resolve, it shall not be necessary to give notice of a meeting of Directors to any Director or alternate Director who, being a resident of the State, is for the time being absent from the State.

75.2 Notice of a meeting of the Directors shall be deemed to be duly given to a Director if it is given to him personally or by word of mouth or sent in writing by delivery, post, cable, telegram, telex, telefax, electronic mail or any other means of communication approved by the Directors to him at his last known address or any other address given by him to the Company for this purpose.

75.3 All meetings of the Directors must be held in Ireland.

76 Quorum for Directors' meetings

- 76.1 The quorum for the transaction of the business of the Directors may be fixed by the Directors and, unless so fixed at any other number, shall be two. A person who holds office only as an alternate Director shall, if his appointer is not present, be counted in the quorum but notwithstanding that such person may act as alternate Director for more than one Director, he shall not count as more than one for the purposes of determining whether a quorum is present.
- 76.2 The continuing Directors or a sole Director may act notwithstanding any vacancies in their number but if the number of Directors is less than the number fixed as the quorum, they may act only for the purpose of filling vacancies or for calling a general meeting.

77 Voting at Directors' meetings

- 77.1 Questions arising at any meeting of Directors shall be decided by a majority of votes. Where there is an equality of votes, the chairman of the meeting shall have a casting vote.
- 77.2 Subject as hereinafter provided, each Director present and voting shall have one vote and in addition to his own vote shall be entitled to one vote in respect of each other Director not present at the meeting who shall have authorised him in respect of such meeting to vote for such other Director in his absence. Any such authority may relate generally to all meetings of the Directors or to any specified meeting or meetings and must be in writing and may be sent by delivery, post, cable, telegram, telex, telefax, electronic mail or any other means of communication approved by the Directors and may bear a printed or facsimile signature of the Director giving such authority. The authority must be delivered to the Secretary for filing prior to or must be produced at the first meeting at which a vote is to be cast pursuant thereto provided that no Director shall be entitled to any vote at a meeting on behalf of another Director pursuant to this Article if the other Director shall have appointed an alternate Director and that alternate Director is present at the meeting at which the Director proposes to vote pursuant to this Article.

78 Telecommunication meetings

Any Director or alternate Director may participate in a meeting of the Directors or any committee established by the Directors by means of conference telephone or other telecommunications equipment by means of which all persons participating in the meeting can hear each other speak. Any such meeting shall be deemed to have been convened in the place from which the conference telephone call or similar telecommunication is initiated, which shall always be in the State. Any such telephonic or other electronic participation in a meeting shall constitute presence in person at the meeting, and be counted for the purposes of determining whether a quorum is present at the meeting.

79 Chairman of the board of Directors

Subject to any appointment to the office of chairman made pursuant to these Articles, the Directors may elect a chairman of their meetings and determine the period for which he is to hold office, but if no such chairman is elected or if at any meeting the chairman is unwilling to act or is not present within five minutes after the time appointed for holding the same the Directors present may choose one of their number to be chairman of the meeting.

80 Validity of acts of Directors

All acts done by any meeting of the Directors or of a committee established by the Directors or by any person acting as a Director, notwithstanding that it be afterwards discovered that there was some defect in the appointment of any such Director or person acting as aforesaid, or that they or any of them were disqualified from holding office or had vacated office, shall be as valid as if every such person had been duly appointed and was qualified and had continued to be a Director and had been entitled to vote.

81 Directors' resolutions or other documents in writing

A resolution in writing (in electronic form or otherwise) signed (whether by electronic signature, advanced electronic signature or otherwise approved by the Directors) by all the Directors for the time being entitled to receive notice of a meeting of Directors or of a committee established by the Directors and to vote thereat shall be as valid and effectual as a resolution passed at a meeting of the Directors duly convened and may consist of several documents in the like form each signed by one or more of the Directors, and for the purposes of the foregoing, signature by any alternative Director shall be as effective as the signature of the Director by whom he is appointed. A resolution in writing shall be deemed to have been signed in the country or place where the last signatory to sign the resolution in writing (in electronic form or otherwise) executes such resolution.

PART XVI - THE SECRETARY

82 Appointment of Secretary

The Secretary shall be appointed by the Directors for such term, at such remuneration and on such conditions as they may think fit and any Secretary so appointed may be removed by them. Anything required or authorised by the Companies Act or these Articles to be done by, or given to, the Secretary may be done by or given to any assistant or acting secretary readily available and capable of acting by or to any officer of the Company authorised generally or specially in that behalf by the Directors, if the office is vacant or there is for any other reason no Secretary readily available and capable of acting Provided that any provision of the Companies Act or these Articles requiring or authorising a thing to be done by or to a Director and the Secretary shall not be satisfied by its being done by or to the same person acting both as a Director and as, or in the place of, the Secretary.

PART XVII - THE SEAL

83 Use of Seal

The Directors shall ensure that the Seal (including any official securities seal kept pursuant to the Companies Act) shall be used only by the authority of the Directors or of a committee authorised by the Directors.

84 Seal for use abroad

The Company may exercise the powers conferred by the Companies Act with regard to having an official seal for use abroad and such powers shall be vested in the Directors.

85 Signature of sealed instruments

Every instrument to which the Seal shall be affixed shall be signed by a Director and shall also be signed by the Secretary or by a second Director or by some other person appointed by the Directors for the purpose (which may include the Depositary) except that as regards any debentures or other securities of the Company the Directors may determine by resolution that such signatures or either of them shall be dispensed with, or be printed thereon or affixed thereto by some method or system of mechanical signature provided that in any such case the document to be sealed shall have been approved for sealing by the Secretary or by the registrar of the Company or by the Auditors or by some other person appointed by the Directors for this purpose in writing (and, for the avoidance of doubt, it is hereby declared that it shall be sufficient for approval to be given and/or evidenced either in such manner (if any) as may be approved by or on behalf of the Directors or by having such documents initialled before sealing or presented for sealing accompanied by a list thereof that has been initialled).

PART XVIII - DIVIDENDS AND RESERVES

86 Declaration of dividends

86.1 The Directors at such times as they think fit may declare such dividends on any class of shares as appear to the Directors to be justified by the profits of the relevant Fund being;

86.1.1 the net income (being the accumulated revenue (consisting of all revenue accrued including interest and dividends)) less expenses; and/or

86.1.2 realised and unrealised capital gains on the disposal/valuation of Investments and other funds less realised and unrealised accumulated capital losses of the relevant Fund; and/or

86.1.3 as disclosed in the Supplement for the relevant Fund.

Notwithstanding the above, the Directors at such times as they think fit and in accordance with the requirements of the Competent Authority may also declare such dividends on any class of shares out of the capital of the relevant Fund.

86.2 The Directors may satisfy any dividend due to Shareholders of the shares in whole or in part by distributing to them in specie any of the Assets of the relevant Fund, and in particular any Investments to which the relevant Fund is entitled. A Shareholder may require the Directors, instead of transferring any assets in specie to him, to arrange for a sale of the Assets and for payment to the Shareholder of the net proceeds of same.

86.3 Shares of any class may at the discretion of the Directors be issued on the basis that any dividends declared in respect of those shares shall be paid by the Company into an account in the name of the Depository for the account of the Shareholders of that Class of Shares. The amount standing to the credit of this account shall not be an asset of the Fund or the Company and will be immediately transferred from the aforementioned account to the account of the Company.

86.4 Shares of any class may at the discretion of the Directors be issued on the basis that any dividends declared in respect of those shares will be reinvested and form part of the assets of the relevant Fund and will be applied when calculating the Subscription Price and the Repurchase Price as part of the proportion of the relevant Fund that is attributable to the Shareholders of that class of shares.

86.5 Shares of any class may at the discretion of the Directors be issued on the basis that no dividends will be declared in respect of those shares and that any profits available for distribution will form part of the assets of the relevant Fund and will be applied when calculating the Subscription Price and the Repurchase Price as part of the proportion of the relevant Fund that is attributable to the Shareholders of that class of shares.

86.6 No dividends shall be payable to the holder(s) of Subscriber Shares.

87 Eligibility for dividends

If any share is issued on terms providing that it shall rank for dividend as from or after a particular date or to a particular extent, such share shall rank for dividend accordingly.

88 Deduction from Dividend

88.1 The Directors may deduct from any dividend or other money payable to any Shareholder on or in respect of a share all sums of money (if any) presently payable by him to the Company in relation to the shares of the Company.

88.2 Where the Company is required to pay any taxation as a consequence of making any dividend payment to a Shareholder the Directors may deduct from the payment to be made to the relevant Shareholder(s) who is or is deemed to be or is acting on behalf of an Irish Resident or a person

Ordinarily Resident in Ireland, an amount equal to the taxation attributable to the relevant payment(s) and pay such amount to the appropriate tax authority.

89 Unclaimed dividends

All unclaimed dividends on shares may be invested or otherwise made use of by the Directors for the benefit of the relevant Fund until claimed. No dividend shall bear interest against the Company. The payment by the Directors of any unclaimed dividend or other money payable on or in respect of a share into a separate account shall not constitute the Company a trustee in respect thereof and any dividend unclaimed after a period of six years from the date of declaration of such dividend shall not be a claim admissible to proof against the Company for the purposes of a winding up and shall be forfeited and revert to the relevant Fund.

90 Currency of Dividend

Any dividend or other money payable on or in respect of a share shall be expressed and payment shall be made in the currency in which the relevant class of shares is designated or in such other currency as the Directors may determine either generally or in relation to a particular class of shares or in any specific case.

91 Payment of Dividend

Any dividend or other money payable on or in respect of a share may be paid by electronic or telegraphic transfer to the account nominated by the Shareholder or person entitled thereto, and in the case of joint Shareholders to that one whose name stands first on the Register in respect of their joint holding or may if required be paid by cheque or warrant sent through the post to the registered address of the Shareholder or the person entitled thereto. Every such payment by cheque or warrant shall be made payable to the order of the person to whom it is sent, and payment of the cheque or warrant shall be a good discharge to the Company and, in the case of payment by electronic or telegraphic transfer, every such payment shall be a good discharge to the Company. Every such cheque or warrant or, where applicable, transfer shall be sent or, as the case may be, made at the risk and cost of the person entitled to the money represented thereby or, as the case may be, payment remitted.

92 Joint Shareholders

If several persons are registered as joint holders of any share, any one of them may give effectual receipts for any dividend or other money payable on or in respect of the share.

PART XIX - ACCOUNTS

93 Accounts

93.1 The Directors shall cause to be kept adequate accounts in accordance with the requirements of the Companies Act and UCITS Requirements.

93.2 The books of account shall be kept at the Office or, subject to the provisions of the Companies Act, at such other place as the Directors think fit and shall be open at all reasonable times to the inspection of the Directors.

93.3 In accordance with the provisions of the Companies Act, the Directors shall cause to be prepared and to be laid before the annual general meeting of the Company from time to time such profit and loss accounts, balance sheets and reports as are required by the Companies Act to be prepared and laid before such meeting.

93.4 A copy of every balance sheet (including every document required by law to be annexed thereto) that is to be laid before the annual general meeting of the Company together with a copy of the Directors' report and Auditors' report shall be sent, not less than twenty-one Clear Days before the

date of the annual general meeting, to every person entitled under the provisions of the Companies Act to receive them PROVIDED THAT this Article shall not require a copy of these documents to be sent to more than one of the joint Shareholders of any shares. Copies of the annual report shall be made and/or sent to all Shareholders by the Company in accordance with the requirements of the Competent Authority.

- 93.5 The Company shall prepare an un-audited half-yearly report for the first six months of each financial year. Such report shall be in a form acceptable to the Competent Authority and shall contain the information required under the Regulations.
- 93.6 Copies of the half-yearly report shall be made available and/or sent to Shareholders in accordance with the requirements at the Competent Authority.
- 93.7 The Company shall provide the Competent Authority with all reports and information to which it is entitled under the Regulations.
- 93.8 Auditors shall be appointed and their duties regulated in accordance with the Companies Act.

PART XX - NOTICES

94 Notices in writing

Any notice to be given, served or delivered pursuant to these Articles shall be in writing.

95 Service of notices

- 95.1 A notice or document (including a share certificate) to be given, served or delivered in pursuance of these Articles may be given to, served on or delivered to any Shareholder by the Company:
 - 95.1.1 by handing same to him or his authorised agent;
 - 95.1.2 by leaving the same at his registered address;
 - 95.1.3 by sending the same by post in a pre-paid cover addressed to him at his registered address; or
 - 95.1.4 where permitted by law, by transmitting the same by facsimile or otherwise electronically.
- 95.2 Where a notice or document is given, served or delivered pursuant to Articles 95.1.1 or 95.1.2, the giving, service or delivery thereof shall be deemed to have been effected at the time the same was handed to the Shareholder or his authorised agent, or left at his registered address (as the case may be).
- 95.3 Where a notice or document is given, served or delivered pursuant to Article 95.1.3, the giving, service or delivery thereof shall be deemed to have been effected at the expiration of forty-eight hours after the cover containing it was posted. In proving service or delivery it shall be sufficient to prove that such cover was properly addressed, stamped and posted.
- 95.4 Where a notice or document is given, served or delivered pursuant to Article 95.1.4, the giving, service or delivery thereof shall be deemed to have been effected at the time of transmission provided in the case of notice sent by facsimile the correct number is received on the transmission report.
- 95.5 Every legal personal representative, committee, receiver, curator bonis or other legal curator, assignee in bankruptcy or liquidator of a Shareholder shall be bound by a notice given as aforesaid if sent to the last registered address of such Shareholder, notwithstanding that the Company may have notice of the death, lunacy, bankruptcy, liquidation or disability of such Shareholder.

95.6 Without prejudice to the provisions of Articles 95.1.1 and 95.1.2, if at any time by reason of the suspension or curtailment of postal services within the State, the Company is unable effectively to convene a general meeting by notice sent through the post, a general meeting may be convened by a notice advertised on the same day in at least one leading national daily newspaper published in the State and such notice shall be deemed to have been duly served on all Shareholders entitled thereto at noon on the day on which the said advertisement or advertisements shall appear. In any such case the Company shall send confirmatory copies of the notice through the post to those Shareholders whose registered addresses are outside the State (if or to the extent that in the opinion of the Directors it is practical so to do) or are in areas of the State unaffected by such suspension or curtailment of postal services. If at least ninety-six hours prior to the time appointed for the holding of the meeting the posting of notices to Shareholders has become practical in the opinion of the Directors, the Directors shall send immediately confirmatory copies of the notice by post to such Shareholders. The accidental omission to give any such confirmatory copy of a notice of a meeting to, or the non-receipt of any such confirmatory copy by, any person entitled to receive the same shall not invalidate the proceedings at the meeting.

95.7 Notwithstanding anything contained in this Article the Company shall not be obliged to take account of or make any investigations as to the existence of any suspension or curtailment of postal services within or in relation to all or any part of any jurisdiction or other area other than the State.

96 Service of notice on joint Shareholders

A notice may be given by the Company to the joint Shareholders of a share by giving the notice to the joint Shareholder whose name stands first in the Register in respect of the share and notice so given shall be sufficient notice to all the joint Shareholders.

97 Service of notice on transfer or transmission of shares

97.1 Every person who becomes entitled to a share shall, before his name is entered in the Register in respect of the share, be bound by any notice in respect of that share that has been duly given to a person from whom he derives his title provided that the provisions of this Article shall not apply to any notice served under Article 7 unless, under the provisions of Article 7, it is a notice that continues to have effect notwithstanding the registration of a transfer of the shares to which it relates.

97.2 Without prejudice to the provisions of these Articles allowing a meeting to be convened by newspaper advertisement, a notice may be given by the Company to the persons entitled to a share in consequence of the death or bankruptcy of a Shareholder by sending or delivering it, in any manner authorised by these Articles for the giving of notice to a Shareholder, addressed to them at the address, if any, supplied by them for that purpose. Until such an address has been supplied, a notice may be given in any manner in which it might have been given if the death or bankruptcy had not occurred.

98 Signature to notices

The signature to any notice to be given by the Company may be written or printed.

99 Deemed receipt of notices

A Shareholder present, either in person or by proxy, at any meeting of the Company or the Shareholders of any class of shares in the Company shall be deemed to have received notice of the meeting and, where requisite, of the purposes for which it was called.

PART XXI - WINDING UP

100 Distribution on winding up

- 100.1 Subject to Article 108 hereof and the provisions of the Companies Act, if the Company shall be wound up the liquidator shall apply the assets of each Fund in such manner and order as he thinks fit in satisfaction of creditors' claims relating to that Fund.
- 100.2 The assets available for distribution among the Shareholders shall be applied as follows: first the proportion of the assets in a Fund attributable to each class of share shall be distributed to the Shareholders of shares in the relevant class in the proportion that the number of shares held by each Shareholder bears to the total number of shares relating to each such class of shares in issue as at the date of commencement to wind up, secondly, in the payment to the holder(s) of the Subscriber Shares of sums up to the consideration paid thereon out of the assets of the Company not attributable to any class of share. In the event that there are insufficient assets to enable such payment in full to be made, no recourse shall be had to the assets of the Company attributable to each class of shares; and thirdly, any balance then remaining and not attributable to any of the classes of shares shall be apportioned pro-rata as between the classes of shares based on the Net Asset Value attributable to each class of shares as at the date of commencement to wind up and the amount so apportioned to a class shall be distributed to Shareholders pro-rata to the number of shares in that class of shares held by them.
- 100.3 A Fund may be wound up pursuant to section 1046 of the Companies Act and in such event, the provisions of Articles 100 and 101 shall apply mutatis mutandis in respect of that Fund.

101 Distribution in specie

If the Company shall be wound up (whether the liquidation is voluntary, under supervision or by the court) the liquidator may, with the authority of a special resolution of the relevant Shareholders and any other sanction required by the Companies Act, divide among the Shareholders of shares of any class or classes within a Fund in specie the whole or any part of the Assets of the Company relating to that Fund, and whether or not the Assets shall consist of property of a single kind, and may for such purposes set such value as he deems fair on any one or more class or classes of property, and may determine how such division shall be carried out as between the Shareholders of shares or the Shareholders of different classes of shares as the case may be. The liquidator may, with the like authority, vest any part of the Assets in trustees on such trusts for the benefit of Shareholders as the liquidator, with the like authority, shall think fit, and the liquidation of the Company may be closed and the Company dissolved, but so that no Shareholder shall be compelled to accept any Assets in respect of which there is a liability. A Shareholder may require the liquidator instead of transferring any asset in specie to him/her, to arrange for a sale of the Assets and for payment to the Shareholder of the net proceeds of same with the cost of any such sale to be borne by the relevant Shareholder.

PART XXII - MISCELLANEOUS

102 Minutes of meetings

The Directors shall cause minutes to be made of the following matters, namely:

- 102.1 of all appointments of officers and committees made by the Directors and of their salary or remuneration;
- 102.2 of the names of Directors present at every meeting of the Directors and of the names of any Directors and of all other members thereof present at every meeting of any committee established by the Directors; and

102.3 of all resolutions and proceedings of all meetings of the Company and of the Shareholders of any class or classes of shares in the Company and of the Directors and of committees established by the Directors. Any such minute as aforesaid, if purporting to be signed by the chairman of the meeting at which the proceedings were had, or by the chairman of the next succeeding meeting, shall be receivable as prima facie evidence of the matters stated in such minute without any further proof.

103 Inspection and secrecy

The Directors shall determine from time to time whether and to what extent and at what times and places and under what conditions or regulations the accounts and books and records of the Company or any of them shall be open to the inspection of Shareholders, not being Directors, and no Shareholder (not being a Director) shall have any right of inspecting any account or book or record of the Company except as conferred by the Companies Act or authorised by the Directors or by the Company in general meeting. No Shareholder shall be entitled to require discovery of or any information respecting any detail of the Company's trading, or any matter that is or may be in the nature of a trade secret, mystery of trade, or secret process that may relate to the conduct of the business of the Company and that in the opinion of the Directors it would be inexpedient in the interests of the Shareholders to communicate to the public.

104 Destruction of records

The Company shall be entitled to destroy all instruments of transfer that have been registered at any time after the expiration of six years from the date of registration thereof, all notifications of change of address at any time after the expiration of two years from the date of recording thereof and all share certificates and dividend mandates that have been cancelled or ceased to have effect at any time after the expiration of one year from the date of such cancellation or cessation. It shall be presumed conclusively in favour of the Company that every entry in the Register purporting to have been made on the basis of an instrument of transfer or other document so destroyed was duly and properly made and every instrument duly and properly registered and every share certificate so destroyed was a valid and effective document duly and properly cancelled and every other document hereinbefore mentioned so destroyed was a valid and effective document in accordance with the recorded particulars thereof in the books or records of the Company. Provided always that:

104.1 the provision aforesaid shall apply only to the destruction of a document in good faith and without notice of any claim (regardless of the parties thereto) to which the document might be relevant;

104.2 nothing herein contained shall be construed as imposing on the Company any liability in respect of the destruction of any document earlier than as aforesaid or in any other circumstances that would not attach to the Company in the absence of this Article; and

104.3 references herein to the destruction of any document include references to the disposal thereof in any manner.

105 Untraced Shareholders

105.1 The Company shall be entitled to sell at the best price reasonably obtainable any share of a Shareholder or any share to which a person is entitled by transmission if and provided that:

105.1.1 for a period of twelve years no cheque or warrant sent by the Company through the post in a pre-paid letter addressed to the Shareholder or to the person entitled by transmission to the share at his address on the Register or the last known address given by the Shareholder or the person entitled by transmission to which cheques and warrants are to be sent has been cashed and no communication has been received by the Company from the Shareholder or the person entitled by transmission (provided that during such twelve year period at least three dividends shall have become payable in respect of such share);

105.1.2 at the expiration of the said period of twelve years by advertisement in a national daily newspaper published in the State and in a newspaper circulating in the area in which the address referred to in Article 105.1.1 is located, the Company has given notice of its intention to sell such share; and

105.1.3 during the further period of three months after the date of the advertisement and prior to the exercise of the power of sale the Company has not received any communication from the Shareholder or person entitled by transmission.

105.2 To give effect to any such sale the Company may appoint any person to execute as transferor an instrument of transfer of such share and such instrument of transfer shall be as effective as if it had been executed by the Shareholder or the person entitled by the transmission to such share. The transferee shall be entered in the Register as the Shareholder of the shares comprised in any such transfer and he shall not be bound to see to the application of the purchase money nor shall his title to the shares be affected by any irregularity in or invalidity of the proceedings in reference to the sale.

105.3 The Company shall account to the relevant Fund or, if the Fund is no longer in existence, to such persons as the Directors may determine for the net proceeds of such sale.

106 Indemnity and Insurance

106.1 Subject to the provisions of and insofar as may be permitted by the Companies Act and the Regulations, each Director (which for the purposes of this Article shall include each former Director), Secretary and other officer or other servant for the time being of the Company and any trustee for the time being and such person's heirs, administrators, executors and personal representatives respectively, shall be indemnified and secured harmless out of the assets and the profits of the Company from and against (otherwise than in the case of negligence, default, breach of duty or breach of trust), and it shall be the duty of the Directors out of the assets and the profits of the Company to pay, all actions, costs, debts, claims, demands, suits, proceedings, judgements, decrees, charges, losses, damages, expenses, liabilities or obligations of any kind that he or his heirs, administrators, executors or personal representatives shall or may incur or sustain by reason of any contract entered into or any act done, concurred in, or omitted to be done by virtue of his being or having been a Director, Secretary or officer for which relief is granted to him by the court, and the amount for which such indemnity is provided shall immediately attach as a lien on the property of the Company and have priority over all other claims.

106.2 The rights of indemnification herein provided shall be severable, shall not affect any other rights to which any Director or officer may now or hereafter be entitled, shall continue as to a person who has ceased to be such a Director or officer and shall ensure to the benefit of the heirs, executors and administrators of such Director or officer.

106.3 The Company may make advances of expenses incurred in the defence of any claim, action, suit or proceedings against any person whom the Company is obliged to indemnify pursuant to this Article.

106.4 The Directors shall have the power to purchase and maintain for the benefit of any persons who are or were at any time Directors or officers of the Company insurance against any liability incurred by such persons in respect of any act or omission in the actual or purported execution and/or discharge of their duties and/or in the exercise or purported exercise of their powers and/or otherwise in relation to their duties, powers or offices in relation to the Company, and the Directors shall be entitled to vote and be counted in the quorum in respect of any resolution concerning the purchase of such insurance.

106.5 Subject to the provisions of and insofar as may be permitted by the Companies Act and the Regulations and subject always to the requirements of the Competent Authority, any manager, the Administrator, the Depositary, any investment manager, any sub-investment manager or investment adviser, any distributor and any other delegate appointed by the Directors shall be

entitled to such indemnity out of the assets of the Company on such terms and subject to such conditions and exceptions and with such entitlement to have recourse to the assets of the Company with a view to meeting and discharging the cost thereof as shall be provided under their respective contracts of engagement.

- 106.6 The Company, any manager, any investment manager, any sub-investment manager or investment adviser, the Administrator, the Depositary, and any distributor shall be entitled to rely absolutely on any declaration received from a Shareholder or his agent as to residence or otherwise of such Shareholder and shall not incur liability in respect of any action taken or thing suffered by any of them in good faith in reliance on any paper or document believed to be genuine and to have been sealed or signed by the proper parties nor be in any way liable for any forged or unauthorised signature on or any common seal affixed to any such document or for acting on or giving effect to any such forged or unauthorised signature or common seal but shall be entitled though not bound to require the signature of any person to be verified by a banker, broker or other responsible person or otherwise authenticated to its or their satisfaction.
- 106.7 None of the Company, any manager, any investment manager, any sub-investment manager, any investment adviser, the Administrator, the Depositary, or any distributor shall incur any liability to the Shareholders for doing or (as the case may be) failing to do any act or thing that by reason of any provision of any present or future law or regulation made pursuant thereto, or of any decree, order or judgement of any court, or by reason of any request announcement or similar action (whether of binding legal effect or not) that may be taken or made by any person or body acting with or purporting to exercise the authority of any government (whether legal or otherwise) either they or any of them shall be directed or requested to do or perform or to forbear from doing or performing. If for any reason it becomes impossible or impracticable to carry out any of the provisions of these Articles, none of the Company, any manager, any investment manager, any sub-investment manager, any investment adviser, the Administrator, the Depositary or any distributor shall be under any liability therefor or thereby.

107 Overriding provisions

In the event of there being any conflict between the provisions of these Articles and the Companies Act or Regulations, the Companies Act or Regulations shall prevail. The prior approval of the Competent Authority shall be required to any amendment to these Articles.

108 Segregation of Liability

- 108.1 Notwithstanding any statutory provision or rule of law to the contrary, any liability incurred on behalf of or attributable to any Fund shall be discharged solely out of the assets of that Fund, and no Director, receiver, examiner, liquidator, provisional liquidator or other person shall apply nor be obliged to apply the assets of any such Fund in satisfaction of any liability incurred on behalf of or attributable to any other Fund.
- 108.2 The assets allocated to a Fund shall be applied solely in respect of the shares of such Fund and no Shareholder relating to such Fund shall have any claim or right to any asset allocated to any other Fund.
- 108.3 Any asset or sum recovered by the Company by any means whatsoever or wheresoever shall, after the deduction or payment of any costs of recovery, be applied to the Fund affected. In the event that assets attributable to a Fund are taken in execution of a liability not attributable to that Fund, and in so far as such assets or compensation in respect hereof cannot otherwise be restored to that Fund, the Directors with the consent of the Depositary, shall certify or cause to be certified, the value of the assets lost to the Fund affected and transfer or pay from the assets of the Fund or Funds to which the liability was attributable, in priority to all other claims against such Fund or Funds, assets or sums sufficient to restore to the Fund affected, the value of the assets or sums lost to it.

- 108.4 The Company may sue and be sued in respect of a particular Fund and may exercise the same rights of set-off, if any, as between its Funds as apply at law in respect of companies and the property of a Fund is subject to orders of the Irish courts as it would have been if the Fund were a separate legal person.
- 108.5 In any proceedings brought by any Shareholder of a particular Fund, any liability of the Company to such Shareholder in respect of such proceeding shall only be settled out of the assets of the Fund corresponding to such shares without recourse in respect of such liability or any allocation of such liability to any other Fund of the Company.
- 108.6 Nothing in this Article 108 shall prevent the application of any enactment or rule of law that would require the application of the assets of any Fund in discharge of some or all of the liabilities of any other Fund on the grounds of fraud or misrepresentation and, in particular, by reason of the application of sections 185 and 604 of the Companies Act.

109 Restriction on modifications to Constitution

No modification shall be made to the Constitution of the Company that would result in the Company ceasing to be authorised under the Regulations or without the prior approval of the Competent Authority.

110 Change of Name

The Directors are entitled to change the name of the Company or any of its Funds (subject to the prior approval of the Competent Authority). The Directors shall, subject to the prior approval of the Competent Authority, change the name of the Company, or any of its Funds, which includes in its name any name proprietary to any third party (including the Manager or a Benchmark Index provider) if the conditions under which the third party (whether contained in an agreement with the Company or otherwise) permits the use of such name include a requirement to change the name of the Fund under certain circumstances, and such circumstances occur. For the avoidance of doubt, in the event that Invesco Investment Management Limited ceases to be Manager of the Company, and a company within the Promoter's group is not appointed in its place as the Manager of the Company, then, prior to or immediately following such termination becoming effective, the Directors may arrange to convene an extraordinary general meeting to propose that the name of the Company be changed to a name which will not reflect any involvement on the part of Invesco Investment Management Limited (or any of its Affiliates) with the Company. At any such extraordinary general meeting called to change the name, those Shareholders who (being individuals) are present in person or by proxy or (being corporations) are present by proxy or by a duly authorised representative and entitled to vote and who vote on a poll in favour of the resolution proposed to change the name of the Company shall collectively have such total number of votes as is one or more than the number of votes which are required to be cast on such a poll for the said special resolution to be carried. Such a change of name shall take place in accordance with the provisions of the Companies Act and the requirements of the Competent Authority.

APPENDIX II

ISSUE OF SHARES

1 Terms and conditions of issue of shares

- 1.1 Prior to the issue of any class of shares, the Directors shall determine the rights and restrictions attaching thereto including the Fund to which they relate, the designated currency of the shares and the fees and expenses to be borne by the class of shares (which shall be disclosed in the Prospectus). The Directors may in relation to a Fund (subject to prior notification to the Competent Authority) create more than one class of shares to participate in the relevant Fund in accordance with the requirements of the Competent Authority, which classes may be denominated by the Directors in the same or different currencies. Where a class of shares is denominated in a currency other than the base currency of the relevant Fund, the Directors shall at the time of creation of such class determine if such class of shares shall be constituted as a Hedged Currency Share Class or an Unhedged Currency Share Class. Notwithstanding anything contained in these Articles, the costs and gains/losses of any hedging transactions relating to a Hedged Currency Share Class shall accrue solely to the Shareholders of shares in such class and shall not form part of the assets of the Fund or constitute a liability of the relevant Fund. Any currency hedging transaction relating to a Hedged Currency Share Class shall be valued in accordance with the provisions of Appendix III and shall be clearly attributable to the specific Hedged Currency Share Class. None of the Hedged Currency Share Classes shall be leveraged as a result of such a currency hedging transaction.
- 1.2 The name of each Fund, including the names set out below, may be amended by the Directors and any such change of name shall not require the approval of the Shareholders in the relevant Fund and will be in accordance with the requirements of the Competent Authority:
- Additional Funds may be added in the future subject to the prior approval of the Competent Authority.
- 1.3 The Directors may issue voting shares and non-voting shares. The non-voting shares carry no right to notice of, attend or vote at general meetings of the Company or any Fund. In accordance with the requirements of the Competent Authority, the decision to subscribe for any class of shares in respect of which voting rights are restricted shall be made solely by the investor and any Shareholder of non-voting shares shall have the right to switch their holding to voting shares (in accordance with item 9 of Appendix II) without including any fee or charge in respect of such exchange.
- 1.4 Subject as hereinafter provided and subject to any regulations made or conditions imposed by the Competent Authority pursuant to the Regulations, the initial issue of shares by the Company shall be subject to the receipt by the Company or its authorised agents of:
- 1.4.1 an application in such form as the Directors may from time to time determine;
- 1.4.2 such information and declarations as the Directors may from time to time require; and
- 1.4.3 payment for shares in such manner and within such usual time limits as the Company from time to time may specify.
- 1.5 Payment for shares shall be made by the Settlement Date in such currency and at such time, place and manner and to such person, on behalf of the Company, as the Directors may from time to time determine.
- 1.6 The Company may (at the option of the Directors) satisfy any application for the allotment of shares by procuring the transfer to the applicant of fully-paid shares, the effective date of such transfer to be the relevant Dealing Day. In any such case, references in these Articles to allotting shares shall, where appropriate, be taken as references to procuring the transfer of shares.

- 1.7 The allotment of shares may take place notwithstanding that the information or declarations referred to in item 1.4.2 above have not been received by the Company or its authorised agent, provided that the application referred to in item 1.4.1 above has been received, and provided further that if the said information or declarations have not been received within one Month (or such other period as the Directors may determine) after the Dealing Day on which such shares are allotted, the Directors shall be entitled to cancel the allotment. If so cancelled, the relevant application money (if any) shall be returnable to the applicant at his risk (together with such additional amount, if any, or after deducting such amount, if any, as the Directors may in their absolute discretion think fit, any such amount so deducted being retained by the Company for its own benefit) and until returned, may be made use of by the Company for its own benefit.
- 1.8 If payment (or such application form, information or declaration referred to at 1.4.2 above) is not received in full for any shares by the relevant Settlement Date or in the event of non-clearance of funds, the Directors or its authorised delegate shall be entitled to: (a) cancel the allotment of shares and the applicant may be required to compensate the Company; or (b) charge the applicant interest at a reasonable rate; or (c) require the applicant to compensate the Company for any loss suffered by it and such compensation may be, for example, deducted from dividends payable to the applicant in relation to the shares allotted to him; or (d) treat the relevant money as payment in respect of an application for shares made by the Dealing Deadline for the Dealing Day next following receipt of such money or of cleared funds. In addition, the Directors, or its authorised delegate, shall be entitled to sell all or part of the relevant applicant's holdings of shares in the relevant fund of the Company in order to compensate the Company.
- 1.9 Applications for shares that are received by or on behalf of the Company on or prior to the Dealing Deadline for a Dealing Day shall, except in exceptional circumstances where the Directors determine otherwise and provided they are received by the relevant Valuation Point, be dealt with on that Dealing Day. Such applications as are received after the Dealing Deadline for a Dealing Day may be carried forward to the next following Dealing Deadline unless the Directors, in exceptional circumstances, otherwise determine to accept one or more applications received after the Dealing Deadline for processing on that Dealing Day provided such application(s) have been received prior to the Valuation Point for the particular Dealing Day (specifically before the close of business in the relevant market that closes first on the relevant Dealing Day). If requested, the Directors may, in their absolute discretion and subject to the prior approval of the Depositary, agree to designate additional Dealing Days and Valuation Points for the purchase of shares relating to any Fund, which will be open to, and notified in advance to, all Shareholders. No interest shall be paid in respect of any application received in advance of a Dealing Day or carried forward to a subsequent Dealing Day.
- 1.10 The Directors reserve the right to reject, in whole or in part, any application for shares without assigning any reason therefore. In such event, the subscription monies or any balance thereof will, subject to applicable law, be returned to the applicant, without interest, expenses or compensation, in such manner as the Directors may determine at the applicant's cost and risk. In particular, if the Directors determine that it would be detrimental for existing Shareholders to accept an application for shares in cash or in specie, representing more than 5 per cent of the Net Asset Value of a Fund, the Directors may decide to defer all or part of the application for shares in excess of 5 per cent until the next Dealing Day or postpone the application and, in consultation with the relevant investor, either require such investor to stagger the proposed application over an agreed period of time, or, at the investor's expense, establish an investment account outside the structure of the Company in which to invest the investor's subscription money. Such investment account will be used to acquire the Shares over a pre-agreed time schedule. If the Directors decide to defer or postpone all or part of the application for shares in excess of 5 per cent, the applicants shall be informed prior to the deferral taking place. The investor shall be liable for any transaction costs or reasonable expense incurred in connection with operating and monitoring any such account. Any applicable preliminary/subscription charge shall be deducted from the subscription monies before the investment of the subscription monies commences.

- 1.11 Applications for the issue of shares will be irrevocable unless the Directors, or a delegate, otherwise agree.
- 1.12 Shares may be issued in dematerialised (or uncertificated) form and the Funds may apply for admission for clearing and settlement through a clearing system. To facilitate this arrangement, the Depositary (or its delegate) will maintain a Depot Account at the relevant clearing and settlement system. Settlement of subscriptions for shares by an authorised participant will take place on a delivery versus payment (“DVP”) basis at the relevant clearing and settlement system. An authorised participant will arrange for delivery of the subscription monies to the Depot Account maintained by the Depositary (or its delegate) who, in turn, will arrange for the simultaneous delivery to the authorised participant of the shares for which it has subscribed.

2 Subscription price of shares

- 2.1 During the Initial Offer Period in relation to a Fund, the Subscription Price per share of the relevant class shall be the price as determined by the Directors. After the Initial Offer Period, the Subscription Price shall be the Net Asset Value per share of the relevant class.
- 2.2 Where shares are issued at the Net Asset Value per share, the Subscription Price per share of the relevant class shall be ascertained by:
- 2.2.1 determining that proportion of the Net Asset Value of the relevant Fund that is attributable to the relevant class of shares as at the Valuation Point for the relevant Dealing Day;
 - 2.2.2 where the class of shares is a Hedged Currency Share Class, adding to or deducting from (as the case may be) the sum calculated in accordance with 2.2.1 above the costs and gains/losses of any currency hedging transactions effected in respect of that class;
 - 2.2.3 making such other adjustments for fees, dividend accumulation or distribution of income and expenses, liabilities or assets attributable to each such class and any other factors differentiating the classes of the relevant Fund as determined by the Directors;
 - 2.2.4 dividing the resulting sum by the number of shares of the relevant class in issue or deemed to be in issue in the relevant Fund at the Valuation Point for the relevant Dealing Day;
 - 2.2.5 rounding the resulting amount so determined to such number of decimal places of the unit of the currency in which such share is designated (“unit” for such purposes being the smallest fraction of the relevant currency that is legal tender in the country of issue of that currency) as the Directors may determine; and
 - 2.2.6 the Directors reserve the right to impose an anti-dilution levy on a transaction basis in the case of net subscriptions as a percentage adjustment (to be communicated to the Administrator) on the value of the relevant subscription calculated for the purposes of determining a Subscription Price to reflect the impact of market spreads, duties and charges and other dealing costs relating to the acquisition or disposal of assets and to preserve the value of, the underlying assets of the relevant Fund where they consider such a provision to be in the best interests of a Fund. Such amount will be added to the price at which Shares will be issued in the case of net subscription requests. Any such sum will be paid into the account of the relevant Fund.
- 2.3 For the purposes of this item 2, shares that have been allotted shall be deemed to be in issue from the close of business on the Dealing Day on which they are allotted and shares that have been repurchased shall be deemed to cease to be in issue at the close of business on the Dealing Day of such repurchase.

3 Allotment of shares for non-cash consideration

The Directors may, subject to the provisions of the Companies Act, in their absolute discretion allot shares against the vesting in the Depositary on behalf of the Company of any Investments and in connection therewith the following provisions shall apply:

- 3.1 the Investments vested in the Depositary on behalf of the Company must qualify as suitable Investments for the relevant Fund in accordance with the investment objective, policies and restrictions determined by the Directors for the relevant Fund;
- 3.2 the number of shares to be allotted shall not exceed that number that would have fallen to be issued for cash on the basis that the amount of such cash was an amount equal to the value as at the relevant Valuation Point for the relevant Dealing Day of the Investments to be vested in the Depositary on behalf of the Company, as determined in accordance with article 3.4 below;
- 3.3 the Directors may provide that the whole or any part of the Duties and Charges arising in connection with the vesting of the Investments in the Depositary on behalf of the Company shall be paid by the Company or by the person to whom the shares are to be issued or partly by the Company and partly by such person;
- 3.4 the value of the Investments to be vested in the Depositary on behalf of the Company shall be determined by the Directors on such basis as they shall decide, so long as such value does not exceed the highest amount that would be obtained if the Investments were valued in accordance with Appendix III hereof;
- 3.5 in the case of the initial issue of shares of any class, the Directors shall determine the number of shares of the relevant class to be allotted against the vesting in the Depositary on behalf of the Company of any Investments;
- 3.6 prior to the Directors exercising their discretion under this item, the Depositary must be satisfied that the terms of any such allotment are not such as would be likely to result in any material prejudice to existing Shareholders;
- 3.7 assets received as non-cash consideration for shares shall be vested in the Depositary; and
- 3.8 any such allotment of shares for non-cash consideration shall be at the risk and cost of the applicant.

4 Preliminary/subscription charge

The Directors may require any person to whom shares of any class are to be allotted to pay to the Company or any of its appointees or as any of them may direct, for its or their absolute use and benefit, a preliminary/subscription charge in respect of each share to be allotted of such amount as may be determined by the Directors but not exceeding in respect of each share an amount equal to 5 per cent of the Subscription Price per Share of the relevant class being allotted. The Directors may on any Dealing Day differentiate between applicants as to the amount of the preliminary/subscription charge required to be paid to the Company, or its appointees or as they may direct and as to the amount of preliminary/subscription charge to be levied on each class of share (subject to the maximum aforesaid).

5 No shares allotted when calculation of Net Asset Value suspended

The Directors may in their absolute discretion determine that no shares shall be allotted or issued during any period when the determination of the Net Asset Value of the relevant Fund is suspended pursuant to item 16 below except those for which applications have previously been received and accepted by the Company or its authorised agent. The Directors will notify investors applying for shares of such suspension at the time of application. Any application for shares that is

not withdrawn shall, subject to the provisions of these Articles, be dealt with on the first Dealing Day after the suspension is lifted.

6 Issue of fractions of shares

Where payments or other consideration received by or on behalf of the Company in respect of the issue or allotment of shares are not an exact multiple of the Subscription Price for those shares, a fraction of a share may be allotted to the investor who shall be registered as the Shareholder of such a fraction provided that any holding of shares is a multiple of 1/10000 part of a share or such other fractional amount as the Directors may determine from time to time. Rights, entitlements and benefits of a Shareholder of a share under the Articles are granted to a Shareholder of a fraction of a share in proportion to the fraction of a share held by him and, except where the context otherwise requires or is otherwise provided herein, reference in these Articles to "share" shall include a fraction of a share. Subscription monies representing less than 1/10000 of a Share may be retained by the Company to defray administration costs. Notwithstanding anything contained in these Articles, the Shareholder of a fraction of a share may not exercise any voting rights in respect of such share.

7 Minimum Initial Investment Amount

The Directors shall decline to issue shares of any class to satisfy any initial application unless the amount in value of the shares to which an application relates equals or exceeds the Minimum Initial Investment Amount or its equivalent in another currency. Thereafter, Shareholders may make additional subscriptions for shares having a value at the then current Subscription Price of not less than the Minimum Additional Investment Amount or its equivalent in another currency. The Directors reserve the right, at any time, to waive any requirements in relation to the Minimum Initial Investment Amount, the Minimum Additional Investment Amount and/or the Minimum Shareholding as and when they determine at their reasonable discretion.

FUNDS

8 Funds

8.1 All consideration, other than the preliminary/subscription charge (if any) payable to the Company or its appointees or as any of them may determine pursuant to item 4 of this Appendix, received by or on behalf of the Company for the allotment or issue of shares of a Fund, or if there is more than one class of shares in a particular Fund, of all such classes, together with all Investments in which such consideration is invested or reinvested, all income, earnings, profits and proceeds thereof shall be segregated and kept separate from all other money of the Company and such assets and money shall be referred to as a "Fund", there being one Fund in respect of each class (or all such classes, as the case may be) of shares and to which the following provisions shall apply:

8.1.1 For each Fund, the separate books and records in which all transactions relating to the relevant Fund shall be recorded and, in particular, the proceeds from the allotment and issue of shares of each class in the Fund, the Investments and the liabilities and income and expenditure attributable thereto shall be applied or charged to such Fund subject to the provisions of this item 8;

8.1.2 Any Asset derived from any other Asset(s) (whether cash or otherwise) comprised in any Fund shall be applied in the books and records of the Company to the same Fund as the Asset from which it was derived and any increase or diminution in the value of such an Asset shall be applied to the relevant Fund.

8.1.3 In the event that there are any Assets that the Directors do not consider are attributable to a particular Fund or Funds, the Directors shall, with the approval of the Depositary, allocate such Assets to and among any one or more of the Funds in such manner and on such basis as they, in their discretion, deem fair and equitable; and the Directors shall have the power to and may at any time and from time to time, with the approval of the Depositary, vary the basis in relation to Assets previously allocated.

- 8.1.4 No shares will be issued on terms that entitle the Shareholder of any Fund to participate in the Assets other than the Assets (if any) of the Fund relating to such shares. If the proceeds of the Assets of the relevant Fund are not sufficient to fund the full repurchase proceeds payable to each Shareholder for the relevant Fund, the proceeds of the relevant Fund will, subject to the terms for the relevant Fund, be distributed equally among each Shareholder of the relevant Fund pro rata to the amount paid on the shares held by each Shareholder. If the realised net assets of any Fund are insufficient to pay any amounts due on the relevant shares in full in accordance with the terms of the relevant Fund, the relevant Shareholders of that Fund will have no further right of payment in respect of such shares or any claim against the Company, any other Fund or any Assets of the Company in respect of any shortfall.
- 8.1.5 Each Fund shall be charged with the liabilities, expenses, costs, charges or reserves of the Company in respect of or attributable to that Fund.
- 8.1.6 In the event that any Asset attributable to a Fund is taken in execution of a liability not attributable to that Fund, the provisions of section 1406(6) of the Companies Act shall apply.

8.2 Subject as otherwise provided herein, the Assets held in each Fund shall be applied solely in respect of the shares of the class (or classes as the case may be) to which such Fund appertains.

9 Fund exchanges

9.1 Subject to the provisions of the Companies Act, the Regulations, these Articles and as hereinafter provided, a Shareholder holding shares in any class of one Fund (the "Original Class") (with the exception of shareholders holding shares on the secondary market) on any Dealing Day shall have the right from time to time to exchange all or any of such shares for shares in another class of the same or another Fund that are being offered at that time (the "New Class") on the following terms, provided that all the criteria for applying for shares in the New Class have been met, by giving notice to the Administrator on behalf of the Company on or prior to the Dealing Deadline for the relevant Valuation Point. The Directors may not be able to exercise this discretion in all circumstances.

The general provisions and procedures relating to repurchases will apply equally to exchanges. All exchanges will be treated as a repurchase of the shares of the Original Class and application of the net proceeds to the purchase of shares of the New Class, based on the then current Subscription Price and Repurchase Price of shares in each Fund.

The number of Shares of the New Class to be issued will be calculated in accordance with the following formula:

$$S = \frac{[Rx(RPxER)] - F}{SP}$$

where

R = the number of shares of the Original Class to be exchanged;

S = the number of shares of the New Class to be issued;

RP = the Repurchase Price per share of the Original Class as at the Valuation Point for the relevant Dealing Day on which the exchange is to be effected;

ER = in the case of an exchange of shares designated in the same currency is 1. In any other case, it is the currency conversion factor determined by the Directors on or about the Valuation Point for the relevant Dealing Day as representing the effective rate of exchange applicable to the transfer of assets relating to the Original and New Classes of shares after adjusting such rate as may be necessary to reflect the effective costs of making such transfer;

SP = the Subscription Price per share of the New Class as at the Valuation Point for the relevant Dealing Day on which the exchange is to be effected; and

F = the fee payable (if any) on the exchange of shares (as set out in item 9.4).

Where there is an exchange of shares, shares of the New Class will be allotted and issued in respect of and in proportion to the shares of the Original Class in the proportion S to R.

- 9.2 The Shareholder shall give to the Company or its authorised agent(s) instructions (hereinafter called an "Exchange Notice") in such form as the Directors may from time to time determine.
- 9.3 The exchange of the shares specified in the Exchange Notice pursuant to this item 9 shall occur on a Dealing Day for the Original Class and the New Class in respect of Exchange Notices received on or prior to the relevant Dealing Deadline for that Dealing Day (or prior to such other time of day as the Directors may determine either generally or in relation to a particular Fund or in any specific case) by the Company or its authorised agent(s) or on such other Dealing Day as the Directors at the request of the Shareholder may agree and a Shareholder's entitlement to shares as recorded in the Register shall be altered accordingly with effect from that Dealing Day.
- 9.4 On any exchange of shares pursuant to this item 9, the Directors may charge a fee, for payment to the Company or any of its appointees or as any of them may direct not exceeding 3 per cent of the Repurchase Price for the total number of shares in the Original Class to be repurchased, calculated as at the relevant Valuation Point for the Dealing Day on which the exchange is effected.
- 9.5 Requests for the exchange of shares as an initial investment in a New Class will only be made if the value of the shares to be exchanged is equal to or exceeds the Minimum Initial Investment Amount for the New Class. The Directors may refuse to give effect to any Exchange Notice if to do so would cause the relevant Shareholder's holding in the Original class to fall below the Minimum Shareholding specified for that Original Class.
- 9.6 Shares in a class may not be exchanged for shares in a different class of the same or another Fund during any period when the calculation of the Net Asset Value of the relevant Funds is suspended by reason of a declaration by the Directors pursuant to item 16 hereof. Applicants will be notified of such suspension at the time of application and any request for the exchange of shares not withdrawn shall, subject to the provisions of these Articles, be dealt with on the first Dealing Day after such suspension is lifted.
- 9.7 The Company may charge an applicant for any costs or expenses incurred in respect of any currency transaction that may be required in respect of an exchange of shares.
- 9.8 The Directors may, at their discretion, refuse to effect an exchange request without giving any reason for such refusal. In addition, restrictions may apply on making exchanges between certain classes as may be set out in the Prospectus.

10 Termination of Funds

- 10.1 Any Fund may be terminated by the Directors, in their sole and absolute discretion, by notice in writing to the Depository in any of the following events:
- 10.1.1 if at any time the Net Asset Value of the relevant Fund shall be less than the Minimum Fund Size of that Fund; or
- 10.1.2 if any Fund shall cease to be authorised or otherwise officially approved by the Competent Authority; or
- 10.1.3 if any law shall be passed or regulatory requirement introduced which renders it illegal or in the opinion of the Directors impracticable or inadvisable or not commercially viable or excessively onerous from a compliance perspective to continue the relevant Fund; or

- 10.1.4 if there is a change in material aspects of the business, or in the economic or political situation relating to a Fund that the Directors consider would have material adverse consequences on the Investments of the Fund;
- 10.1.5 if the Directors have resolved that it is impracticable or inadvisable for a Fund to continue to operate having regard to prevailing market conditions and/or the best interests of the Shareholders; or
- 10.1.6 if the appointment of the investment manager of the Company pursuant to the investment management agreement entered into between the Company and the investment manager is terminated in accordance with the termination provisions stipulated therein.

The decision of the Directors in any of the events specified herein shall be final and binding on all the parties concerned but the Directors shall be under no liability on account of any failure to terminate the relevant Fund pursuant to this item 10 or otherwise.

- 10.2 Any Fund may be terminated by winding up by the Directors, in their sole and absolute discretion, in accordance with the provisions of section 1406(6) of the Companies Act.
- 10.3 In the event of a termination under item 10.1 of this Appendix, the Directors shall give notice of termination of a Fund to the Shareholders of shares in the relevant Fund and by such notice fix the date at which such termination is to take effect, which date shall be for such period after the service of such notice as the Directors shall in their sole and absolute discretion determine.
- 10.4 With effect on and from the date of the relevant notice of termination, no shares of the relevant Fund may be issued, sold or repurchased by the Company unless the Directors otherwise determine.
- 10.5 With effect on and from the date as at which any Fund is to terminate:
 - 10.5.1 no shares of the relevant Fund may be issued or sold by the Company;
 - 10.5.2 the investment manager or sub-investment manager shall, on the instructions of the Directors, realise all the Assets then comprised in the relevant Fund (which realisation shall be carried out and completed in such manner and within such period after the termination of the relevant Fund as the Directors think advisable);
 - 10.5.3 the Depositary shall, on the instructions of the Directors from time to time, distribute to the Shareholders of shares of the relevant Fund in proportion to their respective interests in the relevant Fund all net cash proceeds derived from the realisation of the relevant Fund and available for the purpose of such distribution, provided that the Depositary shall not be bound (except in the case of the final distribution) to distribute any of the money for the time being in its hands the amount of which is insufficient to pay EUR 1 or its equivalent amount in the relevant currency in respect of each share of the relevant Fund and provided also that the Depositary shall be entitled to retain out of any money in its hands as part of the relevant Fund full provision for all costs, charges, expenses, claims and demands incurred, made or apprehended by the Depositary or the Directors in connection with or arising out of the termination of the relevant Fund and out of the money so retained to be indemnified and saved harmless against any such costs, charges, expenses, claims and demands; and
 - 10.5.4 every such distribution referred to above shall be made in such manner as the Directors shall, in their sole and absolute discretion, determine but shall be made only against production of the certificates or warrants relating to the shares of the relevant Fund if issued in respect of which the same is made and on delivery to the Depositary of such form of request for payment as the Depositary shall in its absolute discretion require. All certificates shall in the case of an interim distribution be encased by the Depositary with a memorandum of payments made and in the case of the final distribution shall be

surrendered to the Depositary. Any unclaimed proceeds or other cash held by the Depositary hereunder may at the expiration of twelve months from the date on which the same were payable be paid into court subject to the right of the Depositary to deduct therefrom any expenses it may incur in making such payment.

- 10.6 The Directors shall have the power to propose and implement a reconstruction and/or amalgamation of the Company or any Fund or Funds on such terms and conditions as are approved by the Directors subject to the following conditions namely:

10.6.1 that the prior approval of the Competent Authority has been obtained; and

10.6.2 that the Shareholders of shares in the relevant Fund or Funds have been circulated with particulars of the scheme of reconstruction and/or amalgamation in a form approved by the Directors and a special resolution of the Shareholders of shares in the relevant Fund or Funds has been passed approving the said scheme.

The relevant scheme of reconstruction and/or amalgamation shall take effect on such conditions being satisfied or on such later date as the scheme may provide or as the Directors may determine whereon the terms of such scheme shall be binding on all the Shareholders and the Directors shall have the power to and shall do all such acts and things as may be necessary for the implementation thereof.

RIGHT OF REPURCHASE

11 Shareholders' right to request a repurchase of shares

As the Company is an open-ended investment company, Shareholders shall have the right to request the Company to repurchase their shares in accordance with the provisions of item 12 below.

12 Repurchase mechanism

- 12.1 Subject to the provisions of the Companies Act, the Regulations, these Articles and subject as hereinafter provided, the Company shall, on receipt by it or its authorised agent(s) of a request (which request may, at the Directors' discretion, either generally or in relation to any specific request, be made in writing, by facsimile, by telex or by telephone (in accordance with the procedure set out in the Prospectus) or in such other form (which may include any electronic form or means of communication) as the Directors may, from time to time, determine) by a Shareholder of shares ("the Applicant"), repurchase all or any portion of the shares held by the Applicant at the Repurchase Price, determined in accordance with item 13 hereof, or procure the purchase thereof at not less than the Repurchase Price on the relevant Dealing Day. Such request to repurchase must be accompanied by the duly endorsed certificate or certificates (if any) issued for the shares to which it relates.

PROVIDED THAT:

- 12.1.1 The repurchase of shares pursuant to this item 12 shall be made on a Dealing Day in respect of requests received by the Company or its authorised agent on or prior to the Dealing Deadline for that Dealing Day.
- 12.1.2 Any such request received after the Dealing Deadline for a Dealing Day may be carried forward to the next following Dealing Deadline, except in exceptional circumstances where the Directors may otherwise agree and provided that requests are received before the relevant Valuation Point for the particular Dealing Day (specifically before the close of business in the relevant market that closes first on the relevant Dealing Day).
- 12.1.3 If the determination of the Net Asset Value of the relevant Fund is suspended on any Dealing Day by reason of a declaration by the Directors pursuant to item 16 hereof, an Applicant may withdraw his request to have his shares repurchased pursuant to this item

12. If the request is not so withdrawn, the Company shall be at liberty to repurchase the shares on the Dealing Day next following the end of the suspension.

12.1.4 Subject as aforesaid and to the discretion of the Directors or their authorised delegate, an Applicant shall not be entitled to withdraw a request duly made in accordance with this item 12.

12.1.5 The Company may retain a sufficient portion of the amount payable to the Applicant in respect of the repurchase to pay any taxation payable to the Irish Tax Authorities in respect of the repurchase of the shares.

12.1.6 Any amount payable to the Applicant in connection with the repurchase of shares shall, at the risk and cost of the Applicant, be paid in the same currency as that in which the shares are designated or in such other currency as the Directors shall determine. Any such amount may, at the option of the Directors (but at the risk and cost of the Applicant), be remitted by or on behalf of the Company by electronic or telegraphic transfer to the bank account specified by the Applicant not later than the relevant Settlement Date. In all other instances, any such amount shall be sent by post in the form of a negotiable instrument at the Applicant's risk by or on behalf of the Company to the Applicant not later than the relevant Settlement Date. If the amount to be paid by the Company as aforesaid shall not be expressed in the currency in which the shares that the Company has repurchased were designated, then the rate of exchange between that currency and the currency agreed for payment shall be such rate as the Directors shall consider appropriate. The cost of conversion (if any) shall be debited from the converted payment. The certificate of the Directors as to the conversion rate applicable and as to the cost of conversion shall be conclusive and binding on all persons.

12.1.6 Subject to written instructions from the Applicant to the Company (or its authorised agent) directing otherwise, which the Company (or its authorised agent) may require to be verified or otherwise supported by additional documentation, the Company (or its authorised agent) shall pay the proceeds of repurchase to the Applicant.

12.1.6 If requested, the Directors may, in their absolute discretion and subject to the prior approval of the Depositary, agree to designate additional Dealing Days and Valuation Points for the repurchase of shares relating to any Fund which shall be notified in advance to, and open to, all Shareholders.

12.2 The repurchase of shares under the provisions of this item 12 shall be deemed to be effected immediately after the Valuation Point for the relevant Dealing Day. Shares repurchased in accordance with the provisions of this item 12 shall be deemed to cease to be in issue at the close of business on the Dealing Day on which they are repurchased.

12.3 On the repurchase of a share being effected, the Applicant shall cease to be entitled to any rights in respect thereof (excepting always the right to receive a dividend that has been declared in respect thereof prior to such repurchase being effected) and accordingly his name shall be removed from the Register with respect thereto and the shares shall be treated as cancelled and the amount of issued share capital in respect of such class of shares shall be reduced accordingly.

12.4 Upon a repurchase of shares by an authorised participant, such transaction will take place on a DVP basis at the relevant clearing system. The authorised participant will arrange for the delivery of shares to the Depositary's (or its delegate's) Depot Account who, in turn, will arrange for the simultaneous credit of the redeeming investor's Depot Account with the redemption proceeds.

13 Repurchase price of shares

13.1 The Repurchase Price per share of the relevant class shall be an amount as determined by the Directors on the relevant Dealing Day referred to in item 12.1.1 above by:

13.1.1 determining that proportion of the Net Asset Value of the relevant Fund that is attributable to the relevant class of shares as at the Valuation Point for the relevant Dealing Day;

- 13.1.2 where the class of shares is a Hedged Currency Share Class, adding to or deducting from (as the case may be) the sum calculated in accordance with 13.1.1 above the costs and gains/losses of any currency hedging transaction effected in respect of that class;
 - 13.1.3 making such other adjustments for fees, dividend accumulation or distribution of income and expenses, liabilities or assets attributable to each such class and any other factors differentiating the classes of the relevant Fund as determined by the Directors;
 - 13.1.4 dividing the resulting sum by the number of shares of the relevant class in issue or deemed to be in issue in the relevant Fund at the Valuation Point for the relevant Dealing Day;
 - 13.1.5 rounding the amount so determined to a maximum of such number of decimal places of the unit of the currency of the shares ("unit" for such purposes being the smallest fraction of the relevant currency that is legal tender in the country of issue of that currency) as the Directors may determine; and
 - 13.1.6 the Directors reserve the right to impose an anti-dilution levy on a transaction basis in the case of net redemptions as a percentage adjustment (to be communicated to the Administrator) on the value of the relevant redemption calculated for the purposes of determining a Redemption Price to reflect the impact of market spreads, duties and charges and other dealing costs relating to the acquisition or disposal of assets and to preserve the value of the underlying assets of the relevant Fund of the relevant Fund where they consider such a provision to be in the best interests of a Fund. Such amount will be deducted from the price at which shares will be redeemed in the case of net redemption requests. Any such sum will be paid into the account of the relevant Fund.
- 13.2 The Directors may on any Dealing Day require an Applicant to pay to the Company or any of its appointees or as any of them may direct, for its or their absolute use and benefit, a repurchase charge in respect of each share to be repurchased of not more than 3 per cent of the Repurchase Price of a share of the relevant class prevailing on that Dealing Day. The amount of any such charge may be deducted from the amount to be paid by the Company to the Applicant in respect of the shares to be repurchased. The Directors may on any Dealing Day differentiate between Applicants as to the amount of the repurchase charge required to be paid to the Company, or its appointees or as they may direct and as to the amount of repurchase charge to be levied on each class of share (subject to the maximum aforesaid).
- 13.3 Such portion of the Repurchase Price of any shares repurchased on a Dealing Day (except a Dealing Day that is a record day for the declaration of a dividend) as the Directors in their absolute discretion consider appropriate shall be deemed to be a distribution to the relevant Applicant of the proportion of the undistributed net revenue accrued to the relevant Fund up to such Dealing Day attributable to the shares in respect of which such Repurchase Price is payable.
- 13.4 The Directors may add to the Repurchase Price for any shares an amount in respect of any provision made for a performance fee payable to any investment manager/adviser in respect of the Fund that has not been fully applied.
- 13.5 Where any tax is payable to the Irish Tax Authorities in respect of a repurchase of shares by a Shareholder who is or is deemed to be an Irish Resident or a person Ordinarily Resident in Ireland and or is acting on behalf of such a person, the Repurchase Price shall be reduced by an amount equal to such tax that shall be paid by or on behalf of the Company to the authorities.
- 13.6 If Company is required to deduct, withhold or account for any tax in any jurisdiction, including any penalties and interest thereon the Directors may deduct or arrange for the deduction from the proceeds due to be paid to a Shareholder of a cash amount equal to the liability or, in accordance with the procedures in Article 18.00 hereof, may arrange for the compulsory redemption and cancellation of such number of Shares of such Shareholder as is sufficient after the deduction of any redemption charges to discharge any such liability and the relevant Shareholder shall indemnify and keep indemnified the Company against any loss suffered by it in connection with any obligation or liability to so deduct, withhold or account.

14 Limitations on repurchase

- 14.1 The Directors or their authorised delegate may limit the number of shares of any Fund redeemed on any Dealing Day to shares representing not more than 10 per cent of the Net Asset Value of that Fund on that Dealing Day. In this event, the limitation will apply pro rata, so that all shareholders wishing to redeem their shareholding in that Fund on the relevant Dealing Day will realise the same proportion of their redemption request. Shares not redeemed but that would otherwise have been redeemed, will be carried forward for repurchase on the next Dealing Day and so on to each succeeding Dealing Day until each request has been dealt with in full. If requests for redemptions are carried forward, the Administrator shall inform the shareholders affected.
- 14.2 The Directors may, with the consent of the individual Shareholders, satisfy any request for repurchase of shares by the transfer to those Shareholders of assets of the relevant Fund having a value equal to the Repurchase Price for the shares repurchased. A determination to provide repurchase in specie may be solely at the discretion of the Directors where the redeeming Shareholder requests repurchase of a number of shares that represents 5 per cent or more of the Net Asset Value of the relevant Fund, provided that any such Shareholder requesting the repurchase shall be entitled to request the sale of any asset or assets proposed to be distributed in kind, and the distribution to such Shareholder of the cash proceeds of such sale less the costs of such sale that shall be borne by the relevant Shareholder.
- 14.3 The nature and type of assets to be transferred in specie to each Shareholder shall be determined by the Directors (subject to the approval of the Depositary as to the allocation of assets) on such basis as the Directors in their discretion shall deem equitable and not prejudicial to the interests of the remaining Shareholders in the relevant Fund or class of shares.
- 14.4 Where there is a transfer of Assets pursuant to article 14.2, the Depositary shall transfer to the Applicant his proportionate share of the Assets of the relevant Fund. For the purposes of this Article, "proportionate share" means such part of each type of Asset in the relevant Fund as is proportionate to or as nearly as practicable proportionate to the Applicant's share or such selection from the Assets of the relevant Fund as the Directors shall, following consultation with and subject to the approval of the Depositary, decide is reasonable having regard to the need to be fair both to the Applicant and continuing Shareholders of shares in the relevant Fund.
- 14.5 If any request to the Company to repurchase shares of any class shall (a) reduce the number of shares of the relevant class held by the Applicant below the Minimum Shareholding; or (b) relates to shares having a value less than such de minimus amount as the Directors may determine from time to time, such request may be refused or treated by the Directors as a request to repurchase the Applicant's entire holding. The foregoing shall not prevent a repurchase of the whole of a holding of shares of any class less than the Minimum Shareholding, nor shall this Article apply in circumstances where as a result of the Company exercising its rights to scale down any repurchase requests, in accordance with article 14.1 above, a Shareholder's holding of shares is reduced below the Minimum Shareholding.
- 14.6 If any repurchase requests received by the Directors would necessitate, in the opinion of the Directors, the breaking of deposits at a penalty or the realisation of Investments at a discount below their value, as calculated in accordance with Appendix III, the Repurchase Price in respect of the relevant shares may be reduced by a proportionate part of such reduction in value or penalty that will be suffered by the relevant Fund in such manner as the Directors may consider fair and equitable and that is approved by the Depositary. Alternatively, the Directors may arrange for the Company to borrow funds in accordance with Article 64 subject always to any borrowing restrictions in force in relation to the Company or the relevant Fund, and the costs of such borrowings may be apportioned as aforesaid to such extent as the Directors may consider fair and equitable.

- 14.7 The Company will not be permitted to repurchase shares if, after payment of any amount in connection with such repurchase, the Net Asset Value of the issued share capital of the Company would be equal to or less than EUR2 or the foreign currency equivalent thereof. The foregoing shall not apply to a repurchase request permitted by the Directors in contemplation of the dissolution of the Company in accordance with the Companies Act.
- 14.8 No shares shall be repurchased when the calculation of the Net Asset Value is suspended.
- 14.9 The Directors may, in their absolute discretion, determine that no shares will be repurchased and no repurchase proceeds paid during any period when the determination of the Net Asset Value of the relevant Fund is suspended pursuant to item 16 below. Shareholders applying for a repurchase of their shares will be notified of such suspension at the time of application. Any application that is not withdrawn shall, subject to the provisions of these Articles, be dealt with on the first Dealing Day for the relevant Fund after such suspension is lifted and shall be dealt with in priority to subsequently received repurchase requests.

DETERMINATION OF NET ASSET VALUE

15 Determination of Net Asset Value

The Net Asset Value of a Fund shall be determined in accordance with Appendix III.

16 Suspension of determination of Net Asset Value/ Postponement of a Dealing Day

- 16.1 The Directors may at any time declare a temporary suspension of the determination of the Net Asset Value of a Fund and the issue, repurchase and exchange of shares and the payment of repurchase proceeds during:
- 16.1.1 any period when any of the principal markets or stock exchanges on which a substantial portion of the direct or indirect Investments of the relevant Fund are quoted, listed or dealt in is closed, otherwise than for ordinary holidays, or during which dealings therein are restricted or suspended; or
- 16.1.2 any period when, as a result of political, economic, military or monetary events or any circumstances outside the control, responsibility and power of the Directors, disposal or valuation of a substantial portion of the Investments of the relevant Fund is not reasonably practicable without this being seriously detrimental to the interests of shareholders of the relevant Fund or if, in the opinion of the Directors, the Net Asset Value of the Fund cannot be fairly calculated; or
- 16.1.3 any period when, as a result of adverse market conditions, the payment of repurchase proceeds may, in the opinion of the Directors, have an adverse impact on the relevant Fund or the remaining shareholders in the relevant Fund; or
- 16.1.4 any period (other than ordinary holiday or customary weekend closings) when any market or exchange which is the main market or exchange for a significant part of the instruments or positions is closed, or in which trading thereon is restricted or suspended; or
- 16.1.5 any period when proceeds of any sale or repurchase of the shares cannot be transmitted to or from the account of the relevant Fund; or
- 16.1.6 any period in which the repurchase of the shares would, in the opinion of the Directors, result in a violation of applicable laws; or
- 16.1.7 any breakdown in the means of communication normally employed in determining the price of a substantial portion of any of the relevant Fund's Investments and other Assets or when for any other reason the current prices on any market or stock exchange of any Assets of the relevant Fund cannot be promptly and accurately ascertained; or

- 16.1.8 any period during which any transfer of funds involved in the realisation or acquisition of Investments or payments due on repurchase of shares cannot, in the opinion of the Directors, be effected at normal prices or rates of exchange; or
- 16.1.9 any period when the Company is unable to repatriate funds required for the purpose of making payments due on the repurchase of shares in the relevant Fund; or
- 16.1.10 any period when in the opinion of the Directors such suspension is justified having regard to the interests of the Company and/or the relevant Fund; or
- 16.1.11 any period in which it is or becomes impossible or impractical, for example from a cost, risk or operational perspective to enter into, continue with or maintain FDIs relating to the Benchmark Index for the relevant Fund or to invest in securities comprised within the particular Benchmark Index; or
- 16.1.12 following the circulation to the relevant Shareholders of a notice of a general meeting at which a resolution proposing to wind up the Company or terminate the relevant Fund is to be considered.

The Company will, whenever possible, take all reasonable steps to bring any period of suspension to an end as soon as possible.

- 16.2 Any such suspension shall take effect at such time as the Directors shall declare but not later than the close of business on the Business Day next following the declaration and thereafter there shall be no determination of the Net Asset Value of the relevant Fund and no issues, repurchases or exchanges of shares of the relevant Fund effected and no repurchase proceeds paid until the Directors shall declare the suspension at an end.
- 16.3 The Directors may postpone any Dealing Day for a Fund to the next Business Day if, in the opinion of the Directors, a substantial portion of the Investments of the relevant Fund cannot be valued on an equitable basis and such difficulty is expected to be overcome within one Business Day.
- 16.4 The determination of the Net Asset Value of a Fund shall also be suspended where such suspension is required by the Competent Authority in accordance with the Regulations.

17 Notification of suspension to Competent Authority, Stock Exchanges and Shareholders

Any such suspension of the determination of the Net Asset Value of a Fund shall be notified to the Competent Authority immediately and in any event within the same Business Day on which such suspension occurred as well as, where appropriate, the competent authorities in the jurisdictions where the shares are marketed. If the shares are listed on the official list of the Irish Stock Exchange or any other exchange, any such suspension shall be notified to the Irish Stock Exchange and such other exchange within the time frame specified above. Details of such suspension will also be notified to all Shareholders and will be published in a newspaper circulating in the European Union, or such other publications as the Directors may determine if, in the opinion of the Directors the suspension is likely to exceed 14 days.

18 Compulsory Repurchase or Transfer of Shares

- 18.1 The Directors shall have power in their absolute discretion (but shall not be under any duty) to impose such restrictions (and accordingly may compulsorily redeem) as they may think necessary for the purpose of ensuring that no shares of any class are acquired or held directly or beneficially by a person who is in the opinion of the Directors any of the following:
 - 18.1.1 a U.S. Person (unless permitted under certain exceptions under the laws of the United States) or;
 - 18.1.2 any person whose holding would result in "Benefit Plan Investors" as defined in section 3(12) of the US Employment Retirement Income Security Act of 1974, as amended ("ERISA") holding 25 per cent or more of the total value of any Fund or class of shares in a Fund.

- 18.1.3 any person who does not clear such anti-money laundering checks as the Directors may determine; or
 - 18.1.4 any person who appears to be in breach of any law or requirement of their country or government authority or by virtue of which such person is not qualified to hold such shares; or
 - 18.1.5 any person or persons in circumstances (whether directly or indirectly affecting such person or persons, and whether taken alone or in conjunction with any other person or persons, connected or not, or any other circumstances appearing to the Directors to be relevant) that, in the opinion of the Directors, might result in the Company incurring any liability to taxation or suffering any other pecuniary, fiscal, regulatory or legal disadvantage or material administrative disadvantages; or
 - 18.1.6 an individual who is under the age of 18 (or such other age as the Directors may think fit) or of unsound mind; or
 - 18.1.7 any person unless the transferee of such shares would, following such transfer, be the holder of shares equal to or greater than the Minimum Initial Investment Amount (where relevant); or
 - 18.1.8 any person in circumstances where as a result of such transfer, the transferor or transferee would hold less than the Minimum Shareholding;
 - 18.1.9 any person who does not provide within such number of days of a request as the Directors may determine and provided for in the Prospectus, such information or declaration required under the terms of this item 18.1 to be furnished; or
 - 18.1.10 any person where in respect of such transfer, any payment of taxation remains outstanding. References in these Articles to "Permitted Investor" means any person other than any of the persons specified above.
- 18.2 Furthermore, in circumstances where a Fund is unable to track or replicate the relevant Benchmark Index and unable to substitute another index for the Benchmark Index, the Directors may resolve to compulsorily redeem investors and may subsequently terminate the Fund.
- 18.3 In circumstances where it is or becomes impossible or impractical, for example, from a cost, risk or operational perspective to enter into, continue with or maintain FDIs relating to the Benchmark Index for a Fund or to invest in securities comprised within the particular Benchmark Index, the Directors may resolve to compulsorily redeem investors and may subsequently terminate the Fund.
- 18.4 The Directors shall, unless any Director has reason to believe otherwise, be entitled to assume without enquiry that none of the shares are held in such a way as to entitle the Directors to give a notice in respect thereof pursuant to item 18.5. The Directors may, however, on an application for shares or at any other time and from time to time, require such evidence and/or undertakings to be furnished to them in connection with the matters stated in item 18.1 as they shall in their discretion deem sufficient or as they may require for the purpose of any restriction imposed pursuant thereto or for compliance with any anti-money laundering provisions applicable to the Company. In the event of such evidence and/or undertakings not being so provided within such reasonable period (not being less than 21 days after service of notice requiring the same) as may be specified by the Directors in the said notice, the Directors may, in their absolute discretion, treat any shares held by such a Shareholder or joint Shareholder as being held in such a way as to entitle them to serve a notice in respect thereof pursuant to item 18.5.
- 18.5 If it shall come to the notice of the Directors that any shares are or may be owned or held directly or beneficially by any person who is not a Permitted Investor (the "relevant shares"), the Directors may give notice to the person in whose name the relevant shares are registered requiring him to transfer (and/or procure the disposal of interests in) the relevant shares to a person who is in the opinion of the Directors a Permitted Investor. If any person on whom such a notice is served pursuant to this item 18.5 does not within 21 days after the giving of such notice (or such extended time as the Directors in their absolute discretion shall consider reasonable) transfer the relevant shares to a Permitted Investor, or establish to the satisfaction of the Directors (whose judgement

shall be final and binding) that he is not subject to such restrictions, the Directors may in their absolute discretion on the expiration of such 21 days either arrange the transfer of all the relevant shares to a Permitted Investor in accordance with item 18.7 below or arrange for the relevant shares to be repurchased by the Company at the relevant Repurchase Price. The Shareholder of the relevant shares shall be bound immediately to deliver his certificate (if any) to the Directors and the Directors shall be entitled to appoint any person to sign on his behalf such documents as may be required for the purpose of the transfer or repurchase, as the case may be, of the relevant shares by the Company. The Shareholder of the relevant Shares shall also indemnify the Company for any loss, costs or expenses incurred by the Company by virtue of that Shareholder not being a Permitted Investor.

- 18.6 A person who becomes aware that he holds or owns relevant shares shall immediately, unless he has already received a notice pursuant to item 18.5 above, transfer all his relevant shares to a Permitted Investor or, with the approval of the Directors, request the repurchase of the shares.
- 18.7 A transfer of relevant shares arranged by the Directors pursuant to article 18.5 above shall be by way of sale at the best price reasonably obtainable and may be of all of or part only of the relevant shares with a balance available for transfer to other Permitted Investors or repurchase by the Company. Any payment received by the Company for the relevant shares so transferred shall be paid to the person whose shares have been so transferred subject to article 18.8 below.
- 18.8 Payment of any amount due to such person pursuant to items 18.5, 18.6 or 18.7 above shall be subject to any requisite exchange control consents first having been obtained and the Company not being in breach of any other law or regulation. The amount due to such person will be deposited by the Company in a bank for payment to such person on such consents being obtained and against surrender of the certificate, if any, representing the relevant shares previously held by such person. On deposit of such amount as aforesaid, such person shall have no further interest in such relevant shares or any of them or any claim against the Company in respect thereof, except the right to receive such amount so deposited (without interest) on such consents as aforesaid being obtained.
- 18.9 The Directors shall not be required to give any reasons for any decision, determination or declaration taken or made in accordance with this item 18. The exercise of the powers conferred by this item 18 shall not be questioned or invalidated in any case on the grounds that there was insufficient evidence of direct or beneficial ownership of shares by any person or that the true, direct or beneficial owner of any shares was otherwise than appeared to the Directors at the relevant date provided that the powers shall be exercised in good faith.
- 18.10 Where Irish Residents or persons who are Ordinarily Resident in Ireland acquire and hold shares, the Directors may, where necessary for the collection of Irish tax, repurchase and cancel shares held by a person who is or is deemed to be an Irish Resident or a person Ordinarily Resident in Ireland or is acting on behalf of an Irish Resident or a person Ordinarily Resident in Ireland on the occurrence of a chargeable event for taxation purposes, to pay the proceeds thereof to the Irish Tax Authorities.
- 18.11 The Directors may compulsorily repurchase all of the shares of any Fund if the Net Asset Value of the relevant Fund is less than the Minimum Fund Size.
- 18.12 Without limiting the generality of the foregoing, the Directors may take either of the following actions or any reasonable additional or ancillary actions as they deem necessary in their absolute discretion to comply with FATCA/CRS (or any other law with a similar purpose): (a) require any Shareholder to provide such information or confirmations as necessary from time to time, or (b) share such information with the Inland Revenue, the Revenue Commissioners in Ireland or any other relevant tax or other government authority. Where any Shareholder has failed to provide such information or confirmations as requested or is in any other respect deemed to be a recalcitrant account-holder for the purposes of FATCA/CRS or is for any other reason deemed not to be compliant with FATCA/CRS or would prejudice the Company's ability to comply with FATCA/CRS, the Company may repurchase and cancel the Shareholder's shares and/or compel or effect the sale of those shares or take any other such actions as may reasonably be deemed necessary to enable the Company to comply with FATCA/CRS.

INVESTMENT OF ASSETS

19 Investment of Assets of the Company

- 19.1 The Directors shall, subject to the restrictions and limits imposed under these Articles and the Regulations, determine the investment objectives and policies (including the permissible forms of Investments) and restrictions applying to the Company and any Fund, and the Assets shall be invested in accordance with the investment objectives, policies and restrictions determined by the Directors.
- 19.2 Subject to the Regulations, the Directors may decide to invest up to 100 per cent of the Net Asset Value of a Fund in any of the Specific Investments.
- 19.3 Subject to the provisions of the UCITS Regulations, the Company may, invest up to 20% (35% in certain circumstances and only then in respect of a single issuer) of a Fund's net assets in transferable securities issued by the same body where the aim of the investment policy of the Fund is to replicate the composition of an index which is recognised by the Competent Authority.
- 19.4 Subject to and in accordance with the Regulations and with the prior approval of the Competent Authority, the Company may wholly own any entity that the Directors consider it necessary or desirable for the Company to incorporate or acquire or utilise. All share certificates issued to the Company in respect of its holding in any such entity, as well as all assets of such entity, shall be held by the Depositary or its nominees.
- 19.5 The Directors may decide to invest in collective investment undertakings with which the Company is linked by common management or control or by a substantial direct or indirect holding, subject to the restrictions and limits imposed under the Regulations.
- 19.6 Subject to the Regulations, the Directors may decide to retain, during such time or times as they think fit, all or any amount of cash of any Fund in any currency or currencies either in cash or on deposit with, or in certificates of deposit or other banking instruments issued by, the Depositary or any banker or other financial institution in any part of the world including any appointee of the Company or any associate or affiliate of such appointee, subject to the provisions of the Central Bank Acts, 1942 to 1998 as amended by the Central Bank and Financial Services Regulatory Authority of Ireland Acts, 2003 to 2004.
- 19.7 Subject to the investment objectives, policies and restrictions determined by the Directors, the Company may acquire or utilise derivative contracts of any description under any conditions and within any limits applicable to the Company laid down by the Competent Authority from time to time for the purposes of the Regulations.
- 19.7. Subject to the Regulations, a Fund may be established with the objective of being an index-tracking fund (where the aim of the Fund's investment policy is to replicate the composition of a stock or debt securities index that is recognised by the Competent Authority).
- 19.8. With the exception of permitted investments in unlisted securities, the Company on behalf of a Fund will only invest in those securities and derivative instruments listed or traded on a stock exchange or market (including derivative markets) which meets with the prevailing regulatory criteria (regulated, operate regularly, be recognised and open to the public) and which is listed in the Prospectus.

DEPOSITARY

20 Appointment of Depositary

- 20.1 The Directors shall, subject to the prior approval of the Competent Authority, appoint a Depositary who shall be responsible for the safe custody of all the Assets; shall perform its duties required of a trustee and Depositary as prescribed by the Regulations; and shall perform such other duties on such terms as the Directors may from time to time (with the agreement of the Depositary) determine. The Depositary appointed shall be approved by the Competent Authority to act as Depositary of a UCITS pursuant to the Regulations.
- 20.2 Any contract or agreement entered into by the Company with any Depositary and any variation to any such contract or agreement then in force shall be subject to prior approval by the Competent Authority and shall reflect the regulatory obligations of the Depositary specified in the Regulations.

21 Appointment of sub-custodians

Subject to the requirements of the Competent Authority and the UCITS Requirements, the terms of appointment of any Depositary may authorise such Depositary to appoint (with powers of sub-delegation) sub-custodians, nominees, agents or delegates at the expense of the Depositary and to delegate any of its functions and duties to any person or persons so appointed. For the avoidance of doubt, the Depositary may not delegate its fiduciary obligations and discretions specified in the Regulations and its liability shall not be affected by the fact that it has entrusted to a third party some or all of the assets of the Company in its safekeeping.

22 Remuneration of Depositary

- 22.1 In consideration for its services as Depositary the Depositary shall be entitled to be paid by or on behalf of the Company out of the property of the Company:
- (i) a fee of such amount specified in the Depositary Agreement; and
 - (ii) reasonable expenses and disbursements incurred by the Depositary in the performance of its functions and all other charges or fees expressly authorised by the Depositary Agreement;

and the Depositary shall not be obliged to account to the Shareholders or any of them for any payment received in accordance with the foregoing provisions.

23 Retirement or replacement of Depositary

- 23.1 Subject to the prior approval of the Competent Authority, and in accordance with the terms of the Depositary Agreement, the Depositary may be removed or may retire and a new Depositary appointed in the manner specified in item 23.2 below.
- 23.2 In the event of the Depositary desiring to retire or on being removed in accordance with item 23.1 above, the Company shall, with the prior approval of the Competent Authority, appoint a duly qualified corporation that is approved by the Competent Authority to be the Depositary in place of the Depositary so retiring or being removed, on or before the date on which such retirement or removal is to take effect. In the event of the Depositary having given to the Company notice of its desire to retire or in the event of the Depositary being removed and no successor Depositary having been appointed within such period as may be agreed between the Company and the Depositary, the Depositary shall be entitled to require the Company to convene an extraordinary general meeting of all Shareholders, at which there shall be proposed an ordinary resolution to wind up the Company in accordance with the provisions of these Articles and the Companies Act so that the shares in the Company may be redeemed in accordance with the provisions of these Articles and revocation of the Company's authorisation sought from the Competent Authority. On

the revocation of the Company's authorisation from the Competent Authority, the Depositary's appointment shall terminate.

- 23.3 Notwithstanding the above, the Competent Authority may at any time replace the Depositary with another depositary in accordance with the provisions of the UCITS Requirements.

EQUALISATION PAYMENTS

24 Equalisation Payments

- 24.1 On any allotment or issue of any shares of any class after the Initial Offer Period, if the Directors are operating an Equalisation Account in relation to the relevant Fund (but not otherwise), the Subscription Price in respect of each such share subscribed for should include an Equalisation Payment, the same to be repayable in whole or in part as is hereinafter provided.
- 24.2 In the event of an Equalisation Account being operated in respect of any Fund, all Equalisation Payments received in accordance with item 24.1 above, or deemed to have been received, shall be credited to the Equalisation Account in respect of the relevant Fund. Any amounts paid by way of Equalisation Payment shall be returnable in whole or in part to the payer only in the events specified in item 24.3 below and not otherwise.
- 24.3 The Shareholder of a share on which an Equalisation Payment was paid or deemed to be paid on its issue shall be entitled to payment from the relevant Equalisation Account of a capital sum in the amount hereinafter provided on the payment of the first dividend thereon in respect of the same accounting period after the date of issue of such share but prior to any repurchase being made subsequent to the date of issue of such share.
- 24.4 The capital sum payable pursuant to item 24.3 above shall be an amount equal to the Equalisation Payment paid or deemed to be paid on the issue of such share or, if the Directors so think fit, a sum calculated by dividing the aggregate of all Equalisation Payments standing to the credit of the relevant Equalisation Account at the date to which the relevant dividend relates, by the number of shares in respect of which such capital sums are payable; In so doing, such shares may be divided into two or more groups issued within different periods of time as may be selected by the Directors in any one accounting period and the capital sum payable on each share in each such group shall be a sum calculated by dividing the aggregate of all Equalisation Payments standing to the credit of the relevant Equalisation Account in respect of the shares of each such group by the number of shares in such group. However, in no circumstances shall the capital sum payable in respect of any one share pursuant to this item 24.4 exceed the amount of the dividend declared on such share.
- 24.5 Any capital sums repaid to a Shareholder in accordance with the provisions of this item shall release the Company from any liability to repay to the Shareholder the Equalisation Payment paid, and such Shareholder shall accept any such capital sum in full and final satisfaction of any Equalisation Payment otherwise payable.

DEALINGS IN SHARES

25 Dealings in shares

- 25.1 Without prejudice as to the generality of these Articles, the manager may purchase on any Dealing Day shares of any class at not less than the Subscription Price (in respect of a purchase from the Company) or the Repurchase Price (in respect of a purchase from a Shareholder) for shares of the class in question established as at the relevant Dealing Day. Any amount payable by the manager in respect of the purchase of shares shall be paid not later than the relevant Settlement Date.

- 25.2 The manager shall be entitled, in the name and on behalf of any Shareholder whose shares are to be purchased by the manager, to execute an instrument of transfer in respect of the shares. The manager may be registered as a Shareholder in respect of such shares.
- 25.3 Any shares of any Fund acquired by the manager pursuant to the foregoing provisions and for the time being outstanding may be sold by the manager on the Dealing Day on which the manager acquired them or any subsequent Dealing Day in satisfaction of the whole or any part of any application for shares of the class in question. Such sale shall be effected at any price not exceeding the aggregate of the Subscription Price of shares of the relevant class as at the Dealing Day for which such application is made as at the relevant day in the case of such application, plus the preliminary/subscription charge (if any) to which the manager or its delegate would be entitled under these Articles, and the manager shall be entitled to retain for its own use and benefit all money received by it on such sale.
- 25.4 Subject to the provisions of these Articles, the manager shall have the right on any Dealing Day, provided that the Company is notified on or prior to the Dealing Deadline for such Dealing Day, to surrender certificate(s) to the Company for cancellation of some or all of the shares represented thereby. In respect of any such cancellation of shares, the manager shall be entitled to receive out of the relevant Fund an amount equal to the Repurchase Price that would be payable in respect of such shares if they were repurchased as at that Dealing Day pursuant to the provisions of these Articles. Any amount payable to the manager on foot of such request for cancellation shall be payable not later than the relevant Settlement Date. The right of the manager to require cancellation of any share shall be suspended during any period when the right of holders of shares to require the repurchase of those shares is suspended pursuant to these Articles;

APPENDIX III

Determination of Net Asset Value

- 1 The Net Asset Value (i.e. the value of the assets of a Fund having deducted the liabilities of that Fund therefrom) of any Fund or any class of shares or any individual share shall be expressed in the currency in which the Fund or the class of shares or the individual share is designated or in such other currency as the Directors may determine, from time to time, and shall be determined in accordance with the valuation rules set out hereafter.
- 2 For the purposes of such valuation, Assets of the Company shall be determined to include but are not limited to all cash in hand, on deposit, or on call including any interest accrued thereon as at the relevant Valuation Point and all accounts receivable, (ii) all bills, demand notes, certificates of deposit, and promissory notes, (iii) all bonds, shares, stock, securities, obligations, debentures, debenture stock, forward rate agreements, subscription rights, warrants, promissory notes, futures contracts, options, commodities, asset backed securities, mortgage backed securities, swap contracts, contracts for differences, fixed rate securities, variable and floating rate securities, securities in respect of which the return and/or redemption amount is calculated by reference to any index, price or rate, monetary and financial instruments of all kinds, (iv) all stock and cash dividends and cash distributions to be received by the Company and not yet received by it but declared to stockholders of record on a date on or before the relevant Valuation Point as at which the Net Asset Value is determined, (v) all interest accrued on or before the relevant Valuation Point on any interest-bearing securities owned by the Company except to the extent that the same is included or reflected in, the principal value of such security, (vi) all other Investments of the Company, (vii) the preliminary expenses incurred in establishing the Company that are payable by the Company and that may include the cost of issuing, distributing, marketing and promoting shares of the Company insofar as the same have not been written off and (viii) all other Assets of the Company of every kind and nature including prepaid expenses as valued and defined from time to time by the Directors.
- 3 The Directors shall be entitled to determine in relation to any preliminary costs, charges, fees and expenses of the Company or of a Fund or a class of shares, that the same may be amortised over such period as they think fit.
- 4 The value of any investments listed or dealt in on a stock exchange or regulated market shall be the closing bid price on the relevant stock exchange or regulated market at the relevant Valuation Point unless otherwise disclosed in the relevant Supplement, provided that only one method of valuation in respect of the closing or last known market price may be used by a Fund in accordance with the requirements of the Competent Authority. Where any investment is listed or dealt in on more than one stock exchange or regulated market the Directors shall select the stock exchange or regulated market which they determine provides the fairest criteria in a value for the security. Securities listed or traded on a recognised exchange, but acquired or traded at a premium or at a discount outside or off the relevant exchange or market may be valued taking into account the level of premium or discount at the Valuation Point.
- 5 The value of any investment which is not listed or dealt in on a stock exchange or regulated market or of any investment which is normally listed or dealt in on a stock exchange or regulated market but in respect of which the closing bid price (or applicable closing or last known market price disclosed in the relevant Supplement) is currently unavailable or the current price of which does not in the opinion of the Directors represent fair market value, shall be the probable realisation value thereof estimated with care and in good faith by the Directors or by a competent person appointed by the Directors and approved for such purpose by the Depositary or any other means provided the value is approved by the Depositary. In determining the probable realisation value of any such investment, a certified valuation thereof provided by a competent independent person or in the absence of any independent person, the Investment Manager, who in each case shall have been approved for such purposes by the Depositary, shall be sufficient.

- 6 Cash and other liquid assets will be valued at their face value plus interest accrued, where applicable.
- 7 The value of any exchange traded futures contracts, share price index futures contracts and options shall be based on the settlement price as determined by the stock exchange or regulated market in question as at the Valuation Point. Where the settlement price is not available the value of such contract shall be its probable realisation value which must be estimated with care and in good faith by a competent person appointed by the Directors and approved for the purpose by the Depositary or any other means provided the value is approved by the Depositary.
- 8 The valuation of units or shares or other similar participations in any collective investment scheme which provides for the units or shares or other similar participations therein to be redeemed at the option of the Shareholder out of the assets of that undertaking shall be the latest available net asset value per unit or share or other relevant participation as published by the scheme as at the relevant Valuation Point, or at the latest bid price published by the scheme.
- 9 If in any case a particular value is not ascertainable as provided above, the method of valuation of the relevant investment shall be such as the Directors, with the approval of the Depositary, shall decide.
- 10 Any value expressed otherwise than in the Base Currency of the relevant Fund (whether of any investment or cash) and any non-base currency borrowing shall be converted into the Base Currency at the rate (whether official or otherwise) which the Administrator shall determine to be appropriate in the circumstances.
- 10A The value of any OTC derivative contracts shall be valued in accordance with Article 11 of Regulation (EU) No. 648/2012 on OTC derivatives, central counterparties and trade repositories ("**EMIR**").
- 11 In the case of the Funds whose investment objective is to track a particular index and where there is significant overlap between the assets of the relevant Fund and its Benchmark Index, the assets of such Funds may be valued in accordance with the valuation methodology for such Investments which is utilised by the relevant index. Such valuation methodology may include valuing Investments using mid-market, last traded, bid, and/or offer prices.
- 12 Where reliable market quotations are not available for fixed income securities, the value of such securities may be determined using matrix methodology compiled by the Directors whereby such securities are valued by reference to the valuation of other securities which are comparable in rating, yield, due date and other characteristics.
- 13 Notwithstanding the provisions of items 4 to 12 above:
 - 13.1 The Directors or their delegate may at their discretion, in relation to any particular Fund that is a short-term money market fund, value any investment using the amortised cost method of valuation, where such collective investment schemes comply with the Competent Authority's requirements for short-term money market funds and where a review of the amortised cost valuation vis-à-vis market valuation will be carried out in accordance with the Competent Authority's guidelines.
 - 13.2 The Directors or their delegate may at their discretion, in relation to any particular Fund that is a money market fund or which is not a money market fund but that invests in money market instruments, value any investment on the basis of the amortised cost method, provided that each such security being valued using the amortised cost basis of valuation shall have a residual maturity of less than 3 months and does not have any specific sensitivity to market parameters, including credit risk in accordance with the Competent Authority's requirements.

- 14 In the event of it being impossible or incorrect to carry out a valuation of a specific Investment in accordance with the valuation rules set out in items 1 to 11 of this Appendix, or if such valuation is not representative of the security's fair market value, the value shall be estimated with care and in good faith by a competent person appointed by the Directors (being approved by the Depositary) or by a competent person approved for the purpose by the Depositary, using an alternative method approved by the Depositary.
- 15 If in any case a particular value is not ascertainable as provided above or if the Directors shall consider that some other method of valuation better reflects the fair value of the relevant Investment, then in such case the method of valuation of the relevant Investment shall be such as the Directors in their absolute discretion shall determine, such method of valuation to be approved by the Depositary. The Directors may delegate to the Administrator, and authorise the Administrator to consult with the relevant investment manager in connection with, the determination of Net Asset Value and the Net Asset Value per Share of each Class of each Fund.
- 16 Notwithstanding the generality of the foregoing, the value of an asset may be adjusted by the Manager where such an adjustment is considered necessary to reflect the fair value in the context of currency, marketability, dealing costs and/or such other considerations as are deemed relevant, such as, applicable rate of interest, anticipated rate of dividend, maturity or liquidity.
- 17 If in any case a particular value is not ascertainable as provided above, the method of valuation of the relevant Investment shall be such as the Directors, with the approval of the Depositary, decide.
- 18 For the purposes of this Appendix:
 - 18.1 money payable to the Company in respect of the allotment of shares shall be deemed to be an Asset of the Company as of the time at which such shares are deemed to be in issue in accordance with item 2.3 of Appendix II;
 - 18.2 money payable by the Company as a result of the cancellation of allotments or on the compulsory repurchase or transfer of shares or on repurchase of shares shall be deemed to be a liability of the Company from the time at which such shares are deemed to cease to be in issue in accordance with item 2.3 or item 12.3 of Appendix II.
 - 18.3 money due to be transferred as a result of an exchange of shares to another pursuant to an Exchange Notice shall be deemed to be a liability of the Original Class and an Asset of the New Class immediately after the Valuation Point for the Dealing Day on which the Exchange Notice is received or deemed to be received in accordance with item 9 of Appendix II.
- 19 Where the current price of an Investment is quoted "ex" any dividend (including stock dividend), interest or other rights to which the relevant Fund is entitled but such dividend, interest or the property to which such rights relate has not been received and is not taken into account under any other provisions of this Appendix III, the amount of such dividend, interest, property or cash shall be treated as an Asset of the relevant Fund.
- 20 For the purposes of ascertaining or obtaining any price, quotation, rate or other value referred to in this Appendix III for use in determining the value of any Asset, the Directors shall be entitled to use the services of any recognised information or pricing service.
- 21 Any valuations made pursuant hereto shall be binding on all persons.
- 22 The liabilities of the Company, and where the context so admits or requires, the liabilities of any Fund or any class of shares of a Fund, shall be deemed to include (in each case together with any applicable value added tax):

- 22.1 the costs of dealing in the Assets;
- 22.2 interest incurred in effecting, or varying the terms of, borrowings;
- 22.3 all administrative expenses payable and/or accrued;
- 22.4 any costs incurred in respect of meetings of Shareholders;
- 22.5 costs incurred in respect of the establishment and maintenance of the Register;
- 22.6 the audit fees and expenses of the Auditors;
- 22.7 costs incurred in respect of the distribution of income to Shareholders;
- 22.8 costs incurred in respect of the preparation and publication of prices of shares and of prospectuses, annual and interim reports and financial statements;
- 22.9 legal and other professional fees and expenses incurred in connection with the business of the Company;
- 22.10 all regulatory and compliance consultancy fees incurred by the Company or on behalf of its delegates;
- 22.11 costs and expenses incurred in respect of the formation of the Company and the initial offer of shares in the Company that may be amortised over such period or periods as the Directors may determine;
- 22.12 taxation and duty payable by the Company in respect of the Assets of the Company including any dealings in shares or Assets;
- 22.13 costs and expenses incurred in modifying these Articles and in respect of any agreement entered into by or in relation to the Company from time to time;
- 22.14 unless otherwise agreed, fees, expenses and disbursements of the Depositary and any sub-custodians (at normal commercial rates), the manager (if any), the investment manager/adviser, the paying agent (if any), the Administrator, correspondent bank, fiscal representative or other supplier of services to the Company or with respect to any Fund or class appointed by or on behalf of the Company and their respective delegates and any other appointees of the Company including where appropriate any performance fees payable;
- 22.15 secretarial fees and all costs incurred by the Company in complying with statutory requirements imposed on it;
- 22.16 all brokerage, bank fees, charges and commissions incurred by or on behalf of the Company in the course of its business;
- 22.17 Directors' fees and expenses;
- 22.18 any fees of any regulatory authority in a country or territory outside Ireland and, if applicable, any fees levied by the Competent Authority;
- 22.19 the fees and expenses including overheads, administrative costs, expenses and commissions incurred by any distributor appointed to market and distribute the shares;

- 22.20 the fees and expenses of any paying agent or representative appointed in another jurisdiction in compliance with the law or other requirements of that jurisdiction;
- 22.21 all costs and expenses (including copyright expenses) incurred in relation to the marketing and promotion of the Company and the sale of the shares;
- 22.22 all transfer fees, registration fees and other charges whether in respect of the constitution or increase of the assets or the creation, exchange, sale, purchase or transfer of shares or the purchase or sale or proposed purchase or sale of assets or otherwise which may have become or will become payable in respect of or prior to or upon the occasion of any transaction, dealing or valuation, but not including commission payable on the issue and/or repurchase of shares;
- 22.23 all expenses incurred in connection with the operation and management of the Company, including, without limitation to the generality of the foregoing, all Directors' fees and expenses, all costs incurred in organising Directors' meetings and in obtaining proxies in relation to such meetings, all insurance premiums including any policy in respect of directors' and officers' liability insurance cover and association membership dues and all non-recurring and extraordinary items of expenditure as may arise;
- 22.24 the remuneration, commissions and expenses incurred or payable in the marketing, promotion and distribution of shares including without limitation commissions payable to any person in consideration of his subscribing or agreeing to subscribe or procuring or agreeing to procure subscriptions for any shares in the Company and the costs and expenses of preparation and distribution of all marketing material and advertisements;
- 22.25 all fees and expenses connected with the preparation, publication and supply of information to shareholders and the public including, without limitation, the cost of preparing, translating, printing, distributing the Prospectus and any addenda or supplements, key investor information document and any periodic updates thereof, marketing literature, any report to the Competent Authority or any other regulatory authority, the annual audited report and any other periodic reports and the calculation, publication and circulation of the net asset value per share, certificates, confirmations of ownership and of any notices given to shareholders in whatever manner;
- 22.26 all fees and expenses incurred or payable in registering and maintaining a Fund or class registered with any and all government agencies and/or regulatory authority and/or rating agencies, clearance and/or settlement systems and/or any exchanges in any various countries and jurisdictions including, but not limited to, filing and translation expenses;
- 22.27 all fees and expenses incurred or payable in listing and in maintaining or complying with the requirements for the listing of the shares on the Irish Stock Exchange (or other exchange to which shares may be admitted);
- 22.28 all other liabilities and contingent liabilities of the Company of whatsoever kind and all fees and expenses incurred in connection with the Company's operation and management including, without limitation, interest on borrowings, all company secretarial expenses and all Irish Companies Registration Office filings and statutory fees and all regulatory fees;
- 22.29 all expenses involved in obtaining and maintaining a credit rating for the Company from any rating agency;
- 22.30 any amount payable under indemnity provisions contained in these Articles or any agreement with any appointee of the Company;
- 22.31 all sums payable in respect of any policy of insurance taken out by the Company on behalf of the Directors in respect of directors' and officers' liability insurance cover;

- 22.32 all known liabilities including the amount of any unpaid dividend declared on the shares or for the payment of money and other outstanding payments on shares previously repurchased;
 - 22.33 legal and other professional fees and expenses incurred in any proceedings instituted or defended to enforce, protect, safeguard, defend or recover the rights or Assets;
 - 22.34 legal and other professional fees and expenses incurred in connection with the business of the Company;
 - 22.35 all costs and expenses incurred in relation to the liquidation or winding up of the Company or termination of any Fund;
 - 22.36 the costs of any amalgamation or restructuring of the Company or any Fund;
 - 22.37 all duties, taxes or government charges which may be payable on the assets, income or expenses of the Company;
 - 22.38 all brokerage, bank fees, charges and commissions incurred by or on behalf of the Company in the course of its business;
 - 22.39 all other liabilities of the Company of whatsoever kind and nature including an appropriate provision for taxes (other than taxes taken into account as Duties and Charges) and contingent liabilities as determined by the Directors, from time to time.
- 23 In determining the amount of such liabilities the Directors may calculate administrative and other expenses of a regular or recurring nature on an estimated figure for yearly or other periods in advance and accrue the same in equal proportions over any such period.
- 24 The Directors may at their discretion apply to the Net Asset Value of a Fund a sum representing a provision for Duties and Charges relating to the acquisition and disposal of Investments of the Fund.
- 25 The Directors may at their discretion apply a sum representing Duties and Charges to capital subject to the requirements of the Competent Authority.
