#### **OBJECTIVE AND INVESTMENT POLICY**

**Objective:** To provide long-term capital growth by investing in Europe excluding the United Kingdom.

**Investment Policy:** To invest at least 75% of the fund directly or indirectly in the shares of smaller companies incorporated in, or smaller companies which generate the majority of their income from Europe excluding the United Kingdom.

- The remainder of the fund may invest outside of Europe, as well as in larger companies, and in bonds and cash.
- The fund may invest in other types of financial instruments such as other funds and American and Global depositary receipts (which represent shares of companies and are traded on stock markets around the world).
- The fund may use derivatives (such as futures, options and swaps), which are linked to the rise and fall of other assets, to help reduce risk or manage the fund more effectively.

**Distribution Policy:** Any income generated will be automatically reinvested in more units/shares of the same class unless payment is specifically requested.

**Dealing Frequency:** Normally 12 noon (Irish time) Monday to Friday unless it is an Irish or UK public holiday.

Minimum recommended holding term: This Fund may not be appropriate for investors who plan to withdraw their money within 5 years.
