

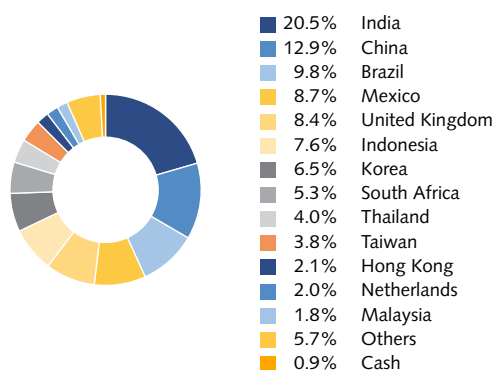
Vontobel Fund - Emerging Markets Equity I GBP

The Fund invests primarily in equities or equity-like securities of companies that are domiciled or have a majority of their business activity in an emerging market and which we believe are undervalued.

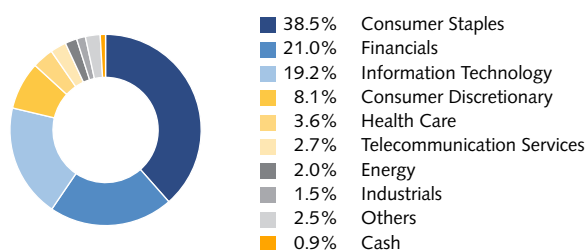
- An actively managed equity fund that invests in emerging market equities
- The investment goal is to achieve absolute capital growth on the long-term through investments in an equity portfolio composed of companies we believe are undervalued
- Investments are strictly made according to the bottom-up approach, which entails analysis of the growth potential of specific stocks, followed by valuation of the opportunities in the sector and overall market
- The portfolio reflects the investment ideas the portfolio manager is most convinced of
- Portfolio composition is not benchmark-oriented
- Long-term investment horizon without an established holding period

Major Sectors



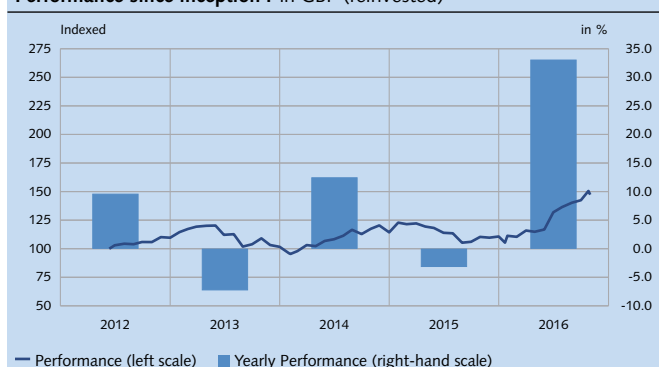
