# Lyxor Core FTSE Actuaries UK Gilts (DR) UCITS ETF - Dist

# 1. FUND INFORMATION

### Description

### Investment objective

The Lyxor Core FTSE Actuaries UK Gilts (DR) UCITS ETF - Dist is a UCITS compliant exchange traded fund that aims to track the benchmark index FTSE Actuaries UK Conventional Gilts All Stocks Total Return.

The investment objective is to replicate rises and falls in the FTSE Actuaries UK Conventional Gilts All Stocks Total Return (Bloomberg ticker: FTFIBGT) ("Benchmark Index"), which represents the UK gilt market. The expected ex-post tracking error under normal market conditions is 0.10%.

#### Risk Factors


UNDERLYING RISK: The Underlying Index of a Lyxor ETF may be complex and volatile. When investing in commodities, the Underlying Index is calculated with reference to commodity futures contracts exposing the investor to a liquidity risk linked to costs such as cost of carry and transportation. 



