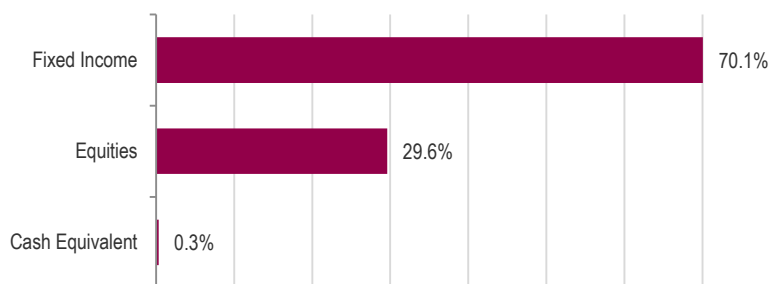

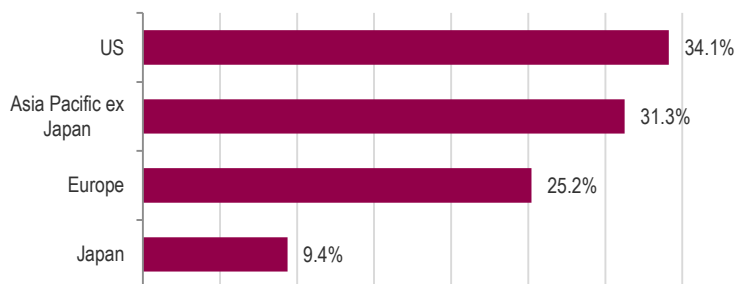

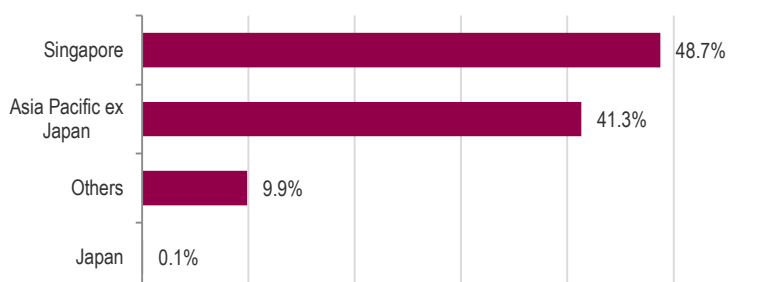
Asset Allocation (% of NAV)

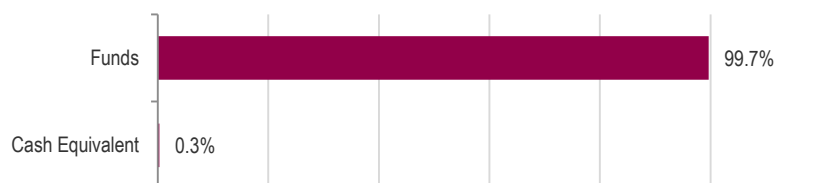
