

Important Notes 重要提示

- 1 Manulife Advanced Fund SPC - Renminbi Bond Segregated Portfolio (the "Fund"), which is a bond fund denominated in USD only and not in RMB, uses the QFII regime, the Bond Connect and/or the Foreign Access Regime to primarily invest directly in RMB-denominated debt instruments. The Fund is exposed to the credit / insolvency risks of its counterparties as an unsecured creditor and that of the issuers of RMB instruments and assets in which the Fund invests.
 - 2 RMB is not freely convertible and is subject to exchange controls and restrictions. There is no guarantee that RMB will not depreciate. There are various requirements and restrictions under the laws of Mainland China and regulations relating to investment via QFII regime and/or China Interbank Bond Market that may expose the Fund to higher volatility, liquidity, emerging market and Mainland China tax and custodial risks.
 - 3 The Fund may invest in convertible bonds which are subject to risks typical to bonds and equity securities, and may expose the investor to greater volatility, credit, interest rate changes and counterparty risks.

- 1 宏利盈進基金SPC - 人民幣債券獨立資產組合(「本基金」)以美元計價，而不是以人民幣計價，主要透過QFII制度、債券通及/或外國准入制度直接投資於以人民幣計價的債務票據。本基金須承受其所投資的人民幣票據及資產之發行人的信貸/無償債能力風險，及其交易對手（作為無抵押債權人）的信貸/無償債能力風險。
 - 2 人民幣不是自由兌換的貨幣並受到外匯管制和限制。沒有保證人民幣不貶值。中國內地於QFII制度及/或中國銀行間債券市場投資的法規有各種要求和限制，使本基金承受波動性、流動性、新興市場、中國內地稅務及託管的相關風險。

Investment Objective 投資目標

To provide capital appreciation and income generation by investing primarily in RMB-denominated debt instruments issued and listed in Mainland China or traded in the Mainland China interbank bond market in accordance with applicable QFII regulations. The fund will invest primarily (i.e. not less than 70% of its net assets) in RMB-denominated debt instruments, including convertible bonds that are listed or transferred on either the Shanghai Stock Exchange or the Shenzhen Stock Exchange, or interbank bonds, and which are issued by the Mainland China Government as well as corporations in Mainland China.

本基金的目標是根據適用的QFII規則，以主要投資於中國內地發行及上市或在中國內地銀行間債券市場交易並以人民幣為單位的債務票據提供資本增長及產生收入。本基金將主要投資(即不少於其淨資產的70%)於在上海證券交易所或深圳證券交易所上市或轉讓，以及由中國內地政府及中國內地公司發行的人民幣計價債務票據(包括可轉換債券)，或銀行間債券。

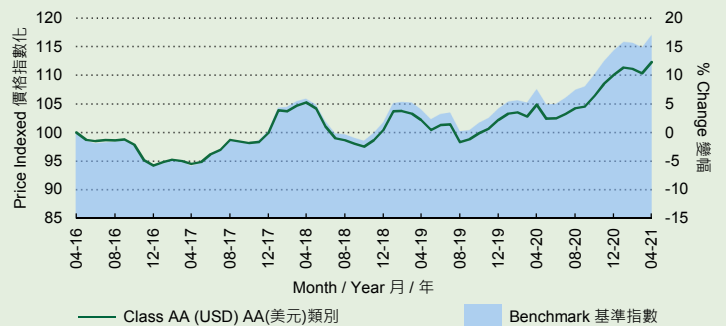

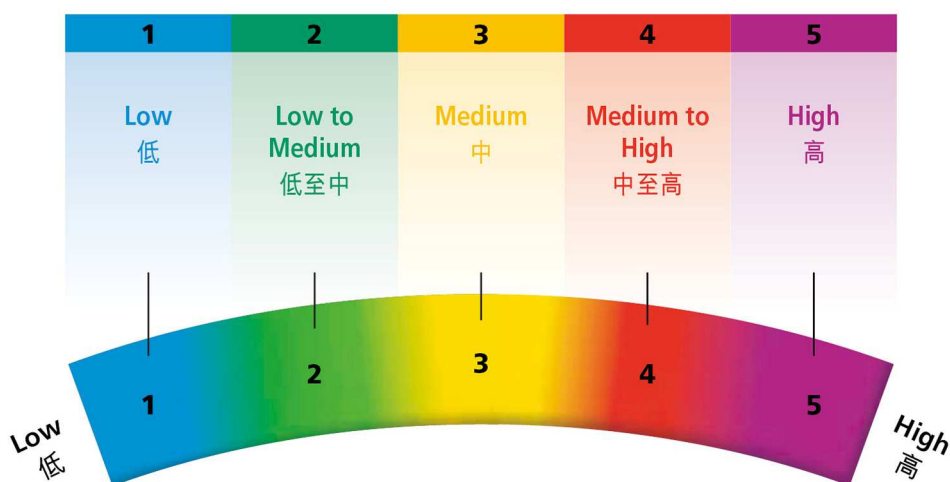
Description of the Manulife Risk Meter

The risk level is represented by the Manulife Risk Meter, a 5-level risk continuum from 1 to 5, which signifies the risk profile of the fund. The more sensitive a fund is to the change of market conditions, the more volatile it is and therefore the higher its risk level is indicated by the Manulife Risk Meter. Likewise, a fund less sensitive to market condition changes has lower volatility and is therefore regarded as bearing lower risk on the Manulife Risk Meter. Each risk level reflects the corresponding risk profile as follows:

有關宏利風險指標

風險水平由一個具有五個級別的宏利風險指標表示，以表示基金的風險程度。當宏利風險指標內所標示的風險級別愈高，就代表該基金對市場狀況的轉變愈敏感，波幅愈大；相反，當宏利風險指標內所標示的風險級別愈低，該基金對市場狀況的轉變愈不敏感，波幅愈小。每個風險級別反映對應的風險程度如下：

Remarks:

The 5 risk levels in the Manulife Risk Meter are determined on the basis of a number of factors relating to the underlying investments of funds, including the types of asset classes and their respective target weightings, the breadth and geography of diversification, the historical volatility and capitalisation of the relevant markets, investment strategy and the presence of any guaranteed investment returns. Please note that the volatility and the risk level of a fund may change over time and the future market volatility may not follow the historical volatility. The composition of the underlying investments of each fund may be different from that of the referenced market index. The Manulife Risk Meter and the risk level of each fund will at least be reviewed quarterly. While a fund of a higher risk level may be more volatile, the lowest risk level does not mean risk-free.
