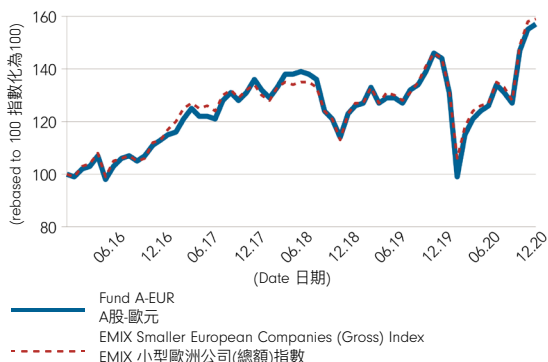
- This fund invests primarily in equity securities of small and medium-sized European companies.

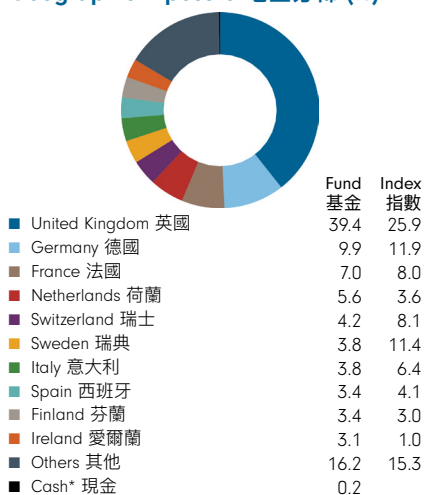

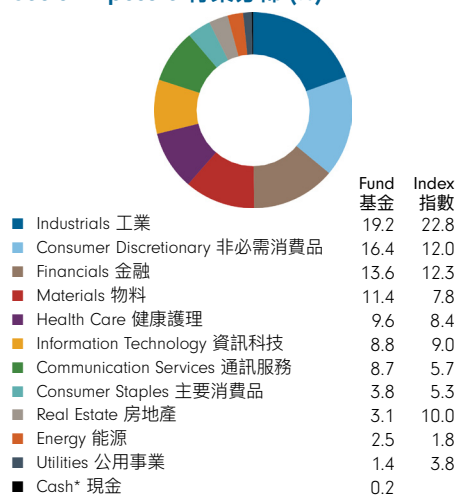
