# What is this product?

## **Objectives**

WisdomTree Natural Gas 3x Daily Leveraged is a fully collateralised Exchange Traded Commodity (ETC) designed to provide investors with a leveraged exposure to Natural Gas . The ETC provides a total return comprised of 3 times the daily performance of the Solactive Natural Gas Commodity Futures SL Index (SOLWSNG2), plus the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Solactive Natural Gas Commodity Futures SL Index rises by 1% over a day, then the ETC will rise by 3%, excluding fees.
