

#### Objectives and investment policy

The fund is passively managed. INVESTMENT OBJECTIVE: The aim is for your investment to reflect the performance, before fees and expenses, of the MSCI GCC Countries ex Select Securities Index (index) which is designed to reflect the performance of the shares of companies based in Bahrain, Kuwait, Oman, Qatar, Saudi Arabia and the United Arab Emirates. DESCRIPTION OF INDEX: A company's weighting in the index depends on its relative size based on the combined value of a company's readily available shares as compared to other companies. MSCI Inc. (index administrator) may exclude certain securities from time to time on the basis that they have restrictions on foreign ownership. INDEX mav REBALANCING, CALCULATION AND ADMINISTRATION: The index is calculated on a total return net basis which means that all dividends and distributions by the companies are reinvested in the shares after tax. The index is reviewed and rebalanced on a quarterly basis. INVESTMENT POLICY: To achieve the aim, the

fund will invest in transferable securities and enter into financial contracts (derivatives) with one or more swap counterparties relating to the transferable securities and the index, in order to obtain the return on the index. 
