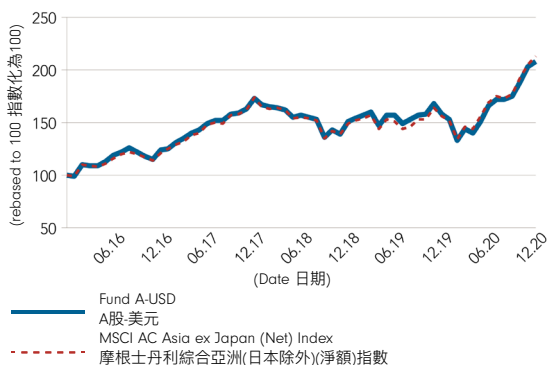

Summary of Investment Objective 投資目標摘要

The fund is an Equity fund and aims to provide long-term capital growth with the level of income expected to be low. The fund invests principally (i.e. at least 70% (and normally 75%) of the fund's assets) in special situations stocks and smaller growth companies in Asia (ex Japan). This region includes certain countries considered to be emerging markets. (Please refer to the offering document for Investment Objective of the fund)

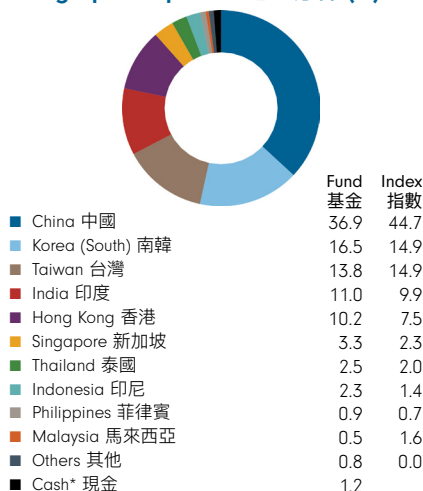

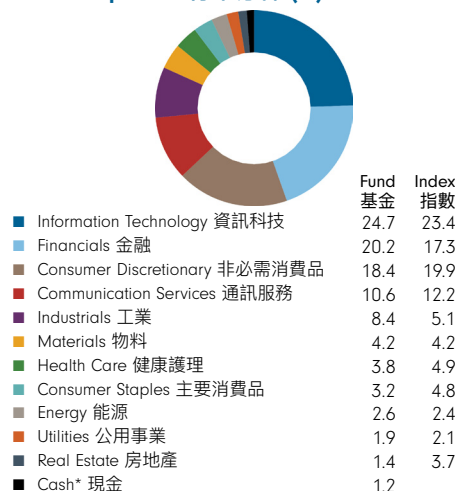
Geographic Exposure 地區分佈 (%)
