

Investment Objective 投資目標

The fund aims to track the performance of the EURO STOXX 50® Index (before fees and expenses) thereby seeking to achieve long term capital growth. The fund uses an 'index tracking' (also known as 'passive') investment management approach whereby it aims to replicate the composition of the index. However, for reasons such as liquidity or excessive cost, it may not always be practical for the fund to invest in every company share in the index or at its weighting within the index. In order to manage the cash position, the fund may invest in collective investment schemes (such as liquidity funds), including those managed by FIL Group, in addition to money market instruments, cash and deposits. As well as investing directly in company shares, the fund will also achieve exposure indirectly through the use of derivatives for efficient portfolio management purposes, for example, at the time of cash inflows to remain fully invested or to reduce transaction costs. 基金旨在追蹤 EURO STOXX 50® 指數的表現(未扣除費用及開支),從而致力取得長期資本 增長。基金採用「指數追蹤」(亦稱為「被動式」)投資管理策略,旨在複製指數的成份組 合。然而,基於流動性或成本過高的原因,基金要時刻投資於指數的所有成份公司股份,或 按照指數的比重進行投資可能並不切實可行。為管理現金持倉,除貨幣市場工具、現金及存 款之外,基金可能投資於集體投資計劃(例如流動性基金),包括由富達集團管理的集體投 資計劃。基金可直接投資於成份公司股份,亦將可透過使用衍生工具作有效管理投資組合的 目的,間接取得有關投資,例如在現金流仍然充份投資或為削減交易成本的情況下。
