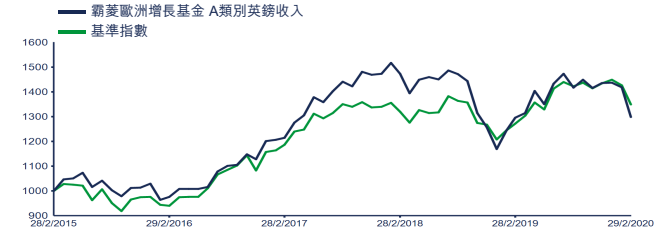

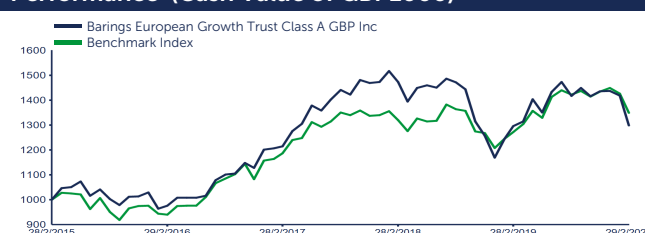
Product Highlights
