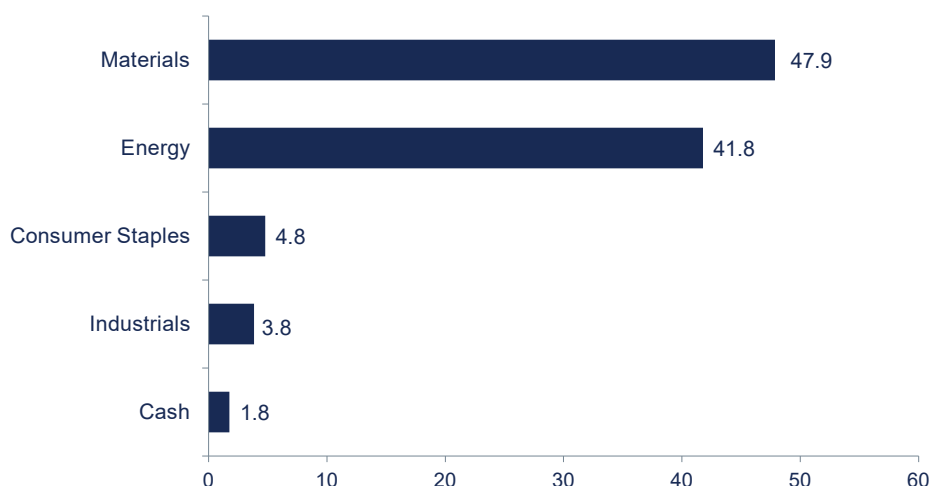

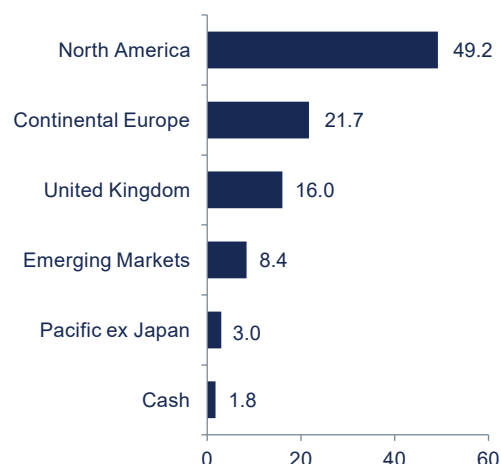
TOP SECTOR WEIGHTING (% OF NAV)³

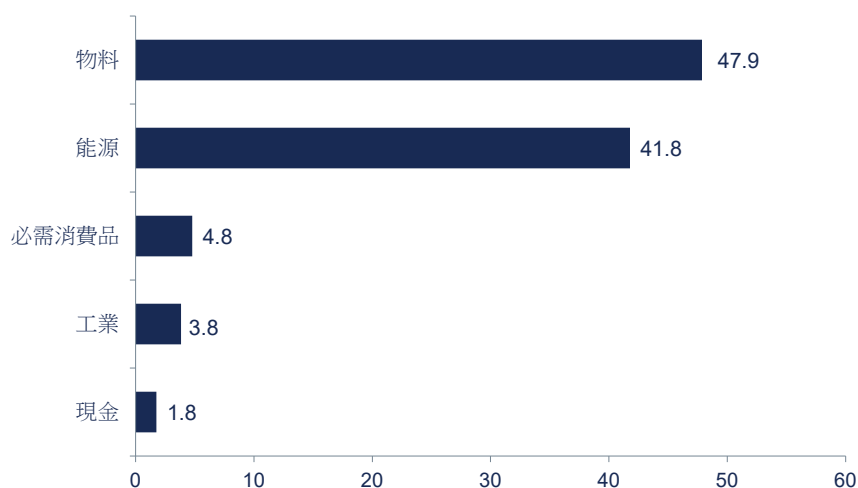

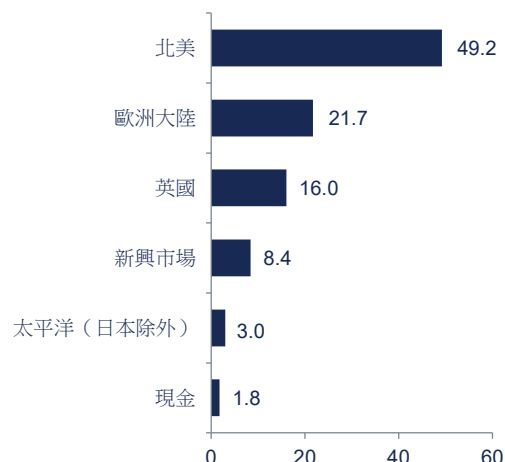
主要行業比重 (佔資產淨值%)³
