Investment objective

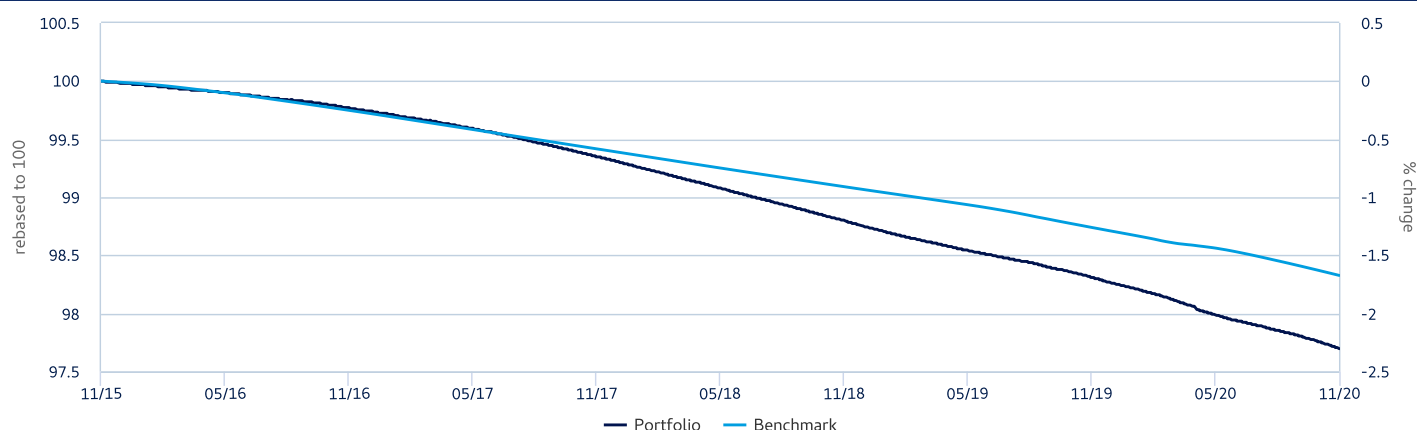

Following this change, Pioneer Asset Management S.A. has renamed to Amundi Luxembourg S.A. Effective 3 July 2017, the investment objective and policy of the Sub-Fund was modified. Effective 24 June 2011, SGAM Fund/Money Market (Euro) and Amundi Funds Euro Reserve were merged into Amundi Funds Money Market Euro. Prior to 24 June 2011, the performance of the Sub-Fund is that of SGAM Fund/Money Market (Euro). The inception date of the Sub-Fund is that of SGAM Fund/Money Market (Euro).

Effective 1 June 2019, the naming of Classes has been standardised. Effective 3 December 2012, Amundi Funds Money Market Euro has changed name to Amundi Funds Cash EUR.
