What is this product?

This product is a UCITS sub-fund of a variable capital umbrella investment company with segregated liability between sub-funds authorised by the Central Bank of Ireland pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011, as amended.

Objectives

The fund aims to provide the performance of the PIMCO Emerging Markets Advantage Local Currency Bond Index (the "Reference Index"). Investment Policy

The Reference Index is a gross domestic product ("GDP") weighted benchmark for local emerging market government debt, subject to a maximum exposure of 15% per country. The particular countries and their weighting are determined annually. Qualifying countries must have a minimum average sovereign rating of BB- (with such ratings provided by recognised rating agencies). The fund invests a substantial portion of its assets in a diversified portfolio of emerging market local government debt.

The fund will attempt to achieve its objectives by investing primarily in a range of non-USD denominated fixed income securities (which are similar to loans that pay a fixed or variable rate of interest). The fund may invest in "investment grade" and

Typical investors in the Fund will be investors looking for exposure to emerging market goverment Fixed Income Instruments and who are willing to accept a high level of volatility on an absolute basis.

This classification is subject to change over time.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level and poor market conditions are unlikely to impact the value of your investment.

Recommended holding period: 3 years
