

Fidelity Funds - Japan Smaller Companies Fund 富達基金-日本小型公司基金



Summary of Investment Objective 投資目標摘要

The fund is an Equity fund and aims to provide long-term capital growth with the level of income expected to be low. The fund invests principally (i.e. at least 70% (and normally 75%) of the fund's assets) in smaller and emerging companies in Japan, including those listed on regional stock exchanges in Japan and on the Tokyo over the-counter market.
